
PURSUANT TO order No. 25700-B-626 of The Supreme Court of Washington and GR 21, as Presiding Judge of the Seattle Municipal Court, in the interest of both public safety and public health during the COVID-19 crisis, and in the interest of the health and safety of potentially exposed court employees, court partners and the public,

IT IS HEREBY ORDERED THAT:

1. The Court's phased reopening plan codified as Appendix A in General Administrative Order 2020-08 which provided the framework for setting out-of-custody criminal matters when the Court resumed limited operations on July 6, 2020, will be amended starting in week 6 of that plan, or August 10, 2020, with additional changes in week 7 and 8 as noted in Appendix C. The framework established for week 8 will continue up through December 31, 2020, unless altered by a subsequent order.
2. Court dates set on matters after the Court resumed limited operations on July 6, 2020 beyond week 6, or August 10, 2020, will be administratively reset to a future date as the schedule noted in Appendix C allows. Due to the unforeseen circumstances of consolidating the Court schedule back to limited capacity, the inability to overset calendars due to social distancing guidance in courtrooms and lack of calendar space, good cause is found for the period of this continuance to be an excluded period in computing time for trial pursuant to CrRLJ 3.3(e).

3. In-custody appearances at Courtroom 2 of the King County Jail (“KCJ2”) will continue to operate as described in Seattle Municipal GAO 2020-08. However, in addition to in-custody arraignments and warrant appearances, the Court will set a limited number of in-custody pre-trial hearing cases in KCJ2 in order to consolidate operations and to limit the number of transports to the Seattle Justice Center.
4. For the health and safety of our employees, justice partners and those who interact with the court, all persons entering the Courthouse are required to perform a self-temperature screening upon entry until further order of the Court. Those visitors who present with a temperature in excess of 100.4 degrees Fahrenheit will be denied entry to the Seattle Justice Center and directed to the Court’s “Quick Pay” window so that Court staff can assist the visitor with their Court business or notify the Courtroom or Probation that the visitor is unable to attend their scheduled appearance.
5. The Court may extend the time frames in this order as required by this continuing public health crisis and, if necessary, will do so by further order. This order and other applicable emergency general administrative orders may be deemed part of the record in affected cases for purposes of appeal without the need to file the orders in each case. All orders in General Administrative Order 2020-08 not specifically amended in this order hereby stand.
