WHEREAS, the court incorporates the findings of its June 24, 2020 Third
Revised and Extended Emergency Administrative Order:

It is hereby ORDERED, pursuant to the authority of Washington State Supreme
Court Orders related to court operations during the COVID-19 pandemic and the
authority as the Presiding Judge of both the Klickitat County and Skamania County
Superior Courts, as follows:

GENERAL ORDERS:

1. This order shall supplement the Third Revised and Extended Emergency
Administrative Order issued on June 24, 2020. The provisions of this order
are effective until December 31, 2020, unless otherwise noted.


1 2. Social Distancing. The social distancing rules and enforcement provisions of
2 the June 25, 2020 Third Revised and Extended Emergency Administrative
3 Order that were imposed for Skamania County Superior Court shall apply for
4 Klickitat County Superior Court room as well.

5 (i) All persons attending court proceedings at the Klickitat County
6 Superior Court courtroom shall adhere to social distancing requirements to
7 the extent practicable. Social distancing (also called "physical distancing")
8 shall require all persons to maintain at least 6 foot distance from all other
9 persons other than those in your household.

10 (ii) Social distancing requirement does not strictly apply to an attorney
11 and their client. Efforts should be made by attorney and client to adhere to
12 the social distancing requirement.

14 3. Enforcement. Court staff shall have the authority to (a) exclude persons
15 exhibiting symptoms of COVID-19, including fever, persistent cough, or
16 shortness of breath; (b) direct persons entering the courtroom the locations
17 within the courtroom where they may and may not be seated; and/or (c)
18 temporarily deny access to the courtroom for individuals refusing to comply
19 with the terms of this order or in an effort to ensure masking and social
20 distancing requirements within the courtroom.
