THIS MATTER has come before the Court Sua Sponte, the Court finds as follows:

On March 18, 2020, the Chief Justice of the Supreme Court of Washington issued an emergency order in response to the public health emergency that affects operations of trial courts in Washington State. In addition to other provisions, the Order suspends all criminal jury trials and continues all **out of custody** criminal matters already pending until after April 24, 2020, in addition, the Order continues all **in custody** criminal matters with certain exceptions until after April 24, 2020;

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. **Prior Order Terminated.** This Order replaces the Order of this Court of March 16, 2020, which is now terminated.
2. **Monday Criminal Dockets and Tuesday Show Cause Dockets.** All matters currently scheduled for the Monday Criminal Dockets and Tuesday Show Cause Dockets that were scheduled to occur between the date of this order and April 24, 2020, are continued as set forth in Attachment A, and incorporated by this reference.
3. **Remaining In Custody Criminal Matters.** Those **in custody** criminal matters not continued under the provisions of paragraph 7 of the Supreme Court Order of March 18, 2020, shall be heard by video conferencing, unless otherwise ordered

by the Court. Notice of the hearing shall be provided not later than one day before the time specified for the hearing, unless otherwise ordered by the Court.
