EMERGENCY ORDER 20 REGARDING
AUTHORIZATION TO CONDUCT
PIERCE COUNTY SUPERIOR COURT
SESSIONS AT ALTERNITIVE
LOCATIONS

WHEREAS, RCW 2.08.030 provides that Superior Courts:

...shall hold their sessions at the county seats of the several counties, respectively, and at such other places within the county as are designated by the judge or judges thereof with the approval of the chief justice of the supreme court of this state and of the governing body of the county;

and,

WHEREAS, In December 2006, the Chief Justice of the Washington State Supreme Court ordered:

That the Pierce County Superior Court may hold session at locations other than Tacoma, the county seat, when exigent circumstances necessitate that the court be held in a different location. (See Appendix hereto);

and,

WHEREAS, because "safe distancing" is necessary to guard against the spread of the Covid -19 pandemic, and

WHEREAS, for the foreseeable future, at least well into the year 2021, there is not sufficient space within the Pierce County Superior Courthouse (County City Building) to conduct civil jury trials due to the requirement of "safe distancing;" and,

The Pierce County Superior Court has requested the Chief Justice's approval to hold sessions at alternative locations outside the county seat in the event of an emergency or disaster. The superior courts are required to hold their sessions at the county seats and the judges may designate other places within the county with the approval of the Chief Justice and governing body of the county, pursuant to RCW 2.08.030.

Pierce County Superior Court has adopted a Continuity of Operations Plan which provides alternative locations in the event of an emergency or disaster. The Pierce County Council adopted Ordinance No. 2006-138, authorizing the Pierce County Superior Court to hold sessions in locations other than in Tacoma, the county seat.

The Chief Justice having considered the request and having determined that approval would aid in the prompt and orderly administration of justice in the event of a disaster or emergency;

Now, therefore, it is hereby

ORDERED:

That Pierce County Superior Court may hold sessions at locations other than Tacoma, the county seat, when exigent circumstances necessitate that court be held in a different location. In
