WHEREAS, On February 29, 2020, Washington State Governor Jay Inslee declared a state of emergency due to the public health emergency posed by the spread of the coronavirus (COVID-19) and

WHEREAS, On March 4, 2020 Chief Justice Debra Stephens of the Washington Supreme Court adopted Order No. 25700-B-602, granting emergency authority upon all Washington courts to adopt, modify, and/or suspend court rules and orders, and to take further actions concerning court operations, as warranted to address the current state of emergency issued an emergency order in response to the public health emergency that affects operations of trial courts in Washington State; and

WHEREAS, to reduce spread of COVID-19, the United States Centers for Disease Control and Prevention and the Washington State Department of Health (DOH) recommend implementation of community mitigation strategies to increase containment of the virus, including cancellation of large gatherings and social distancing in smaller gatherings; and

WHEREAS, Supreme Court Order No. 25700-B-606 requires the courts in this state to significantly alter current practices,

NOW, THEREFORE, IT IS HEREBY ORDERED:

## THIS ORDER SUPERSEDES ORDER NO. 1-2020 AND THEREFORE ORDER NO. 1-2020 IS HEREBY REPEALED.

In accordance with Supreme Court Order No. 25700-B-606, attached hereto, and the closing of all City of Olympia buildings through March 31, 2020, the Olympia Municipal court is closed to the public through May 4, 2020, except as specifically stated below.

- If you are sick or experiencing flu-like symptoms such as a cough, fever or other respiratory
  problems, or if you are 60 years or older, have at risk health conditions, have weakened immune
  systems, or are pregnant please DO NOT come into any of the Olympia Municipal Court facilities –
  including court services, probation services, the community court provider building and courtrooms.
- 2. All **in custody** criminal matters shall be continued until after May 4, 2020, except with limited personnel, the court will address, hearings of first appearances, arraignments, plea

hearings, criminal motions for release of the accused, and sentencing hearings at 2:00 PM every judicial day. Defense attorneys and the City prosecution shall appear by telephone. Defendants shall appear by video.

Defense counsel may file a written motion by email for release of accused on any case where the defendant is held in custody. If the City does not object to the release, the court will review the filed motion and make a decision without a hearing. If the City objects to the motion for release or the court denies the motion, the defendant will be heard on the next available 2:00 pm calendar. No other hearings will be held until after May 4, 2020.

- 3. All **out of custody** criminal matters already pending shall be continued until after May 4, 2020. If you are the defendant in the case, contact your attorney as soon as possible to discuss rescheduling your hearing. If you have a public defender and do not know how to contact your attorney, please contact the court at <u>court@ci.olympia.wa.us</u> or (360) 753-8312.
- 4. Arraignment on **out of custody** cases filed between today's date and May 4, 2020 or the first appearance in court after that date shall be deferred until the next available first appearance date at least 45 days after the filing of charges. Good cause exists under CrRLJ 4.1 to extend the arraignment dates. The new arraignment date shall be considered the "initial commencement date" for purposes of establishing the time for trial under CrRLJ 3.3(c)(1).
- 5. All Jury trials are suspended until after May 4, 2020. When jury trials recommence:
  - a) Jurors who are 60 years or older, have at risk health conditions, have weakened immune systems, or are pregnant, please call or email the court to alert us that you fall into one of these high-risk categories. Potential jurors in these categories will be excused and will not be reporting for jury duty at this time. The court will accommodate you and reschedule your service for a later jury term.
  - b) If you are sick, please to not report for jury duty, but please contact the court by phone or email at (360) 753-8312 or <u>court@ci.olympia.wa.us</u>.
- 6. Community Court will be cancelled for the immediate future. Community Court will resume when reasonably prudent to do so. All clients will be rescheduled. Participants should contact the community court case manager by phone for check-ins.
- All in person traffic and parking hearings have been rescheduled. Hearings may be conducted by mail. Requests for hearings, deferrals, or payment plans may be made by e-mail to <u>court@ci.olympia.wa.us</u>. Payments may be made by phone at (877) 793-8935 or through the City's website: olympiawa.gov/court.
- 8. Probation appointments will be conducted by telephone unless otherwise directed. Probation clients **must** contact probation for reporting instructions at (360) 753-8263.

- 9. The April 16<sup>th</sup> Victim's Impact Panel is cancelled. Those currently scheduled for the April panel will be rescheduled. Please contact Olympia Probation for further information at (360) 753-8263.
- 10. The April 16<sup>th</sup> DUI Alternative Program is cancelled. The next program is currently scheduled for Thursday, July 9<sup>th</sup>. If you are currently scheduled to attend on April 16<sup>th</sup>, you will be reset to a future date and notified by mail or telephone. Any questions please contact Olympia Probation at (360) 753-8263.
- 11. In person MRT classes are cancelled for now. Please contact probation for further information at (360) 753-8263.
- 12. Warrants will only be issued for individuals for the immediate preservation of public or individual safety. Warrants will not be issued for only failure to appear at this time. Warrants previously issued in an amount less than \$2,500 shall not be confirmed, unless necessary for the immediate preservation of public or individual safety.
- 13. For all hearings currently pending and for hearings on new cases filed during the pendency of this order that are delayed by effect of this order, the delay/continuance shall constitute an excluded period for purposes of Speedy Trial, CrRLJ 3.3, CrRLJ 4.1, IRLJ 2.2, IRLJ 2.4, IRLJ 2.6, and any other applicable court rule.
- 14. It is Further Ordered that in all hearings delayed by this order, notices will be mailed to the parties for the next scheduled hearing date via US mail. Any party needing to update their mailing address should contact the court clerk at (360) 753-8312 or email the court at court@ci.olympia.wa.us.
- 15. For all hearings not continued by effect of this rule, telephonic hearings will be permitted to the greatest extent possible in order to encourage social distancing as recommended by both the Centers for Disease Control and local public health officials.

This order may be modified consistent with the Court's continual assessment of the needs of the community as well as the recommendations of public health officials.
