O R D E R

WHEREAS, on February 29, 2020, Governor Inslee proclaimed a state of emergency due to the novel coronavirus disease (COVID-19) outbreak in Washington; and

WHEREAS, on March 13, 2020, President Trump declared a national emergency due to the novel coronavirus disease (COVID-19) outbreak across the United States; and

WHEREAS, during this state of emergency, the Centers for Disease Control and Prevention and the Washington State Department of Health strongly urge all organizations to impose social distancing measures and other restrictions on public gatherings; and

WHEREAS, the public spaces in the Temple of Justice, a historic building which houses the Washington State Supreme Court and the Washington State Law Library, cannot effectively be managed to ensure compliance with recent public health guidelines, and keeping the building open to the public poses a significant health risk to visitors, litigants, and court staff; and

WHEREAS, the Washington State Supreme Court has suspended oral arguments until its Spring Term commencing May 5, 2020, and has no in-person court hearings scheduled before that time; and

WHEREAS, the Washington State Law Library has closed its public reading rooms for public safety, while continuing to serve patrons online and by telephone; and

WHEREAS, all essential functions of the Washington State Supreme Court and the Washington State Law Library can continue uninterrupted without the Temple of Justice building remaining open to the public,


NOW, THEREFORE, pursuant to the Court's power to administer justice and to ensure the safety of court personnel, litigants, and the public,

IT IS HEREBY ORDERED:

The Temple of Justice Building shall be closed to the public until the next scheduled oral argument on May 5, 2020. All business with the court and the library shall continue using electronic, mail, and other available means that do not require physical entry of the public into the building.
