CALL TO ORDER

Judge Gehlsen, District and Municipal Court Judges' Association (DMCJA) President, noted a quorum was present and called the DMCJA Board of Governors (Board) meeting to order at 12:32 p.m. Judge Gehlsen asked attendees to introduce themselves.

GENERAL BUSINESS

A. Minutes

The Board moved, seconded, and passed a vote (M/S/P) to approve the Board Meeting Minutes for December 4, 2020.

B. Special Guest Margaret Fisher was honored for 40 years of Public Legal Education Service in Recognition for her Passion, Unconditional Commitment and making an Extraordinary Difference in the World. Ms. Fisher discussed the purpose of the Street Law program and some of the impacts of the programs. Judge Stewart, Judge Crawford-Willis, Judge Ringus, Judge Henke, Judge Smith, and Commissioner Cooper gave kind words about Ms. Fisher's work and achievements.

BREAK OUT SESSIONS

- C. Discussion Question (break out rooms; pick a spokesperson to report back to the group):
- 1. What are you doing differently due to the pandemic (innovation, helpful tip, etc.) that is helping your court?

Group 1 – Judge Smith reported that one court retrofitted their courtroom with audio and visual updates. Another court sends notifications that people can appear in person or on Zoom, and people are responding by attending virtually more often. One court is having staff meetings once a week as a check-in on how people are doing—spirits of staff remain high. They discussed the fact that this pandemic is affecting people differently, but everyone needs to stay vigilant and recognize the importance of collaboration to solve problems.

Group 2 – Judge Goodwin reported that their discussion focused on where we go from here; how much of what we are doing now will change how the court system functions. It provides a lot of opportunities to see what works and what doesn't in small courts and large courts.

Group 3 – Judge Short reported about the transition to working online and the challenge of the backlog of trials; the online hearings; and the need for grace, kindness, and patience in the current situation. One court has weekly town hall meetings; previously they met several times a week when the pandemic situation was quickly changing.

Group 4 – Commissioner Leo discussed inspiring things that have happened; for example, successful defendants that are on deferred prosecutions, using interpreters over Zoom and tackling problems related to sending information to the person and interpreter, and finding innovations and teamwork to solve problems.

Group 5 – Judge Grim reported that they spent time talking about *State v. Gelinas* and the impact on issuance of bench warrants. They discussed problem solving related to signing documents and trial continuance orders.

Further discussion was had on *State v. Gelinas*, and CrRLJ 3.4, and Judge Gehlsen advised that there will be a webinar on the subject.

INTRODUCTION: Judge Gehlsen briefly introduced the new DMCJA Court Association Coordinator, Stephanie Oyler. Stephanie most recently worked as a Management Analyst in the Contracts & Initiatives Unit with the Department of Licensing.

GENERAL BUSINESS

D. Treasurer's Report

M/S/P to approve the Treasurer's Report. Jeff Smith stated that the audit is almost complete; 25% of dues were collected in the first month; halfway through the year and halfway through the budget.

E. <u>Judicial Information Systems (JIS) Report</u>

Ms. Cullinane ceded her time to Judge Walden's presentation to later on the agenda.

F. Special Fund Report

M/S/P to approve the Special Fund Report for both November 2020 and December 2020.

G. Standing Committee Reports

1. Rules Committee - agenda item continued to Judge Goodwin's presentation.

2. Diversity Committee

Judge Short reported on the letter sent to the Association regarding this year's pro-tem training. This happens every two years; last year COVID-19 delayed it. They will be holding the training virtually this year over three days, February 26, March 5, and March 12 instead of two full in-person days. Judge Williams reported that staff is diligently working on a survey and reported on some of the challenges.

3. Legislative Committee

Judge Ringus reported that they have been meeting with members of the House and Senate, and they are preparing for the first executive committee meeting of the session on Monday, January 11.

LIAISON REPORTS

A. Administrative Office of the Courts AOC

Ms. Rubio was not present and did not report.

B. Board for Judicial Administration (BJA)

Judge Logan reported that BJA had a robust discussion regarding court security, a change in the prioritization, and might move it on for approval. The last meeting was in November. Judge Robertson reported that due to priorities changing and the COVID-19 impacts to the legislative session, the Trial Court Security Committee withdrew their budget request and will re-submit the proposal in the next biennium.

C. <u>District and Municipal Court Management Association (DMCMA)</u>

Ms. Thompson reported in place of Ms. Patricia Kohler. In December, DMCMA sponsored two sessions on implicit bias taught by Commissioner Lack, garnering 500+ attendees. DMCMA is planning their May conference and are updating their model court administrator job description, last updated in 2003.

D. <u>Misdemeanant Probation Association (MPA)</u>

Ms. Scarpaci was not present but sent in notes in advance that MPA had no update for today.

E. Superior Court Judges' Association (SCJA)

Judge Estudillo reported that they are in full swing getting ready for legislative session. He mentioned a bill of interest regarding automatic felon reinstatement of firearms. They obtained a 30-day Governor proclamation that delays the repeal of RCW 26.10 and anticipate a further delay of six months. The SCJA committees continue their work to address structural racism.

F. Washington State Association for Justice (WSAJ)

Mr. Malcolm was not present and did not report.

G. Washington State Bar Association (WSBA)

Ms. Hunter was not present and did not report.

DISCUSSION

A. CLJ-CMS Project and Rules for E-filing

Judge Walden gave a brief history and status of the CLJ-CMS Project. Pilot courts have been chosen: Gig Harbor Municipal, Fircrest/Ruston Municipal, Tacoma Municipal, and Pierce County District Court.

Spring 2021, pilot courts will begin and will need to have a mandatory e-Filing court rule; she explained the e-Filing model in detail. One of the incredible benefits is that e-Filed documents will be available and searchable through the new case management system. Questions were posed about costs per filing vs. costs of filing via envelope. A bundle of documents filed in a particular case at a particular time constitutes a "filing." Judge Walden discussed future plans to support courts that don't have dedicated IT support. The rollout of the schedule will begin with pilot implementation in 2021, and then regionally. Hubs will be established within the regions to support the rollout.

Immediate next steps involve each court adopting a mandatory e-Filing local rule and a model rule. Right now GR 30 allows courts to offer an optional e-Filing method.

Judge Williams asked whether an attorney could buy a subscription to file limitlessly. Mr. Marler mentioned that they can establish an account, but there is not a flat rate subscription. A discussion about superior court e-Filing was had.

While e-Filing is the wave of the future and the benefits are positive, members gave feedback that education will be key as a mandatory rule will require now mandatory new filing fees.

Based on the discussion, there were no objections to the course that the CLJ-CMS Steering Committee has suggested, which is to circulate a model local court rule that pilot courts and other courts could use as a basis for their local e-Filing court rule. This will relieve the Rules Committee of a substantive role in drafting or presenting local or statewide rules. The Rules Committee is still welcome to give feedback or raise issues as they deem appropriate.

B. <u>DMCJA Rules Committee Update on Court Rule Amendments Effective in February</u>

Judge Goodwin gave updates on several rules that become effective February 1, 2021. CrRLJ 3.4 changes the requirements related to when a defendant's personal appearance is required. On December 30, 2020, *State v. Gelinas* was ordered published by Division I, Court of Appeals (previously it had been an unpublished opinion). Members are having vigorous discussions regarding recently adopted CrRLJ 3.4 and implementation issues related to the version passed along with the recent Division I opinion. Members are interested in suggesting revisions and looking at the rule and case in more detail.

Judge Goodwin advised that the following become effective February 1, 2021, but do not have significant impact to the courts of limited jurisdiction: Indigent Defense Standards for Mental Health, CrRLJ 3.1, CrR 3.1, JuCR 9.2, and New MRP 2.1—Mental Health Guidelines.

Additionally, changes to CrRLJ 8.2 allow for a motion for reconsideration to be governed by CRLJ 59.

Other recently-adopted rules that may be challenging for courts to immediately implement include: (1) GR 7, which requires a more rigorous process related to local court rules; and (2) GR 11.3 and 11.4, which were recommendations from the Interpreter's Commission and adopted without the opportunity for comment.

Judge Goodwin reported that he attended the last meeting of the Interpreter Commission Issues Committee, and he anticipates further review based on the discussion. GR 11.3 applies to remote interpreting, and the language in the amended rule is broad and may present implementation problems. Specifically, GR 11.3(f) places the burden on the court to provide several things to the interpreter in advance of the hearing. Judge Goodwin provided a memorandum to Judge Antosz, Chair of the Issues Committee, on the challenges to implementation. GR 11.4 establishes standards for interpreter time that will present fiscal challenges to the courts of limited jurisdictions.

Judge Goodwin reported generally that the Rules Committee continues to look at CrRLJ 3.4, GR 11.3, and 11.4, as well as electronic exchange of documents under CRLJ 5.

Ms. Benway, Rules Committee staff, updated the Board on the passage of CrRLJ 1.3, GR 29, CR 30, and GR 30.

CALL TO ORDER

Judge Gehlsen, District and Municipal Court Judges' Association (DMCJA) President, noted a quorum was present and called the DMCJA Board of Governors (Board) special meeting to order at 12:03 p.m. Judge Gehlsen noted that this special meeting was called to determine whether the DMCJA should make a financial contribution to the Racial Justice Consortium in response to a request from Justice Mary Yu.

DISCUSSION

Judge Gehlsen briefly explained the background of the request and opened the discussion, which is summarized as follows:

Members noted the Association's commitment to racial justice and recognized that the funds would be well spent on an important cause. DMCJA published a letter on November 25, 2020, stating that "Identifying and Eliminating Systemic Racism in our Justice System" is DMCJA's first priority.

Members expressed concerns about the source of the funds. There was discussion about the possibility of contributing as individuals or utilizing the DMCJA Special Fund since those funds are personal contributions and not public funds.

Judge Gehlsen suggested that she and DMCJA staff speak to Dirk Marler from AOC to request guidance on the details of making a contribution. Members suggested a resolution to memorialize the Board's intentions for a contribution. Judge Smith offered to draft the resolution.



Judge Goodwin called the meeting to order at 12:01 p.m.

The Committee discussed the following items:

1. Welcome & Introductions

Judge Goodwin welcomed the Committee members in attendance. Judge Eisenberg introduced Judge McDowall, his benchmate in Seattle Municipal Court, who prepared a memo on <u>State v.</u> Gelinas that was provided to the Rules Committee.

2. Approve Minutes from the December 9, 2020 Meeting

It was motioned, seconded, and passed to approve the minutes from the December 9, 2020 Rules Committee meeting. The approved minutes will be provided to the DMCJA Board.

3. Discuss Recent Amendments to CrRLJ 3.4 & State v. Gelinas

CrRLJ 3.4, pertaining to the presence of the defendant, was recently amended by the WSSC and was the subject of the recent Division I opinion State v. Gelinas. The Committee is concerned about the readability of the current rule, the potential for more hearings, how the waiver process will work, and the implication for speedy trials under CrRLJ 3.3. Judge Goodwin noted that he has also been meeting with the Interpreter Commission regarding their concerns about the rule. Due to the number of issues and the amount of material, the Committee set a special meeting for Thursday, February 11 to continue the discussion. Ms. Benway will schedule the meeting and send notice to Committee members.

4. Discuss Recently Amended GR 11.3 and New GR 11.4

Judge Goodwin stated that the WSSC recently amended GR 11.3 and enacted new GR 11.4 pertaining to the use of interpreters that could have a large impact on courts of limited jurisdiction. They were published on an expedited scheduled without providing the opportunity for comment. Judge Goodwin has been meeting with the Issues Committee of the Interpreter Commission, which is chaired by Judge Antush, to propose helpful language, and has encouraged them to request that the rules be published for comment. This item will be carried over to the next meeting.

5. Discuss Proposal to Amend ARLJ 14

The District and Municipal Court Managers' Association (DMCMA) has proposed an amendment to ARLJ 14, which would require training for court administrators. Ms. Kohler answered questions regarding the proposal, and stated that the training requirement could be fulfilled through the trainings and conferences offered by the DMCMA. The proposal has not yet been submitted to the WSSC, as the DMCMA would like to have DMCJA support before doing so. This item was continued to the next meeting.

6. Discuss Rules Recently Published for Comment by the WSSC

The WSSC recently published several rule and rule amendment proposals for comment, many of which may impact courts of limited jurisdiction. The comment deadline is April 30, 2021. Of particular note are:

- Proposed new GR 39, pertaining to legal financial obligations. The Committee agreed that it would be helpful to have a process but had questions about the proposal. This item will be carried over to the next meeting.
- Proposal to amend CR 71, pertaining to time limits on attorney withdrawal. The Committee questioned whether a similar amendment would be helpful for courts of limited jurisdiction and concluded that it would not.
- Proposal to amend CrRLJ 3.2, pertaining to release of the accused. The Committee discussed the proposal and agreed the proposed amendments may be beneficial. This item will be carried over to the next meeting.
- Proposal to amend CrRLJ 3.1 Standards, adds a requirement pertaining to the appeals process. The Committee had no objection.

7. Update Regarding Model Local Rule for Electronic Filing

The Committee had previously discussed the need for local courts to adopt a model rule if the court intends to require electronic filing (per GR 30). Judge Goodwin stated that the proposed rule had been discussed at the DMCJA Board meeting and the CLJ-CMS Steering Committee was taking the lead on this issue.

8. Discuss Potential Amendments to CRLJ 5

Judge Finkle stated that he was putting together an informal workgroup to look into the issue of electronic service under CRLJ 5. This item will be brought back to the Committee at a later meeting.

9. Other Business and Next Meeting Date

Judge Eisenberg stated that he appreciated Judge McDowall's attendance at the meeting and recommended her membership on the Committee. Judge Goodwin and the rest of the Committee agreed. Ms. Benway will convey the recommendation to DMCJA Staff.

The next Committee meeting is scheduled for Wednesday, February 24, 2021 at noon, via zoom video conference. The Committee also scheduled a special meeting on Thursday, February 11, at noon via zoom, to discuss CrRLJ 3.4. There being no further business, the meeting was adjourned at 12:57 p.m.

Judge Goodwin welcomed the Committee members in attendance.

2. Approve Minutes from the October 28, 2020 Meeting

It was motioned, seconded, and passed to approve the minutes from the October 28, 2020 Rules Committee meeting. Judge Goodwin stated that he appreciated Ms. Benway's work on the minutes and the Committee concurred. The approved minutes will be provided to the DMCJA Board.

3. Discuss Revised Proposal to Amend GR 22 (formerly GR 31)

The Committee reviewed the revised version of the proposal to amend GR 22 to protect certain materials in therapeutic courts, which addresses concerns raised by the Washington State Association of County Clerks (WSACC); WSACC has approved this version. Ms. Benway stated that she had also submitted the proposal to the Superior Court Judges' Association (SCJA) Rules Committee for comment as well. Judge Finkle stated that he appreciated the revisions and wanted to suggest that the phrase "under chapter 10.77 RCW" be used in place of "mental health proceedings." The Committee agreed that this was a good amendment and Judge Eisenberg stated that he would make that change. It was motioned, seconded, and passed that the proposed rule amendment (as revised by Judge Eisenberg) be conveyed to the DMCJA Board with a recommendation to forward it to the WSSC Rules Committee. Ms. Benway stated

that per GR 9, the WSSC was not accepting rule amendment proposals until October 2021. The Committee requested that Ms. Benway investigate whether it would be possible to present the WSSC with the proposal prior to that time.

4. Discuss Potential Amendment to CRLJ 43

The Committee considered whether language should be added to CRLJ 43(a) to make it identical to CR 43(a). The provision states: "For good cause in compelling circumstances and with appropriate safeguards, the court may permit testimony in open court by contemporaneous transmission from a different location." The Committee agreed with this addition and requested that Ms. Benway prepare a GR 9 Cover Sheet for the proposal. It was motioned, seconded, and passed to submit the proposal to the DMCJA Board with a recommendation to forward it to the WSSC Rules Committee for consideration.

5. Update Regarding Recently Enacted Rules

Ms. Benway provided an update regarding rules the WSSC recently enacted that will impact courts of limited jurisdiction. Of particular note were amendments to GR 7 regarding adopting local rules, and changes to statewide rules due to the repeal of RCW 9A.72.085. The Committee requested that Ms. Benway provide the report at the next DMCJA Board meeting. Ms. Benway stated that she would speak to DMCJA staff regarding adding that to the agenda.

6. Discuss Potential Amendments to CRLJ 5

Judge Finkle sent a message to the DMCJA listserve regarding how and whether various courts are using CRLJ 5, and Ms. Benway presented the results to the Committee. Judge Finkle stated that judges had very varied responses regarding the use of CRLJ 5 in the courtrooms. It did confirm that not all courts have access to the same technology. The Committee requested that Judge Finkle continue to look into the issue of electronic service. He stated that he may draft a revised rule for discussion purposes and discuss it with other CLJ judges. This item will be brought back to the Committee at a later meeting.

7. Discuss Amendments to CrRLJ 3.4

Ms. Benway stated that the WSSC had adopted amendments to CrRLJ 3.4 and CrR 3.4 that will be effective on February 1, 2021. The amendments were proposed by the Washington Defender Association, and may present operational challenges for trial courts. The Superior Court Judges Association has drafted a revised rule that it provided to DMCJA Rules Committee for review. Committee members will review the proposal for discussion at the next meeting. The Committee agreed to carry this item forward to the January 2021 meeting.

8. Other Business and Next Meeting Date

Judge Goodwin expressed concern regarding meeting attendance and asked if a different day or time would work better for Committee members. Committee consensus was that while not perfect, the fourth Wednesday at noon seemed to work for most Committee members. Judge Goodwin asked Committee members to let him or Ms. Benway know if another day or time works better for meeting.

- C. Purpose: It was recently brought to the attention of the DMCJA that CR 43(a)(1) includes a sentence pertaining to remote testimony that is absent from CRLJ 43(a)(1). The sentence reads, "For good cause in compelling circumstances and with appropriate safeguards, the court may permit testimony in open court by contemporaneous transmission from a different location." Having considered the matter, the DMCJA Board determined that courts of limited jurisdiction would benefit from similar flexibility in permitting remote testimony. Further, it is good practice for the rules of the trial courts to remain congruent. Therefore, the DMCJA requests that an additional sentence be added to CRLJ 43(a)(1) making that subsection identical to CR 43(a)(1).

- **E. Expedited Consideration:** Expedited consideration is not requested.

WASHINGTON STATE COURT GENERAL RULES:

RULE 22: ACCESS TO FAMILY LAW AND GUARDIANSHIP COURT RECORDS

Submitted by the District & Municipal Courts Judges Association

A. Name of Proponent: District & Municipal Courts Judges Association

B. Spokesperson: Judge Michelle Gehlsen, DMCJA President

C. <u>Purpose</u>: The DMCJA recommends amending GR 22 to include therapeutic court records. Therapeutic courts are defined under RCW 2.30.010. This amendment would further the goal of therapeutic courts to provide individualized treatment intervention. Limited public access to assessments and treatment reports would help encourage defendants to cooperate more honestly with risk/needs assessments, mental health and chemical dependency evaluations, and treatment.

In RCW 2.30.010, the Legislature recognized the unique ability of therapeutic courts to help defendants address their individual treatment needs:

- (1) The legislature finds that judges in the trial courts throughout the state effectively utilize what are known as therapeutic courts to remove a defendant's or respondent's case from the criminal and civil court traditional trial track and allow those defendants or respondents the opportunity to obtain treatment services to address particular issues that may have contributed to the conduct that led to their arrest or other issues before the court. Trial courts have proved adept at creative approaches in fashioning a wide variety of therapeutic courts addressing the spectrum of social issues that can contribute to criminal activity and engagement with the child welfare system.
- (2) The legislature further finds that by focusing on the specific individual's needs, providing treatment for the issues presented, and ensuring rapid and appropriate accountability for program violations, therapeutic courts may decrease recidivism, improve the safety of the community, and improve the life of the program participant and the lives of the participant's family members by decreasing the severity and frequency of the specific behavior addressed by the therapeutic court.
- (3) The legislature recognizes the inherent authority of the judiciary under Article IV, section 1 of the state Constitution to establish therapeutic courts, and the outstanding contribution to the state and local communities made by the establishment of therapeutic courts and desires to provide a general provision in

statute acknowledging and encouraging the judiciary to provide for therapeutic court programs to address the particular needs within a given judicial jurisdiction.

Successful completion of a therapeutic court program by a defendant is dependent on the defendant being honest throughout the entire process. Initial evaluations require defendants to be honest about their personal history, their addiction issues, their mental health issues, etc. Having such evaluations and treatment reports be restricted will help facilitate this goal because defendants can speak freely to evaluators, treatment providers and probation counselors without fear their personal private information will be released to the general public.

To further this end, the DMCJA proposes an amendment to GR 22 that would create restricted access to certain critical records used in therapeutic courts. This amendment would facilitate public access to court records while also protecting personal privacy and not unduly burdening the ongoing business of the courts.

PROPOSED AMENDMENT:

GR 22 ACCESS TO FAMILY LAW, AND GUARDIANSHIP, AND THERAPEUTIC COURT RECORDS

(a) Purpose and Scope of this Rule. This rule governs access to family law, and guardianship, and therapeutic court records, whether the records are maintained in paper or electronic form. The policy of the courts is to facilitate public access to court records, provided that such access will not present an unreasonable invasion of personal privacy, will not permit access to records or information defined by law or court rule as confidential, sealed, exempted from disclosure, or otherwise restricted from public access, and will not be unduly burdensome to the ongoing business of the courts.

(b) Definition and Construction of Terms.

- (1) (8) [Unchanged.]
- (9) "Therapeutic court cases" means any case in which a party is receiving treatment pursuant to a therapeutic court program under Chapter 2.30 RCW.
 - (c) Access to Family Law, or Guardianship, and Therapeutic Court Records.
- (1) General Policy. Except as provided in RCW 26.26.610(2) and subsections (c)(2) and (c)(3) below, all court records shall be open to the public for inspection and copying upon request. The Clerk of the court may assess fees, as may be authorized by law, for the production of such records
- (2) Restricted Access. The Confidential Information Form, Sealed Financial Source Documents, Domestic Violence Information Form, Notice of Intent to Relocate required by RCW 26.09.440, Sealed Personal Health Care Record, Retirement Plan Order, Confidential Reports as defined in (e)(2)(B), copies of any unredacted Judicial Information System (JIS) database information considered by the court for parenting plan approval as set forth in (f) of this rule, and any Personal Information Sheet necessary for JIS purposes, and evaluations and reports pursuant to chapter 10.77 RCW, therapeutic court risk/needs assessments, treatment evaluation and treatment compliance forms used in therapeutic court cases or otherwise ordered by a court, shall only be accessible as provided in sections (h) and (i) herein.
- (3) *Excluded Records*. This section (c) does not apply to court records that are sealed as provided in GR 15, or to which access is otherwise restricted by law.
- (d) **Restricted Personal Identifiers Not Required**—Except. Parties to a family law case or the protected person in a guardianship case or defendants in a therapeutic court or those ordered to do treatment by a therapeutic court shall not be required to provide restricted personal identifiers in any document filed with the court or required to be provided upon filing a family law or guardianship case, except:
 - (1) "Sealed financial source documents" filed in accordance with (g)(1).

- (2) The following forms: Confidential Information Form, Domestic Violence Information Form, Notice of Intent to Relocate required by RCW 26.09.440, Vital Statistics Form, Law Enforcement Information Form, Foreign Protection Order Information Form, and any Personal Information Sheet necessary for JIS purposes.
- (3) Court requested documents that contain restricted personal identifiers, which may be submitted by a party as financial source documents under the provisions of section (g) of this rule.

Comment

Court records not meeting the definition of "Sealed Financial Source Documents," "Personal Health Care Records," Retirement Plan Orders, Confidential Reports or court records that otherwise meet the definition but have not been submitted in accordance with (g)(1) are not automatically sealed. Section (3) provides authority for the court to seal court records containing restricted personal identifiers upon motion of a party, or on the court's own motion during a hearing or trial.

(e) Filing of Reports in Family Law, and Guardianship, and Therapeutic Court cases--Cover Sheet.

- (1) This section applies to documents that are intended as reports to the court in Family law, and Guardianship, and therapeutic court cases including, but not limited to, the following:
 - (A) Parenting evaluations;
- (B) Domestic Violence Assessment Reports created by Family Court Services or a qualified expert appointed by the court, or created for a therapeutic court purpose or otherwise ordered by a court;
- (C) Risk Assessment Reports created by Family Court Services or a qualified expert, or created for a therapeutic court purpose or otherwise ordered by a court;
- (D) <u>Treatment evaluation and compliance reports required by a therapeutic court or otherwise ordered by a court;</u>
 - (E) Mental health competency evaluations;
- (<u>ĐF</u>) CPS Summary Reports created by Family Court Services or supplied directly by Children's Protective Services;
 - (EG) Sexual abuse evaluations; and
 - (<u>FH</u>) Reports of a guardian ad litem or Court Appointed Special Advocate.
 - (2) (3) [Unchanged.]
 - (f) (g) [Unchanged.]

- (h) Access by Courts, Agencies, and Parties to Restricted Documents.
- (1) Unless otherwise provided by statute or court order, the following persons shall have access to all records in family law, or guardianship, or therapeutic court cases:
 - (A) (B) [Unchanged.]
- (2) Except as otherwise provided by statute or court order, the following persons shall have access to all documents filed in a family law, or guardianship, or therapeutic court case, except the Personal Information Sheet, Vital Statistics Form, Confidential Information Form, Domestic Violence Information Form, Law Enforcement Information Form, and Foreign Protection Order Form.

RE: ETHICS OPINION 20-07

The District and Municipal Court Judges Association (DMCJA) Board of Governors has reviewed the recent ethics advisory opinion 20-07 and would like the Ethics Advisory Committee (EAC) to consider the following response and request. The DMCJA believes that the EAC provides an important service to the entire judiciary and very much appreciates the guidance the EAC provides. While the DMCJA completely agrees that judicial conduct that promotes public confidence in the independence, integrity, and impartiality of the judiciary and that avoids impropriety and the appearance of impropriety is of the highest priority, it does not share the EAC's conclusion reached in opinion 20-07. We do not agree with a broad conclusion that all criminal defense attorneys who practice in a county's superior court who would serve as a pro tem judge over the same county's district court criminal matters undermine public confidence in the judiciary.

The EAC was asked if there were ethical issues with criminal defense attorneys who practice in a county's superior court serving as a pro tem in district court in the same county. In its opinion, the EAC begins by stating that there is no blanket prohibition on qualified defense attorneys serving as pro tem judges and concludes by stating with a bright line decision that there is one when it comes to criminal law.

The effect of this decision has decimated the amount of qualified and knowledgeable attorneys that are eligible to serve as pro tem judges when there are not direct disqualifying factors present in CJC 2.11. If attorneys who practice criminal law¹ do not serve as pro tem judges on criminal calendars in district and municipal courts, which make up the vast majority of calendars in courts of limited jurisdiction, then the pro

tem judges presiding in criminal matters are reduced to only lawyers who have no experience in criminal law. The public should have confidence that pro tem judges are knowledgeable and experienced in the issues they are asked to decide.

Another effect of this bright line rule recommended by the EAC is that it hinders the ability of the DMCJA to promote diversity. The entire judicial branch of the state of Washington is committed to address the "gavel gap" in terms of diversity. The criminal bar, which includes defense attorneys and prosecutors, is the most diverse group of lawyers and a pool of talent that courts must rely on not only for pro tem service but, for the future of the judiciary. Public confidence in the judiciary is highest when the face of the bench resembles the jurisdiction in which that judge presides.

The DMCJA agrees that there will be instances when attorneys should recuse themselves for various reasons, but these instances should be resolved on a case by case and court by court basis as discussed in opinion 20-07. The factors identified by the EAC are completely appropriate and each court should consider them when appointing a pro tem judge. Each pro tem judge should also consider them before accepting an appointment or ruling on an issue and/or a case. The factors identified by the EAC generally describe the current practice in any jurisdiction that appoints attorneys who practice criminal law as a judge pro tem.

It is also important to remember that anyone who serves as a judge pro tem in any court takes an oath to adhere to the Washington State and United States constitutions. Any judge pro tem is also subject to oversight of the Commission on Judicial Conduct (CJC). The public should have confidence that if any judge violates that oath he or she is subject to discipline from the CJC.

Finally, numerous former defense attorneys and prosecutors currently serve as some of the best elected and/or appointed judges in superior, district, and municipal courts. Many of those former criminal defense attorneys and prosecutors, including some DMCJA Board members, served as pro tem judges in courts of limited jurisdiction and gained valuable experience prior to being elected or appointed. They were elected or appointed in part because of their experience and their reputation for fairness that was developed while sitting as a judge pro tem.

The DMCJA appreciates the assistance provided by the EAC and agrees with the general reasoning and factors to consider that are given in the opinion. However, we respectfully request the EAC amend Opinion 20-07 to remove the bright line rule that concludes the opinion. The DMCJA believes that the factored test has been, and is an adequate safeguard to promote the integrity, independence, and impartiality of judges pro tem and that the test can be administered individually by each court and each judge pro tem. The DMCJA's request to amend the opinion is based on the reasoning that disqualifying otherwise eligible attorneys from presiding over criminal matters simply because they practice in that area of law is overbroad. The DMCJA believes that the fact that an attorney who practices criminal law does not automatically give rise to an appearance of impartiality for that attorney to serve as judge pro tem on criminal matters. Additionally,

eliminating otherwise qualified attorneys to serve as pro tems has had a detrimental effect on the courts of limited jurisdiction and, arguably, the public when less experienced attorneys are chosen to preside over such matters.

The DMCJA has received feedback from many of its members regarding this decision and how such advice has impacted the operations of the courts. We have worked hard to listen to the concerns of our members and to unify a response instead of having multiple, individual questions posed to the committee.

¹ Although the question answered by the EAC only pertained to defense attorneys, the reasoning of the opinion would appear to apply to prosecutors as well. Many courts of limited jurisdiction appoint out of jurisdiction prosecutors to serve as judges pro tem. The DMCJA, however, is not asking the EAC to opine on that issue.

ARLJ 14 -- COURT ADMINISTRATOR EDUCATION

(a) Purpose. The protection of the rights of free citizens depends upon the existence of an independent and competent judiciary. Courts require skilled court administrators to ensure an open, fair and efficient justice system. This is particularly true in courts of limited jurisdiction—the court level the public most often turns to for services. This rule establishes minimum requirements for education and training of court administrators and equivalent employees in courts of limited jurisdiction.

(b) Definitions.

- (1) "Court administrator", as used in this rule, means the court administrator or equivalent employee in a court of limited jurisdiction to whom the presiding judge may delegate administrative functions described in GR 29(f). Each district and municipal court presiding judge must designate at least one person as the court administrator for purposes of this rule. The presiding judge of each district and municipal court shall designate a minimum of one court administrator or equivalent employee per court to comply with this rule.
- (2) "Designee", as used in this rule, means the court administrator or equivalent employee as designated by the presiding judge.
- (3) "AOC" means the Administrative Office of the Courts described in Ch. 2.56 RCW.

(c) Minimum education requirement.

- (1) Each <u>designeecourt administrator</u> shall attend and complete the Washington Court Administrator's Academy ("Academy") within twelve months of initial appointment <u>as a court administrator in a court of limited jurisdiction.</u>
- (1)(2) Each court administrator or designee holding this position who has been a court administrator for fewer than four years at the time this rule becomes effective shall attend and complete the Academy within twenty-four months of the effective date of this rule.
- (2)(3) The Academy shall consist of no fewer than [fifteen] hours of education and shall include instruction about roles and responsibilities of court

- administration, ethics, GR 29, executive branch collaboration, court finances, human resources, and AOC resources and requirements.
- The Academy will be offered in conjunction with the annual DMCMA program that receives funding allocated by the Board for Judicial Administration's Court Education's Court Education Committee (CEC). Subject to the availability of CEC and AOC resources, the Academy may also be offered as a webinar or streaming video. if resources are available.
- (5) In the event of extreme hardship, a presiding judge may request on behalf of their court administrator designee a delay of not more than one year in the court administrator's completion of the to complete the Academy.
- (4)(6) The local court jurisdictions lack of adequate budgeting Failure of the local jurisdiction to adequately budget for the court administrator designee to attend the Academy shall not constitute an extreme hardship.

(d) Certified Court Manager Program.

- (1) A <u>court administratordesignee</u> who has successfully completed the Academy is eligible to attend and complete a Certified Court Manager <u>Program</u> (CCM<u>P</u>) <u>program</u>.
- (2) The CEC, in consultation with the District and Municipal Court Management Association (DMCMA), will adopt and publish the required curriculum and accreditation standards for the CCMP. The CEC may award credit for self-study or teaching.
- (3) Course credits will be given for programs the CEC determines enhance the knowledge and skills that are relevant to the court administrator designee's position.
- (4) CCMP certification shall be valid for [three] years.
- (4)(5) A court administrator designee must complete at least [15]15 hours of approved continuing education credits during the three years their certificate is valid to earn renewal of the certificate for an additional [three]three years.
- (5)(6) Credits earned by those who have received CCMP certification may not be carried forward into the next three-year certification period.

- (e) Reporting. The presiding judge or their designee shall annually register the name, address, and telephone number of the court administrator with the AOC as provided in ARLJ 12. The presiding judge or their designee shall report any change of court administrator to the AOC within 30 days. Each designee shall confirm with the Administrative Office of the Courts (AOC) on or before January 31 each year, in such form as the AOC shall prescribe, the designee's progress toward the minimum education requirements of section (c) of this rule during the previous calendar year. If the designee does not respond by January 31, their credits will be confirmed by default. A designee who does not have the requisite number of hours at the end of their three-year reporting period will have until March 1 to make up the credits for the previous three-year reporting period. These credits will not count toward their current three-year reporting period.
- (f) Compliance. A court administrator and any court personnel supervised in whole or in part by the court administrator who fails to satisfy the minimum requirements of this rule will be restricted from access to the Judicial Information System applications or data except as a public user. Notification of non compliance shall be reported to the chair(s) of the CEC and the presiding judge of the appropriate court.
- (g) Effective date. This rule becomes effective January 1, 2022.

Please find below the recommendations from the Rules Committee for proposed new rules and amendments published by the Washington State Supreme Court:

GR 39 SUP		This is a new GR proposed by the Washington State LFO Workgroup. If adopted, this GR would incorporate all the relief provided under statute for remission of LFOs. This proposal adopts the indigency standards of RCW 10.101.010 ¹ . The petition for relief would be submitted on a pattern form. The Committee agrees with the proponents' comments in the GR 9 cover sheet that this rule change would simplify and streamline the process for requesting LFO relief already available under statute and rule. No new LFO relief provisions are proposed within the rule.

¹ RCW 10.101.010(3) "Indigent" means a person who, at any stage of a court proceeding, is:

(c) Receiving an annual income, after taxes, of one hundred twenty-five percent or less of the current federally established poverty level; or

⁽a) Receiving one of the following types of public assistance: Temporary assistance for needy families, aged, blind, or disabled assistance benefits, medical care services under RCW 74.09.035, pregnant women assistance benefits, poverty-related veterans' benefits, food stamps or food stamp benefits transferred electronically, refugee resettlement benefits, medicaid, or supplemental security income; or

⁽b) Involuntarily committed to a public mental health facility; or

⁽d) Unable to pay the anticipated cost of counsel for the matter before the court because his or her available funds are insufficient to pay any amount for the retention of counsel.

CrRLJ 3.1	NO POSITION	This amendment adds a requirement that counsel representing indigent persons be familiar with appellate indigent defense standards.
CrRLJ 3.2(a) Recognizance	OPPOSE	This amendment to the rule proposed by Judge Kessler (Ret) that would preclude recognizance (bail / bond) as a pretrial release condition for non-violent offenses unless the accused has failed to appear on the current charge, is on probation for another charge, or has a pending charge predating the current offense.
		Unless one of the above-noted factors is present, recognizance could not be ordered for a non-violent offense, even if evidence before the court supports a finding of a likely FTA. The judge would also be precluded from requiring recognizance for non-violent offenses even if evidence supported a finding of substantial danger that the accused will commit a violent crime, intimidate witnesses, or interfere with the administration of justice.
		CrRLJ 3.2 already contains a presumption of release without recognizance. In order to require recognizance, the court must make specific findings of a likely failure to appear or a substantial danger that the accused will commit a violent crime, intimidate witnesses, or interfere with the administration of justice. The current rule also requires the court to consider the defendant's financial circumstances and set recognizance adequate to assure the defendant's appearance. Correctly applied, the current version of CrRLJ 3.2 protects defendants from unnecessary and burdensome release conditions and provides the court the discretion to protect individuals and the public when release conditions are supported by evidence.
		The basis for this proposal, according to the GR 9 cover sheet, is a belief, without any supporting facts, that the existing requirements of CrRLJ 3.2 are often not honored. If judicial officers are not scrupulously honoring the requirements of the rule, the better remedy is education, not the stripping away discretion exercised by trial court judges properly applying the rule.
CrRLJ 3.2(b) Cash Bail	SUPPORT	If adopted, this amendment would also eliminate the ability to post 10% on a bond and would permit cash bail. The committee supports this change in the current rule as it would the court with additional discretion in setting recognizance. Additionally, while a forfeited bond cannot be reinstated by the trial court, forfeited cash bail could be reinstated.

CR 71	NO POSITION	This proposed amendment to the Superior Court Civil Rules would establish a separate procedure for attorneys seeking to withdraw within 90 days of trial. The Committee considered whether a concurrent CRLJ would be beneficial to DMCJA members and concluded it would not. Issues surrounding civil trials in Superior Court are substantially different that those addressed in CLJs. Because this propose amendment only impacts Superior Court, the Committee recommends no position.
GR 22	NO POSITION	These proposed amendments address family law and guardianship records. The DMCJA proposal regarding therapeutic court records will likely be presented during the next comment cycle.
GR 23	NO POSITION	This amendment addresses professional guardians.
GR 24	NO POSITION	This amendment modifies the definition of practice of law consistent with the new RDI
APR 29	NO POSITION	This is a new APR that moves trust account requirements to the APRs
APR 30	NO POSITION	This is a new APR permitting an attorney to transfer to voluntary incapacity inactive status.
RDI	NO POSITION	The Rules for Discipline and Incapacity (RDI) will replace the current attorney discipline and incapacity structure. If the RDI are adopted, the following rules will also be amended for conformity: GR 1: Classification of Rules GR 12.4: WSBA Access to Records GR 12.5 Immunity APR 1, 5, 8, 9, 12, 14, 15 LPORPCs 1.0, 1.8, 1.10, 1.12A LLLT RPCs 1.0B, 1.15A, 5.4, 5.8, 8.4 RPCs 1.0B, 1.6, 1.15A, 5.4, 5.6, 5.8, 8.1, 8.4, 8.5
RPC 6.5	NO POSITION	This amendment provides clarification to RPC 6.5 regarding notice of conflicts.

APR 5	NO POSITION	Replaces the expiration of preadmission requirements to the July 31, 2022 end date

I also wanted to provide an update on several other rules provisions the DMCJA Rules Committee is working on.

ARLJ 11 – The new rule would address Court Administrator educational requirements. Rules is working with DMCMA for some clarification regarding the need to include the language referencing the Certified Court Manager Program within the proposed rule.

GR 11.3 / 11.4 – I have met with the Interpreter Commission Issues Committee and expressed DMCJA concerns regarding ability to comply with these new remote interpreter requirements. They are weighing whether to request recall of the rules and put a revised version out for publication. I have no heard anything further at this point.

CrRLJ 3.4 – Rules has determined that suggested revisions to CrRLJ 3.4 are premature. The consensus of the Committee is to defer any action until CLJs have had the opportunity to apply CrRLJ 3.4 and address any preliminary challenges to the mechanisms various jurisdictions will be implementing regarding the waiver provisions under CrRLJ 3.4(a) and securing the defendant's appearance for additional hearings under the 'good cause' standard of CrRLJ 3.4(d)

CRLJ 5 – We are continuing to evaluate possible changes to the rule to allow electronic exchange of documents.

2020-2021 DMCJA Priorities

The DMCJA faces unprecedented challenges that compel us to rethink how we operate. New issues such as the Coronavirus (COVID-19) public health emergency compounded with the longstanding, chronic issue of systemic racism require us to respond with creativity and cooperation to meet these challenges. The DMCJA has demonstrated that it can be nimble and responsive to a pandemic. We must apply this rigor to dismantling systemic racism in our justice system. Given these challenging circumstances, our 2020-2021 DMCJA Priorities have become even more essential to create a fairer justice system.

1. Identifying & Eliminating Systemic Racism in our Justice System

Direct and systemic racism has created individual and community trauma. A fair justice system must earn people's trust and confidence in order to properly function. We must do better, especially since we are the courts in which most people interact. Action is required. Empty platitudes will solve nothing. This crisis will not be fixed overnight but will require a recommitment by each judge every day. To that end, DMCJA is committed to recruiting more judges of color that will better reflect our communities across the State. DMCJA will also seek to improve data and utilize more effective research to better identify where systemic racism exists within our justice system and then address those inequities with best practice solutions. This commitment guides and permeates all of the following priorities.

2. Adequate Court Funding

The Courts of Limited Jurisdiction (CLJ) cannot provide services or justice without appropriate funding. We need to educate the public, from the voters to the legislators, regarding the effect that funding has on our ability to serve the constitutionally protected interests of the public. We should assess the mandated services the court provides and question how we are expected to provide these services in an environment of shrinking budgets. Major projects that need adequate funding are listed below:

a. JIS/Case Management

The Courts of Limited Jurisdiction Case Management System (CLJ-CMS) Project is moving forward. The Project ran into some unforeseen obstacles on our first try to find a commercial product that meets Washington's district and municipal court needs. In 2019, the Project Steering Committee (PSC) selected a commercial off the shelf (COTS) product based on the recommendation of Gartner, an industry leading consulting firm. The PSC also recommended selecting Tyler Technologies as its vendor after failed state contract negotiations with Journal Technologies. The DMCJA is committed to the full and complete sharing of information among courts, therefore, our association continues to support the CLJ-CMS Project and considers it a top priority.

b. Courthouse Security

The safety of all who visit our courthouses remains a top priority for the DMCJA. Without adequate security, the safety of all patrons is in needless jeopardy, including:

- Members of the public summonsed for jury duty, traffic infractions, civil cases, and criminal cases
- Every party involved in domestic violence cases, including alleged victims and witnesses, who
 appear to deal with domestic violence criminal cases, protection order cases, stalking and antiharassment cases
- Courthouse staff who are required to work every day in a building where disputes are resolved and where some of those involved in those disputes will present a risk for violence

General Rule (GR) 36, *Trial Court Security Rule*, as well as Minimum Court Standards, became effective on September 1, 2017. Judge Rebecca Robertson, Federal Way Municipal Court, and

Judge David Steiner, formerly King County District Court, prepared a GR 36 implementation guideline for DMCJA members that was disseminated to the association on August 1, 2017. Further, the DMCJA Long Range Planning Committee supports educating the association membership about pursuing federal grants related to courthouse security.

i. Courthouse Security Task Force

The DMCJA will actively participate with the Board for Judicial Administration (BJA) Court Security Task Force. Judge Rebecca Robertson, serves as the Co-Chair. DMCJA members also participate with this group. Ms. Harvey, DMCJA Policy Analyst, will also work closely with this task force. These DMCJA representatives will ensure that district and municipal court security issues are implemented in any and all reports and materials created by this initiative.

c. Access to Justice (Court Education, Interpreters and Technology Expansion)

Access to justice is critical to the citizens of Washington State. Access includes: quality interpreter services, courtroom and court staff accessibility, technological related access, and the facilitation of services for self-represented litigants. Several issues related to interpreters should be highlighted, including ADA/foreign language interpreters, the quality of interpretation options and access to interpreters. In our digitized world, members of the public should also have the option of using technology to access the courts. The DMCJA has supported the efforts of the BJA Court System Education Funding Task Force and BJA Interpreter Services Funding Task Force. Both task forces have obtained requested funds for court interpreter services and online court education, respectively. The DMCJA should continue to track pilot initiatives, such as Tukwila Municipal Court's robot, *Sheldon*, which is used to provide remote interpreter services.





3. Educate Justice Partners

To accomplish the goals of our member courts and the DMCJA as a whole, we must educate the executive and legislative branches of both local and state government. Through such education, the other branches of

government will learn of our accomplishments and needs. The Public Outreach Committee is tasked with developing materials that will assist both urban and rural court judges in educating local governmental agencies and the public. We may likely find that topics of importance to the judiciary may be just as important to cities, counties, and the state. These topics include, but are not limited to security concerns, court funding, the separation of powers, court administration, access to justice and access to court records and court information. Committee members suggested several ways to begin educating our justice partners, including creating reference materials for judges to obtain in a centralized repository on the Inside Courts web site. Initially, this repository will contain documents for use in contacting and informing local legislators, council members, and partner organizations of our accomplishments and needs. The DMCJA Public Outreach Committee will now serve as a resource for judges to find programs and plans for such things as state of the court addresses to the local funding sources and other community partners. Such partners may include: Association of Washington Cities (AWC), Washington Association of Prosecuting Attorneys (WAPA), Washington State Association of Municipal Attorneys (WSAMA), Washington State Association of Counties (WSAC), risk management agencies, city and county councils, local school districts, and civic and social clubs. Our members have done some amazing work in their communities and it is time for the public and governmental entities to learn about our courts and judges.

a. Public Outreach Committee

The DMCJA Public Outreach Committee has determined that its charges are (1) to educate justice partners on the accomplishments and challenges of district and municipal courts, and (2) to provide resource materials to assist DMCJA members when communicating with local governmental entities and stakeholders. This Committee will continue to partner with the Council on Independent Courts to educate justice partners.

b. Collection of Legal Financial Obligations (LFOs)

This issue was originally categorized under the heading of getting judges out of the money collection business. At the 2015 Board Retreat, the DMCJA Board discussed the difficulties of removing the courts from collecting LFOs and determined that a legislative change is necessary because laws require district and municipal courts to collect fines. In discussing this issue, the Committee determined that the category should be amended from *Courts out of the Collection Business* to the broader category of *Collection of Legal Financial Obligations*. The Committee recommends that the DMCJA consider *State v. Blazina*, 182 Wash.2d 827, 344 P.3d 680 (2015), legislative proposals, and court funding issues to address the courts' involvement in the collection of LFOs.

4. Preserving the Independence, Integrity, Quality, and Consistency of the Courts of Limited Jurisdiction
The purpose of this priority is to ensure that justice is dispensed fairly throughout the state for all criminal
defendants. The DMCJA thinks the court system is bifurcated and administrative court funding should be
consistently applied throughout the State to allow all courts to maintain their independence from the executive
and legislative branches of government. Judges should not be in jeopardy of losing their positions based upon
the exercise of judicial independence. In order to reach this goal, the DMCJA Board created the Judicial
Independence Fire Brigade Committee in May 2017. The Workgroup on Judicial Independence, a subgroup of
the Fire Brigade Committee, which has changed its name to the Council on Independent Courts ("CIC"), has
proposed suggested amendments to General Rule (GR) 29 and assists judges experiencing judicial
independence related issues. In 2019, the DMCJA membership voted for the CIC to become a standing
committee. The DMCJA needs to work to maintain the quality and consistency of justice across all courts of
limited jurisdiction. We must continue to work to remove statutory disparities between district and municipal
courts and monitor regional courts initiatives.

5. Foster Development of Therapeutic Courts (Community Courts, Mental Health Courts, Veterans Courts, Drug Courts, etc.)

The purpose of this priority is to address pressing issues facing our court community, such as mental health, homelessness, veteran needs, and drug addiction. The Board is concerned with the consistent management of mentally ill offenders. Defendants who do not arise to the level of the criminally insane, RCW 10.77, but need housing and services should be able to get the attention that they need in all Washington State courts.

6. Member Involvement

The DMCJA fulfills its statutory obligations through its committees. Therefore, the Board should actively encourage its members to participate in the committee work and governance of our organization. Some examples of encouraging member involvement include: (1) performing skits related to membership involvement during the Annual Spring Conference, (2) sponsoring a break out session about the association during Judicial College, and (3) highlighting members who have served on committees. Face to face committee meetings during annual conferences, placing committee sign-up sheets in the room during the annual DMCJA Business meeting, and providing an option to skype in to committee meetings may also encourage more member participation. It is also beneficial for the DMCJA to have a succession plan and active mentoring opportunities as judges leave the bench and new judges are elected or appointed. Approximately twenty-eight percent (28%) of the membership participate on DMCJA Committees.

This email is sent on behalf of DMCJA President, Judge Michelle K. Gehlsen, and DMCJA Legislative Committee Co-Chairs Judge Kevin Ringus and Commissioner Paul Wohl.

Dear Colleagues:

We write for your help addressing a court funding crisis developing this legislative session.

As you read this, the Legislature is considering dozens of meritorious and forward-thinking policy changes that will directly impact court operations. The District and Municipal Court Judges' Association (DMCJA) supports many of these reforms. While the reforms and goals are laudable, they won't pay for themselves. One bill with significant impacts, SHB 1320, is entirely unfunded. The current proposal is to delay the implementation of the bill and address funding and other issues in the future. Historically, that process has not worked to our benefit. Without some substantial changes, we can expect the costs to fall to our county and city budgets.

DMCJA has been working overtime to educate legislators about the costs, workload demands, and realistic implementation timelines. Many of you have helped in this effort. But it is important that county and city officials also understand the actual costs of these proposals and the consequences for their budgets. They often have relationships with local legislators that can add gravity to the concerns being raised. Accordingly, we ask you to contact your county/city commissioners, councilmembers, mayors, and executives to discuss this bill and the financial consequences if state funding is not appropriated.

Four documents are attached to this email. First is a letter template for you to send to your local elected officials. Based on your preferences, it can be sent by you, individual judges, or collectively by your full bench. Next is a breakdown of some of the major costs associated with this bill as calculated by the Superior Court Judges' Association. Their analysis applies equally to us. Third, an impact analysis provided by King County District Court and how much it will cost them to implement this bill. You may want to run a similar analysis for your court or use the analysis from King County for illustrative purposes. The final attachment is AOC's Judicial Impact Fiscal Note, which outlines some of the additional administrative costs.

The fiscal impact of this bill would be significant even in the best of times. Today, with courts and government resources severely challenged by the pandemic, they are staggering.

To reiterate, the DMCJA applauds important reforms, but it implores a realistic assessment of what is possible. Please reach out to your local city/county officials as soon as you can. The Legislature moves quickly. Time is of the essence to share these concerns with local officials.

SAMPLE LETTER FROM JUDGES TO COMMISSIONERS/COUNCIL MEMBERS AND EXECUTIVES/MAYORS
Dear Commissioner/Councilmember/Executive/Mayor:
I/We are writing to alert you to a bill pending in the state Legislature that will have a significant impact on our County/City budget and court operations. This bill, SHB 1320, has merit and important goals. To achieve the intended goals, however, this bill will impose substantive requirements on, and increase the budgets for, your county/city courts. It is extremely important to note that <u>as of this writing, none of these substantial fiscal impacts are funded</u> .
An illustrative impact of SHB 1320 is attached. It is written from the Superior Court perspective, but the analysis and fiscal impacts apply across the board. If passed, it is difficult to see how your county/city court(s) will be able to meet its/our Constitutional obligations and fulfill these mandates without substantial funds added to our budget to expand staff and operational resources. The financial burden to comply with new mandates will fall to our county/city.
Two obvious local financial impacts are readily apparent. First, by providing for attorneys to be assigned on civil cases (currently not required), our county/city will be paying for the costs of these appointments. Second, the implementation and coordination of IT work to accommodate the proposed database and information exchange will impact our local IT departments.
As you well know, no county/city in Washington has been spared by the financial crisis our nation faces. Almost every county/city is experiencing budget cuts, furloughs, program changes, and even lay-offs. We cannot conceive how our county/city can fund costs associated with this bill.
The District and Municipal Court Judges' Association (DMCJA) has been working hard to educate legislators about how their bills will affect court operations, costs, and county/city budgets. DMCJA does this on a daily basis – testifying at hearings, contacting legislators, and offering alternatives to bill sponsors. We also work collaboratively with the Washington Association of Counties (WASAC) and the Association of Washington Cities (AWC) to share this message with legislators. We are deeply concerned that our voices in these venues have not sufficiently communicated the real and critical financial impacts of these measures on state, county, and city budgets.
I/We need your help. I/We ask you to communicate this message directly with our local state legislators. Legislators have conveyed the approach of passing this policy, delaying its effective date, and leaving it for a future legislature to determine fiscal impacts and appropriate funding mechanisms. Historically, this approach has not worked well for counties and cities. We have been left holding the bag and disappointing our residents who have been promised unfunded mandates.
