CALL TO ORDER

Judge Jeffrey Smith, District and Municipal Court Judges' Association (DMCJA) President, noted a quorum was present and called the DMCJA Board of Governors (Board) meeting to order at 12:34 p.m.

PRESENTATION

- A. Ted Talk: <u>Sheila Marie Orfano and Densho: Can stereotypes ever be good?</u>
 The Board watched a Ted Talk and held brief discussion about the content.
- B. Who We Are Documentary <u>Trailer Rent/Buy Documentary</u>
 Judge Smith requested that Board members view the documentary Who We Are prior to the next meeting. The film is available for rent on several platforms.
- C. Presentation from Collaborative Partners Initiative Grant Writing Successes
 Collaborative Partners Initiative (CPIN) provided an overview of the work they've completed with courts of limited jurisdiction over the last year. A summary of their work is provided in the meeting materials.

GENERAL BUSINESS

A. Minutes

The minutes from the December 2023 meeting were previously distributed to the members. Judge Smith asked if there were any changes that needed to be made to the minutes. There being no changes, the minutes were approved by consensus.

B. Treasurer Report for December 2023

Treasurer Judge Jeffrey Goodwin was not present.

C. Special Fund Report for December 2023

Special Fund Custodian Judge Anita Crawford-Willis was not present. Tracy Dugas reported that about 50 members have paid special fund dues utilizing the only payment portal.

LIAISON REPORTS

A. Superior Court Judges' Association (SCJA)

SCJA President-Elect Kristin Ferrera reported that SCJA is continuing to work on legislative issues, including a proposal for judicial education. SCJA also continues to work on an internal anti-harassment policy for members.

B. District and Municipal Court Management Association (DMCMA)

DMCMA President LaTricia Kinlow reported that the DMCMA spring conference will be held at the Northern Quest (Spokane) in May. She suggested that leadership for each of the CLJ associations (DMCJA, DMCMA, and MPA) should attend the conferences of the other associations. A second CLJ Summit will be held in the coming months to follow up on issues raised at the first summit in October.

C. Misdemeanant Probation Association (MPA)

Representative Meagan Terlep-Boxley reported that registration for the MPA conference ends today, and MPA's Education and Training Chairs will be providing free training on fentanyl and substance abuse.

D. Washington State Association for Justice (WSAJ)

Representative Mark O'Halloran was not present.

E. Washington State Bar Association (WSBA)

Representative Dan Clark was not present.

F. Administrative Office of the Courts (AOC)

State Court Administrator Dawn Marie Rubio was not present.

G. Board for Judicial Administration (BJA)

Representative Judge Tam Bui reported that BJA Court Education Committee met this morning; they are continuing the work of revamping their policies. There will be an emphasis on livestreaming of education next year. Annual Conference will be held September 22-25, 2024. Judge Logan reported that BJA Budget and Funding Committee continues to discuss budget issues with Chris Stanley. Chris has regularly been presenting to the legislature and others on the judicial branch budget, and discussions for the next biennium will begin in May or June. Judge Robertson reported that the Trial Court Security Task Force has now been turned into a permanent Security Committee for BJA.

H. Judicial Information System (JIS)

Alex MacBain, Senior Court Program Analyst, reported that AOC is working with the Tribal State Court Consortium to engage with tribal courts on utilizing the Protection Order Document System (PODS). Regarding CLJ-CMS, the steering committee recently received a letter from Pierce County District Court requesting to be removed from the pilot, so AOC will be scheduling a meeting to better understand their reasons for that decision and plans for moving forward. The Enterprise Integration Platform project is nearing the end of the vendor selection process, and contract execution should happen by early February. More information is available in the meeting materials.

E. Judicial Assistance Services Program (JASP)

Judge Mary Logan reported that JASP has completed the Anger to Authenticity course, which has been handed off to Scott Hillstrom to be built into the Learning Management System (eLearning). JASP will be presenting at Judicial College this year.

F. Legislative Committee

Judge Kevin Ringus reported that the Executive Legislative Committee meets every week on Mondays during legislative session. Although this is a "short" legislative session ending in early May, there have been a substantial number of bills filed. The cutoff calendar has also been changed this year, with bills needing to be out of committee in their house of origin by January 31, which is the day that DMCJA Legislative Day will be held. Judge Ringus remarked that the incompetency bill, HB 2152, has been somewhat contentious. Several other issues and bills have been discussed by the committee, and members have testified.

G. Public Outreach Committee

Judge Michelle K. Gehlsen reported they the committee met this week, where they discussed the Legislative Day event planning with the Legislative Committee Co-Chairs. "You've Been Served," the Public Outreach event where legislators are invited to courthouses, will be held again this year in the fall but planning for that event will be on-hold until May.

A. Blake Update

Judge Smith reported that Justice Yu has convened a Blake Workgroup and requested his participation on behalf of DMCJA. Judge Smith noted that the goal of the workgroup appears to be seeking a way for the trial courts to help the Refund Bureau work better and more efficiently. Judge Smith reported that he has asked DMCJA staff to send out a poll to CLJ Presiding Judges to find out how courts are

handling Blake cases, how the prosecutor is involved in the process, whether or not courts have done any hiring to assist with the work, and if information is available on court websites. Brenden Higashi added that it appears that many advocates want the Blake processes to be similar from jurisdiction to jurisdiction, and for courts to have information about the process easily accessible on their websites.

CLJ-CMS Project (ITG #102)

Early Adopters Implementation Phase

Following the success of transitioning Tacoma Municipal Court onto Enterprise Justice, eFile & Serve, Enterprise Supervision, and Defendant Access, the Project Team has been working on the next steps for continued implementation of the CLJ-CMS project. The original implementation plan called for a pilot with several different locations and about 200 court and probation users. The size of the pilot was structured so that the overall performance of the new systems could be appropriately exercised and tested. The new systems are currently in use at one location with 40 users.

To better exercise and test the new systems, the CLJ-CMS Project Team will be moving forward with an early adopters implementation phase that will add new locations and increase the number of end users. The early adopters phase will include up to 10 courts that would all go-live by the 4th quarter of 2024. Eligibility criteria for the early adopters phase includes availability of key court personnel, size of the court, and complexity of the existing automated processes.

The number and size of the courts that will be in the phase, and the fact that participating courts will have few complex automated processes will allow for the projected expedited implementation timeline. The Project Team will take advantage of feedback from the pilot courts and lessons learned from the pilot todate to assist early adopter courts make a smoother transition to the new systems. The number of courts in the early adopters phase will be much smaller than future implementation phases – allowing participating early adopter courts more personalized service from the CLJ-CMS Project Team, up through the go-live process.

Based on preliminary qualifying criteria the Project Team has identified a small number of courts that they will be engaging with about their operations and their feasibility to implement the new systems this fall.

Outreach Plan

Work continues on finalizing a comprehensive, multi-prong outreach plan with the goals of earlier contacts with courts for sharing relevant information about the new systems; and providing guidance about how to begin to prepare for implementation.

The initial regional meetings will occur in Spokane on March 25th and Wall Walla on March 28th. Formal communication regarding these and future regional meetings will be sent in the coming weeks. These meetings are intended for Presiding Judges, Court Administrators/Managers, IT representatives, and Probation staff leaders for courts within a 50-mile radius of the meeting site.
