CALL TO ORDER

Judge Jeffrey Smith, District and Municipal Court Judges' Association (DMCJA) President, noted a quorum was present and called the DMCJA Board of Governors (Board) meeting to order at 12:32 p.m.

PRESENTATION

A. The Board discussed the documentary film Who We Are: A Chronical of Racism in America, which Judge Smith had previously requested that members view prior to the meeting.

GENERAL BUSINESS

A. Minutes

The minutes from the January 2024 meeting were previously distributed to the members. Judge Smith asked if there were any changes that needed to be made to the minutes. Judge Jewett noted that a correction needed to be made under Special Fund Report, which should say "Tracy Dugas reported that about 50 members have paid special fund dues utilizing the onlyonline payment portal." With this change, the minutes were approved by consensus.

B. Treasurer Report for January 2024

Treasurer Judge Jeffrey Goodwin provided the Treasurers Report and briefly reported on the transition to Umpqua Bank. The DMCJA accounts with Washington Federal and Bank of America are now closed. Judge Goodwin also noted that he is keeping a close eye on expenses and that the pro tem budget line is

already overbudget. The Reserves Committee will meet in March to discuss a proposed budget for 2024-2025, which will be approved by the Board at the May Retreat.

C. Special Fund Report for January 2024

Special Fund Custodian Judge Anita Crawford-Willis reported that special fund dues continue to come in.

LIAISON REPORTS

A. Superior Court Judges' Association (SCJA)

SCJA President-Elect Kristin Ferrera gave a brief report.

B. District and Municipal Court Management Association (DMCMA)

DMCMA President-Elect Frankie Peters reported that the next CLJ Summit, with leadership from DMCJA, DMCMA, and MPA, will be held on March 22. Frankie noted that DMCMA would be happy to review and assess legislative bills if DMCJA would like assistance.

C. Misdemeanant Probation Association (MPA)

Representative Meagan Terlep-Boxley reported that registration for the MPA annual conference, which will be held from April 29 to May 1 in Vancouver, opened this week. Meagan reminded that MPA meets quarterly, and their current big project is working on changes to ARLJ 11 which is the rule for how misdemeanant probation operations. Meagan reported that MPA is also looking to have their training academy move from the Criminal Justice Training Commission, which would require a legislative change.

D. Washington State Association for Justice (WSAJ)

Representative Mark O'Halloran was not present and did not submit a report.

E. Washington State Bar Association (WSBA)

Representative Dan Clark was not present and did not submit a report.

F. Administrative Office of the Courts (AOC)

State Court Administrator Dawn Marie Rubio was not present and did not submit a report.

G. Board for Judicial Administration (BJA)

Representative Robertson had no report. Representative Logan reported on behalf of BJA Budget and Funding that the judicial budget package is being receive favorably because we have stayed within the parameters of what a supplemental budget should be. The supplemental education funding proposals from DMCJA and SCJA are also being well-received. The Committee does not know yet what the process will be for decision packages for the coming biennium, but more information should be available soon.

H. Judicial Information System (JIS)

AOC Senior Court Program Analyst Alex MacBain reported that it has been a busy few weeks for the CLJ-CMS project. The Project Team will be reaching out to certain courts regarding the early adapter implementation phase, which will begin this fall. More information about the project and the Integration Platform is available in the meeting packet.

STANDING COMMITEEE REPORTS

A. Bylaws Committee

Judge Kristian Hedine was not present and did not submit a report but Natasha Johnson, committee staff, reported that proposed language was recently sent to the Reserves and Conference Planning Committees for their approval prior to presentation to the Board.

B. Diversity Committee

Judge Willie Gregory was not present and did not submit a report. Judge Williams reported that Diversity Committee is working on an education session for Spring Program. They will also be proposing a choice session with Oppression Monopoly for the Fall Conference.

C. DOL Liaison Committee

Judge Angelle Gerl reported that DOL Liaison Committee met in January. The Relicensing Subcommittee is still working on a relicensing template. Judge Gerl noted that Carla Weaver has informed the committee that not all courts are complying with the changes from (2021) SB 5226 regarding inability to pay, and the committee is working on a solution for how to address the issue.

D. Education Committee

Judge John H. Hart was not present and did not submit a report.

E. Judicial Assistance Services Program (JASP)

Judge Mary Logan reported that the Anger to Authenticity course is now up and running, and they are working to get CJE credits for the course. Dr. Kanther-Raz is working with the SCJA Wellness Committee, and Judge Logan is currently formulating an idea regarding "Take 10" for self-care.

F. Legislative Committee

Judge Kevin Ringus reported that there are several bills the Executive Legislative Committee is currently watching. DMCJA's bill regarding incompetency terms is still alive but will need to be pull from the House Rules Committee by next Tuesday, February 13. The committee is working with the bill sponsor, Rep. Thai, on an amendment to change the language from "mental health disorder" to "mental health condition." WAPA has also now requested a change to the "inability to proceed" language. Judge Ringus also reported that the DMCJA Legislative Day, held on January 31, was a success with about 30 judges attending the event in Olympia to meet with over 70 legislators. Melissa Johnson, the DMCJA lobbyist, sends a report to full DMCJA membership every week that should help to inform about what is going on with session. Melissa's contract with DMCJA will expire on May 31 this year so the Board may need to discuss a new contract prior to the Board Retreat in May where it will be approved.

G. Public Outreach Committee

Judge Michelle K. Gehlsen reported that the Public Outreach Committee hasn't met since her last update. The committee continues to work on supporting Law Day events throughout the state, and they will begin planning for the next You've Been Served event, which is held in September, at their May meeting. In addition, they are looking at starting another toolkit to assist judges who would like to participate in community events.

H. Rules Committee

Judge Catherine McDowall reported that the Rules Committee will be discussing the rules that have been proposed for comment, but they have already provided feedback on many of them because they were given an opportunity to comment through the BJA Remote Proceedings Workgroup.

I. Therapeutic Courts Committee

Judge Fred Gillings reported that the Therapeutic Courts Committee met earlier this month. They received updates on the relicensing project from Judge Howson and on Legislative Day from Judge Finkle. They informally surveyed the committee about who will be attending the All Rise conference in May, and more than half of the committee will be attending.

JIS Report

CLJ-CMS Project (ITG #102)

Early Adopters Implementation Phase

As previously indicated, to better exercise and test the new systems, the CLJ-CMS Project Team is moving forward with an early adopters implementation phase that will add new locations and increase the number of end users. The early adopters phase will include 10 courts that would all go-live by the 4th quarter of 2024. Eligibility criteria for the early adopters phase includes availability of key court personnel, size of the court, and complexity of the existing automated processes.

The Project Team is working to identify the courts that will be part of the early adopters implementation phase, with the goal of making final decisions by early April.

Outreach Plan

The outreach plan was developed based on feedback from the pilot courts regarding gaps they identified in the areas of communication, project tasks, and training. The goals of these earlier contacts with courts are sharing relevant information about the new systems; and providing guidance about how to begin to prepare for implementation. These in-person regional meetings are intended for Presiding Judges, Court Administrators/Managers, IT representatives, and Probation staff leaders for courts within a 50-mile radius of the meeting site.

Formal communication regarding the outreach plan was sent in mid-February. Formal communication regarding the first batch of regional meetings was also sent in mid-February. The initial regional outreach meetings will occur in Spokane on March 26th and Wall Walla on March 28th. Followed by meetings in Chelan on May 7th, Snohomish on May 14th, and Tukwila on May 16th. There is a registration process for these meetings outlined in the formal communication.

Each quarter and following each information session, the CLJ-CMS project team will be hosting brief Zoom webinars that demonstrate how you would use Enterprise Justice and other supporting systems. These remote sessions will give a more comprehensive demonstration of the different functions available in eFile & Serve, Enterprise Justice, Enterprise Supervision, Defendant Access, and Judge Edition. The demonstrations will be broken into specific sessions so that court leaders and staff can elect to join only those sessions on systems they would like to see. The initial remote demonstrations will be in late April. Expect additional details on these demonstrations shortly.

THIS AGREEMENT is entered into between the WASHINGTON STATE DISTRICT AND MUNICIPAL COURT JUDGES' ASSOCIATION ("Association" or "DMCJA"), established pursuant to RCW 3.70.010, and BOGARD & JOHNSON LLC.

1. RECITALS

- A. The Association is mandated by RCW 3.70.040(3) to report annually to the legislature on the condition of business in the courts of limited jurisdiction and to make recommendations to the legislature as to needed changes in the organization, operation, judicial procedure and laws or statutes affecting such courts.
- B. The Association is in need of having regularly available representation in the legislative process to assist with the formulation and presentation of mandated recommendations.
- C. The Lobbyist is able to provide the assistance and representation needed by the Association in making necessary and appropriate recommendations and presentations to the legislature.

2. <u>AGREEMENT</u>

- A. <u>Term</u>: This agreement shall be for the period commencing <u>July June</u> 1, 202<u>4,2</u>1 through May 31, 202<u>6,42</u> unless earlier terminated as provided below.
- B. <u>Compensation</u>: The Association shall pay to the Lobbyist the sum of \$1564466,000.00 for the Lobbyist's services to be paid as follows:

\$6,5000 per month due on the 15th of each month, commencing with the month of July June, 202421.

- A. The Association shall provide direction to the Lobbyist as to what recommendations, presentations, and other lobbying efforts are to be undertaken by the Lobbyist for and on behalf of the Association.

The Lobbyist shall make and maintain all necessary and required Public Disclosure Commission filings, together with any and all other filings and reports as may be required by law in the conduct of lobbying activities. Such forms shall be made available to the Association for inspection upon request to the Lobbyist from the President of the Association. The Lobbyist shall obtain and maintain in effect any licenses as may be required by law to conduct lobbying activities.
- G. The Lobbyist agrees to provide the Association a list of all other employment secured by the Lobbyist prior to the commencement of the 20235 and 202642 regular legislative sessions and promptly advise the Association of any actual or potential conflicts of interest that exist prior to or arise during the legislative session.
- Η. Specific additional lobbying services shall include, but not be limited to the following:

- (1) Support, provide information, testify on behalf of or seek defeat or amendment of pending legislation as requested by the Association.
- (2) Identify opportunities to involve the Association's Legislative Committee members, committee chairs, and individual members in the legislative process, either through testimony, making personal contacts, and/or participating in meetings with legislators or the Governor.
- (3) Attend meetings of the Association's Legislative Committee and provide regular reports of legislative activities. Maintain regular contact with the Association's Legislative Committee chair and staff.
- (4) Attend Board of Judicial Administration (BJA) Legislative Committee meetings.
- (5) Represent the Association legislative interest to the Governor's office and pertinent state agencies during session and interim as needed.
- (6) Assist the Association's Legislative Committee and Board of Governors in the development of a legislative agenda during interim by participation in its development, coordination of appropriate contacts with legislators, development of appropriate legislative agendas, and consultation on presentation.
- (7) Attend, provide information, and report to the Association on legislative activities of other groups as requested by the Association during the interim. Assist the Association when requested with other interest groups.
- (8) Arrange pre-session and in session meetings with key legislative leaders and other contacts.
- (9) Accompany DMCJA members when meeting with legislators.
- (10) Accompany DMCJA members when testifying at legislature.
- (11) Attend, provide information, and otherwise represent the Association at legislative assembly days, other scheduled meetings of standing committees or legislators during the interim months.

5. <u>TERMINATION</u>

- A. This Agreement shall automatically terminate May 31, 202642, unless terminated earlier as provided below.

Either party may terminate this Agreement, without cause, by providing written notice of termination to the other party not less than 30 days before the end of any calendar month (28 days in February). In the event this Agreement is terminated by the Association, the Lobbyist shall be entitled to retain all compensation previously paid under the terms of this Agreement and the Lobbyist shall be entitled to receive monthly compensation for the month immediately preceding termination. In addition, the Lobbyist shall be paid a final severance in the amount of \$62,000.00.
- D. 6. <u>INDEPENDENT CONTRACTOR</u>

The Lobbyist is an independent contractor with the Association and is not an employee. The Lobbyist shall accrue no claim against the Association under this Agreement or otherwise for vacation pay, sick leave, retirement benefits, social security benefits, workers compensation benefits or employee benefits of any kind.

7. ACTIVITIES NOT COVERED BY THIS AGREEMENT

This Agreement does not cover any activities related to salaries, pensions, and/or benefits to Association members. Any activities necessary for such issues shall be subject to a separate agreement between the parties.

8. ASSIGNMENT PROHIBITED

Neither party may make or permit assignment of any rights or obligations covered by this Agreement without the written consent of the other party.

Memorandum for Discussion

To: DMCJA Board of Governors

From: DMCJA Rules Committee

Date: March 1, 2024

In January, the Supreme Court published dozens of proposed rules for comment. Many of the proposed rules that have been issued for comment have come from the Remote Access Proceeding Workgroup. Several of our Board members were involved in those efforts, and we had input at that stage. Rules Committee does not plan to recommend comment on any of those proposals, but we are monitoring comments to them to determine whether it makes sense to send a comment in support.

Some of the other proposed rules listed for comment were proposed by other parties. The Rules Committee reviewed these proposals and will recommend specific language for the April Board meeting, but what follows is a summary of the general approach the Rules Committee recommends for each of these proposed rules.

RECOMMENDATIONS FOR COMMENT

1. CrR and CrRLJ 3.2 (proposed by DPD).

- **SUMMARY:** This proposal would amend the bail release rule to allow defendants to deposit 10% of an ordered bond amount with the court and that such deposit is returned at the conclusion of the case if the conditions are followed.
- PROPOSED POSITION: Oppose
- **REASON FOR POSITION:** DMCJA realizes that there are problems with the bail system, but opposes attempts to change this system via rulemaking. Stakeholders from every part of the system (prosecutors, court administrators, defenders, judges, bail bondsmen, etc) should be consulted on a viable approach. This proposal is confusing and difficult to implement from a court administration perspective in many smaller jurisdictions.

2. CrR and CrRLJ 4.7 (proposed by DPD).

• **SUMMARY:** This proposal would allow defense attorneys to provide redacted discovery to their clients, without review by the prosecutor or the court to determine if the redactions are complete and appropriate. The rule would also require member courts to develop local rules adopting a process and guidelines for redaction within three months of adoption of the rule.

• PROPOSED POSITION: Oppose

• REASONS FOR POSITION:

- Proposed rule would endanger the personal information of crime victims and once released to a defendant would be impossible to remedy. The prosecutor review puts a needed check on release of such information.
- Proposed rule requires courts to develop a policy which may not apply to them, posing an unnecessary burden on jurisdictions where the problems sought to be addressed by the rule almost never arises.
- DPD appears to be trying to solve a single county problem with rule making that affects the entire state.

3. CrR and CrRLJ 8.3 (proposed by DPD).

- **SUMMARY:** This proposed change would allow a court do dismiss a criminal prosecution due to arbitrary action or governmental misconduct, <u>without</u> a showing of prejudice to the defendant that materially affects the defendant's right to a fair trial.
- **PROPOSED POSITION:** Oppose
- REASONS FOR POSITION:
 - Oppose because it removes all guidance to courts for what to consider when deciding whether to dismiss a case from the rule.
 - Rule would result in wildly different standards being applied from court to court
 as judges invent their own standard for a reason that would be sufficient to justify
 dismissal.
 - Violates separation of powers by infringing on a prosecutor's discretion to
 prosecute, essentially substituting the court's opinion on whether a case should be
 allowed to proceed for any reason, similar to the problems addressed with the
 failed HB 1994.

RULES WITH POTENTIAL IMPACT ON DMCJA COURTS

The Rules Committee notes the potential impact on our member courts of the following proposals, but does not recommend DMCJA taking a position on the proposals unless comments by other parties suggest a need for response. We will be keeping a close eye on the comments submitted in favor of or opposed to these rules.

- o GR 11.3 Remote interpretation guidelines.
- o GR 3.2 Calculations of time for incarcerated individuals
- o GR 41 Remote jury selection. All discretionary, not mandated.

What Can I Do About Racism? FOR WHITE PEOPLE

1. RECOGNIZE IT

- Genetics aside, white is a color/race.
- Acknowledge racism exists.... Understand that it is not all about slavery.
 It is important that white people understand the benefits reaped from
 historical and current racial practices. Notice where those practices
 continue and question if you participate in them. Understand race and
 racism present complexities and contradictions. Do not try to reduce or
 simplify.
- There is no excuse for unconscious racism.

2. LISTEN

- Listen to people of color just listen. When a person of color is sharing their experiences, resist any urge to jump in and minimize or excuse their feelings. Understand that when a person of color talks to you about racism, they are trusting you. Treat that trust with the utmost respect. If you offend someone (we all do), instead of saying, "I don't know why you're upset," try something like, "I want to understand better to avoid a possible mistake going forward please tell me more about why you're upset."
- **Honor experience**... Remember people of color are sharing their experiences, not merely voicing opinion. Experience trumps opinion. Remember people of color have experiences you don't. Being defensive gets in the way of listening.
- Not everyone is either white or a person of color... Let people selfdefine and respect their identities.

3. EDUCATE YOURSELF

- **Know our history**... And make sure that your kids know the facts. Make sure your kids' teachers know the facts, too.
- Acknowledge and examine our society's stereotypes... Assume you've been influenced by them (we all have). Work on stereotypes of, or prejudices toward, others you may have. Deconstruct your view and see where they have been influenced by internalized racism and strive to overcome those views.
- Don't repeat the mistakes of the past... Examine personal behavior and lessons from history to avoid behaving in ways that are destructive to racial justice.

What Can I Do About Racism?

4. BROADEN EXPERIENCES (CAUTION: COMPLETE STEPS 1 – 3 FIRST)

- Learn about other cultures... Not by asking questions, but by spending time with people.
- Get out there... Put yourself into environments predominantly attended by people of color. Make a commitment to participate in an activity that helps you to shift your awareness.
- **Make new friends**... Diversify your circle of friends. Stereotypes have power when we don't know people as individuals.
- Raise smart kids... Expose them to differences early on. Actively encourage your children and all children to develop relationships with people of color, both adults and children.

5. TAKE ACTION

- Consider racism a problem you can help solve... Always confront racism and inappropriate behavior/language when you see, hear, read, or experience it. Encourage others to talk about racism. Learning "what not to say" is not the goal.
- **In the media**... Be willing to discuss media reports with family, friends, and co-workers to educate them and yourself.
- **At work**... Whatever your place of profession, eliminate institutionalized practices that are discriminatory toward people of color. Maintain a wide range of employees.
- **In the community**... Become involved in an organization that is involved with communities of color.
- With your kids... Because people often live in mostly segregated parts of any city/town, integrate the books and toys in your children's school and at home. Promoting a racially integrated educational environment is best for white kids as well as kids of color.

What Can I Do About Racism? FOR PEOPLE OF COLOR

1. BE REAL

- **Be yourself**... The best way to eliminate negative images and create positive images is to be who you REALLY are.
- Love yourself and one another... You have too much in common to not support each other. Hold each other up.
- Gather courage to show up as who you are... Don't hide your opinions, your interests, and your reaction to America's norms people can and will respect you for it.

2. SPEAK OUT

- Our voices are important... It is important for America to hear from people directly impacted by racism not just from white people who believe racism is wrong.
- Remember that we are not powerless... Do not be fearful of speaking up if a person, regardless of age or status, says a racist comment or joke.
- **Always be armed**... Educate yourself read and listen so that you can bring facts and passion to the table (see 3 below).

3. EDUCATE YOURSELF

- **Know our history**... And make sure that your kids know the facts. Make sure your kids' teachers know the facts, too. Teach the children in your life from an early age to have pride in who they are and their race.
- Acknowledge and examine our society's stereotypes... Assume you've been influenced by them (we all have). Work on stereotypes of, or prejudice toward, others you that you may have. Deconstruct your views and see where they have been influenced by internalized racism and strive to overcome those views.
- Charles Barkley was wrong... You can and should be a role model for what we as a people can do in the world and in America.

What Can I Do About Racism?

4. BUILD TIES

- **Join together as people of color**... Know the interconnected history of people of color in the United States. Put yourself into environments where you are likely to get to know more people of color that are of a race different than your own.
- Do not talk about any other group the way you would not want others talking about you... Instead, make an effort to learn about all groups.
- Not everyone is either white or a person of color... Let people self-define and respect their identities.
- Make a commitment to recruit everyone... We need everyone all people of color and white people. We need to partner with everyone who shares our vision of racial justice.

5. TAKE CARE

- Many white people care deeply... Know that there are white people who care about eliminating racism.
- Walk away when you are too tired, too angry, or just don't feel like confronting racism. Make your health and sanity a priority. A good balance is to walk away, but let people know why you are walking away. Then you've said something without getting into a long or frustrating discussion.
- Have a safe person/group where you can vent your anger, sadness, or rage over racism when emotions arise.
- Appreciate progress, but don't be seduced... Many Blacks in America have been successful we even had a two-term president however, don't let the progress for some distract from the truth about the conditions still experienced by most Blacks in America.
