Call to Order & Approval of Meeting Minutes

Justice Barbara Madsen called the Judicial Information System Committee (JISC) meeting to order at 10:02 a.m. This meeting was held virtually on Zoom.

Justice Madsen asked if there were any changes or additions to be made to the October 2022 meeting minutes. Hearing none, the meeting minutes were approved as written.

eFiling/Courthouse News Service Litigation

Mr. Dirk Marler briefed the Committee on the Courthouse News Service litigation, which has been taking place all across the country. Courthouse News Service (CNS) styles itself as a legitimate independent news service primarily focusing on civil litigation, whose core audience is lawyers and law firms who subscribe to the service. Essentially, CNS wants unfiltered and prompt access to new non-confidential civil case filings, and they sue in federal court alleging violations of First Amendment rights when they do not get that access. Mr. Marler outlined a number of issues that are involved in this litigation, as well as explained CNS's argument that as more cases are being filed electronically, the public does not have as readily-available access to those filings they would had the cases been filed in person at the courthouse. Actions have been brought in 25 jurisdictions across the country, ten or eleven of which are still open. Outcomes to these litigations have been varied. Mr. Marler added that while CNS has been active in Washington, it has not been litigious thus far.

HB 1320-1901: Protection Order Document Sharing (PODS) for Judicial Officers (ITG 1344) Project Update

Mr. Sriram Jayarama gave a presentation on the Protection Order Document Sharing (PODS) for Judicial Officers project. As part of House Bill 1320/1901, the Legislature mandated a mechanism for all judicial officers statewide to be able to electronically view Protection Order (PO) documents. JABS will be the statewide viewer for PO documents; only public POs will be available, and these documents will be viewable by any judicial officer if their JABS profile already allows them to access such information across courts. Because POs are stored in multiple Document Management Systems (DMS) across the state, AOC will build a "proxy" mechanism to go between JABS and the various DMS to "fetch" the document images for JABS display. PO documents will not be stored by AOC.

Mr. Jayarama then gave an update on recent project activities, as well as provided a process overview that included examples of what the changes look like in the JABS docket screen, case order screen, and person order screen and how the PO document images will look when accessed. The team is currently conducting testing in the lead up to go-live, and will be starting User Acceptance Testing in the second week of December. The first phase implementation (superior courts) is scheduled to go live on December 30, 2022.

Mr. Kevin Ammons gave a status update on some technical issues with a few of the link-only courts; nine of the fifteen link-only counties are working through technical issues at this time. It is likely that some of these counties may not be ready for the implementation on January 1, 2023. AOC continues to work with all of these courts to help resolve the outstanding issues, and will also be communicating status updates out to court customers leading up to the implementation.

JIS Priority Project #1 (ITG 102): Courts of Limited Jurisdiction – Case Management System (CLJ-CMS)

CLJ-CMS Project Update

Mr. Garret Tanner provided an update on the CLJ-CMS project; he reminded the Committee of the Pilot courts go-live delay and the project team's next steps going forward. These include preparing for and completing Solution Validation (end-to-end testing) to ensure the system meets the needs of the CLJs, completing data exchanges with Justice Partners, and reviewing go-live tasks and assumptions to identify a new data for Pilot courts go-live. Mr. Tanner then gave details on Solution Validation status, recent eFiling and CMS activities, project outreach, and work in progress; he then highlighted updates to the project issues and risks.

Quality Assurance Assessment Report

Mr. Allen Mills, with the project's QA vendor Bluecrane, provided an overview of the October QA Assessment Report for the CLJ-CMS project. The full report can be found in the JISC meeting packet.

JIS Budget & JIS 23-25 IT Decision Packages Update

Mr. Chris Stanley provided a brief 21-23 budget and JIS 23-25 decision packages update. The current biennial expenditures are still running as has been expected. AOC are projecting to be approximately

\$7 million in the red by the end of the fiscal year. AOC has submitted a budget request to backfill that amount on a one-time basis in the current fiscal year. Going forward, AOC is asking for \$12 million a year as a deposit from the General Fund into the JIS account. The reception AOC's decision packages have received from the Legislature at this point is noncommittal, but legislators recognize the critical importance of the JIS account. Mr. Stanley added that many of the individuals and groups he has spoken with (including legislators) did not know that the courts' entire IT infrastructure is financed by traffic tickets. Mr. Stanley reminded the Committee that these requested funds are for the base budget of work, to stabilize the existing expenditures of the account.

Data Dissemination Committee (DDC) Report

The Data Dissemination Committee did not meet this month, as there were no new agenda items.

Meeting Wrap Up & Adjournment

Justice Madsen adjourned the meeting at 11:26 a.m.

2023 Legislative Session

The House and Senate have returned to holding committee hearing and floor action in person; however, they have retained the opportunity to testify on bills remotely.

Important Upcoming Dates:

Friday, February 17 is the last day for bills to be voted out of their policy committees, unless the bill is in the House fiscal committees, Senate Ways & Means Committee, or Transportation committees.

Friday, February 24 is the last day for bills to be voted out of the House fiscal committees, Senate Ways & Means Committee, or Transportation committees.

Wednesday March 8 is the house of origin cutoff. Bills must be voted out of their chamber of origin by 5pm.

2023 BJA Request Legislation

The Administrative Office of the Courts (AOC), on behalf of the Board for Judicial Administration (BJA), filed four agency request bills in the 2023 legislative session.

- <u>HB 1023</u>- Eliminating wiretap authorization reporting to the administrative office of the courts
 - o Prime Sponsor: Representative Walen
 - Summary: Increases court efficiency by eliminating AOC and the Chief Justice's reporting requirements for wiretap authorizations.
 - o Referred to House Rules Committee
- HB 1102 Concerning judge pro tempore compensation
 - o Prime Sponsor: Representative Taylor
 - Summary: Addresses the pay disparity that exists for retired Superior Court Judges and Supreme Court Justices when they return to pro tem in a Superior Court.

Currently, retired Superior Court judges and Supreme Court Justices make 60% of what is paid to private attorneys who serve as pro tems.

- o Voted out of the House (96-0-2); Referred to Senate Law and Justice Committee
- <u>SB 5003</u>- Increasing the number of district court judges in Snohomish county
 - o Prime Sponsor: Senator Lovick
 - Summary: Changes the number of District Court Judges in Snohomish County in statute from eight to nine.
 - o Voted out of the Senate (49-0); Referred to House Civil Rights & Judiciary Committee
- SB 5128/HB 1598- Concerning jury diversity
 - o Prime Sponsor: Senator Trudeau and Representative Hackney
 - Summary: This is an omnibus bill with 4 subproposals aimed at increasing jury diversity by removing barriers to jury service. Barriers such as juror pay, dependent or child care, and electronic service of jury summons. This bill also continues pertinent data collection regarding juror demographics in Washington and forms a workgroup to study the potential implementation of a childcare voucher assistance program or jurors.
 - o [HB 1598] Filed 01/26/2023; Referred to House Civil Rights & Judiciary Committee
 - o [SB 5128] Heard in the Senate Ways & Means Committee on 01/31/2023

<u>Positions taken by the Board for Judicial Administration and/or the Administrative Office of the Courts</u>

- SB 5046 Concerning postconviction access to counsel
 - o Prime Sponsor: Senator Saldana
 - Summary: Directs the director of the Office of Public Defense to administer additional state-funded services for appellate and postconviction indigent defense. Requires counsel to be appointed at state expense to indigent persons filing a first, timely personal restraint petition; for petitions authorized by the Legislature; or if a final decision of an appellate court creates an ability to challenge a conviction or sentence. Clarifies when counsel may be appointed at state expense to file or prosecute second or subsequent personal restraint petitions or other collateral attacks. Tasks the Office of Public Defense to study the barriers to providing postconviction counsel to indigent persons.
 - o Heard in the Senate Ways & Means Committee on 01/31/2023
 - o BJA Signed-in Pro
- **SB 5155** Concerning the court of appeals
 - o Prime Sponsor: Senator Wagoner
 - Court of Appeals request legislation
 - Summary: Removes certain language from state law addressing the administrative matters of the Court of Appeals for: providing that panels of judges in the first division are to be comprised of judges as directed by the chief judge of that panel; and providing for the transfer of judges or cases between divisions as directed by the Chief Justice of the State Supreme Court.

- o Placed on Senate floor calendar
- o BJA Signed-in Pro
- SB 5347 Concerning access to abstract driving records
 - o Prime Sponsor: Senator Wagoner
 - DMCIA request legislation
 - Summary: Authorizes the Department of Licensing to provide an abstract of the full driving record, and all alcohol related offenses to an alcohol or drug assessment or treatment agency for an individual who has applied for evaluation or treatment. Permits probation officers and probation clerks employed by a court to provide an abstract driving record to a treatment agency. Permits courts to waive production and copying fees for the abstract driving records of indigent persons.
 - o BJA Signed-in Pro
- SB 5392 Concerning overpayments for certain matters
 - o <u>Prime Sponsor:</u> Senator Schoesler
 - WSACC request legislation
 - Summary: Permits courts to retain overpayments in amounts of \$10 or less in connection with any litigation. Overpayments shall be remitted by the clerk of the court to the local treasurer for deposit in the Local Current Expense Fund.
 - o BJA & AOC Signed-in Pro

Legislative Topics of Interest to the Judiciary in 2023

This session the legislature has focused on bills that address homelessness, legal financial obligations, and the Blake decision.

There are several pieces of legislation of interest to the judiciary:

- HB 1432/SB 5474- Concerning juvenile justice
 - o Prime Sponsor: Representative Farivar and Senator Frame
 - o Summary: Eliminates legal financial obligations for juveniles.
- **HB 1492** Providing relief for persons affected by State v. Blake
 - o Prime Sponsor: Representative Simmons
 - o Summary: Expands definition of LFO and what can be reimbursed under *Blake*.
- HB 1715- Enacting comprehensive protections for victims of domestic violence
 - o <u>Prime Sponsor:</u> Representative Davis
 - Summary: Strengthens the protections and simplifying the process for protection orders for domestic violence survivors; adds victim monitoring and notification technology in all courts/jurisdictions in Washington.
- SB 5197- Addressing landlord-tenant relations by providing technical changes
 - o Prime Sponsor: Senator Kuderer
 - Summary: Makes technical fixes to the Eviction Resolution Pilot Program; mandates that courts allow remote participation by any party in forcible and unlawful detainer actions.

- **SB 5434** Concerning the jurisdiction of juvenile court
 - o Prime Sponsor: Senator Trudeau
 - Summary: Increases the minimum age of juvenile court jurisdiction; increases the maximum age of incapacity; establishes that children ages 8 through 13 charged with murder in the first or second degree are presumed incapable of committing the crime; and creates a Raise the Age Juvenile Justice Task Force to consider and provide recommendations regarding implementation of juvenile jurisdiction expansion.
- SB 5467/HB 1613- Encouraging treatment for possession of certain counterfeit drugs or controlled substances
 - o Prime Sponsor: Senator Salomon and Representative Rule
 - Summary: Makes knowingly possessing a counterfeit substance a gross misdemeanor; requires peace officers to include time and place to appear in court on notice to appear; vacates convictions with proof of completion of a use disorder program.
- <u>SB 5536</u>- Concerning controlled substances, counterfeit substances, and legend drug possession and treatment
 - o <u>Prime Sponsor:</u> Senator Robinson
 - Summary: Makes knowingly possessing a controlled substance a gross misdemeanor, encourages prosecutor to divert cases to treatment services, court must advise defendant of available pretrial diversion programs, and vacates convictions with proof of completion of a use disorder program.
- SB 5644/HB 1769- Concerning juvenile records
 - o Prime Sponsor: Senator Frame and Representative Cortes
 - Summary: Explains that all records relating to the commission of juvenile offenses are confidential; requires courts to provide written notice to individuals whose records are sealed that includes an explanation of what it means to have a sealed juvenile record; creates a cause of action where various legal and government entities that disseminate sealed or destroyed juvenile records may be sued for damages by the subject of those records; provides individuals whose records are eligible for sealing with access to an attorney, if necessary.
- SB 5707- Establishing a housing court pilot program
 - o Prime Sponsor: Senator Kuderer
 - Summary: Creates a housing court pilot program in courts of limited jurisdiction; tasks the administrative office of the courts with facilitating the creation and implementation of this pilot program.

HB 1715 – Protections for Domestic Violence Victims







Introductory Note on Project Structure

The Courts of Limited Jurisdiction – Case Management System (CLJ-CMS) Project consists of three primary areas of activity, namely:

- eFiling
- Case Management
- Supervision

These three high-level "workstreams" or "sub-projects" ultimately combine to deliver an integrated solution for participating district and municipal courts (and some other entities such as violations bureaus). However, work in each sub-project is being planned and conducted as a separate activity with a keen awareness of interdependencies and the interrelationships that will eventually come into play. For these reasons, much of our risk analysis will assess the three sub-projects individually. For consistency in terminology, we will reserve the term "CLJ-CMS" to refer to the three combined sub-projects and use the terms "eFiling," "Supervision," and "Case Management" to refer to the individual efforts.

1. Executive Summary

1.1 Executive Overview

This report provides the February 2023 Quality Assurance (QA) assessment by Bluecrane, Inc. ("bluecrane") for the Washington State Administrative Office of the Courts (AOC) Courts of Limited Jurisdiction – Case Management System (CLJ-CMS) Project.

Solution Validation (SV) began February 6, 2023, after the CLJ-CMS Project Team completed their review and initial testing of the Priority 1 fixes delivered by Tyler Technologies at the end of December 2022. *This is outstanding news!* We congratulate the team, AOC, Project Steering Committee, Pilot Courts, and other stakeholders who have persevered through the delay from late last summer to ensure a quality solution is being delivered. There is "a long road" still ahead, but the start of SV is a very significant milestone for the project. The progress of SV over the coming weeks will be a critical element in determining a new Pilot Court Go-Live date with a high degree of confidence.

From our high-level, independent perspective, there are three "areas" of activities that are most significant at the current time. They are:

- 1. Outstanding Priority 1 Issues: Delivery of the remaining outstanding Priority 1 fixes by Tyler. As of the writing of this report (a bit earlier than usual due to busy February calendars at Washington Courts), there are 24 Priority 1 issues outstanding. They all relate to Data Conversion.
- 2. Data Exchanges and Data Conversion: Complete necessary work to utilize the Enterprise Data Repository (EDR) and ensure all legacy data exchanges are viable in the new solution's environment. As has been previously reported, data conversion for Enterprise Supervision is becoming a complex undertaking, given the manner in which probation information is stored in JIS. The CLJ-CMS Project Team's testing of Alliance (the assimilation of the new Enterprise Supervision solution with Enterprise Justice) continues.
- 3. Completion of SV and Incorporation of Priority 2 Fixes Expected in April: As we have reported previously, AOC will not initiate Pilot Court Go-Live until Tyler delivers fixes for all Priority 1 and Priority 2 defects in their 2022.1.6 release which is currently targeted for mid-April 2023. If the results of SV confirm that the Tyler solution is working as expected and the Priority 2 fixes are on-track, then a date for Pilot Court Go-Live can be selected and announced at that time.

As SV was getting underway during the first week of February, a potential issue was identified with the Washington State Patrol (WSP) legacy data exchange. At this time, it appears that WSP will not be able to complete the necessary work on its end to modify the legacy data exchange to accept "Law Table Updates" from Enterprise Justice (as opposed to JIS). The CLJ-CMS Project Team believes that a temporary "work-around" may be able to be used until the WSP modifications can be made. More analysis is needed (and is underway by the team) to understand how significant the issue is. For now,

we are not assessing this as a critical risk. However, it is on our "watch list." Once the team completes its analysis, we will be in a better position to assess the risk to Pilot Court Go-Live.

As we have noted for many months, staffing continues to be a risk for the CLJ-CMS Project. Labor market challenges that are beyond AOC's control continue to be a challenge. However, we are able to report that other projects in the Olympia and Seattle areas with which *bluecrane* is involved are beginning to see increased numbers of qualified applicants, apparently due to the large layoffs that have occurred (and are continuing to occur) in the technology business sector.

We continue to encourage limited jurisdiction judges and other stakeholders to lobby the legislature to approve the Decision Package (DP) for the integration platform project (which is an internal infrastructure project separate from the CLJ-CMS Project) as well as other budgetary requests essential to keeping the JIS fully funded. At this time, the integration platform effort is progressing through appropriate governance processes without impacting the performance and delivery of the CLJ-CMS Project.

New risks identified in February are the ones related to data conversion for Enterprise Supervision and the WSP "watch list" item noted above. The data conversion risk is being worked on by the CLJ-CMS Project Team and Tyler Technologies. With the initiation of SV, risks to schedule are continuing to decrease. While we are not ready to reduce the assessment level of schedule from "red" yet, we are cautiously optimistic that, if all goes well in the first few weeks of SV, a Pilot Go-Live date can be announced at that time.

1.2 Executive "At-a-Glance" QA Dashboard

The following table provides a summary of our risk assessment ratings for this month and the previous two months. Detailed findings, risk explanations, and recommendations for risk response are provided in Section 2 of this report. As a reminder to the reader, "blue" items indicate areas of ongoing risk; however, the mitigation and other response activities of the Program for blue items are assessed as adequate for the current review period.

At its August 26, 2022 meeting, the JISC approved a motion for AOC to seek funding from the legislature and begin planning activities while awaiting funding to develop an "Enterprise Integration Platform." The platform will adopt a common communication standard for all systems, thereby enabling new systems to "be plugged into" existing systems at a lower cost with a much faster development time. The platform is essential to protect the state's network, servers, and systems from unauthorized access and intrusion when third-party systems are allowed to retrieve and update data that is protected for confidentiality purposes. It is expected that the platform will provide logging, auditability, and support features, including reporting and tracking mechanisms for problem resolution.

During the summer months of 2022, a significant risk to the CLJ-CMS Project was the potential expansion of project scope that was being contemplated by the Project Steering Committee (PSC) as tolerable and permissible. In keeping with our dislike of "cookie cutter" approaches, we tailored the specific areas of assessment for relevance and importance to CLJ-CMS at this stage of its program lifecycle. Some of the areas noted in the diagram have been assessed at a relatively detailed level, while others are so early in their lifecycle that a more thorough assessment will come later.






Figure 1. Areas of CLJ-CMS Project Assessed for Risks

Call to Order

Chief Justice González called the meeting to order at 9:00 a.m.

The Supreme Court is in the process of lifting some of the COVID emergency orders. A draft of the revised orders is available from Jeanne Englert or Reza Pazooki. The new orders will be finalized next week.

Innovating Justice Awards Presentation of Awards

The purpose of the Innovating Justice Awards is to recognize those who provided exceptional leadership to resolve critical court needs and helped courts deliver innovative and responsive justice by promoting race equity and access to justice.

The Innovating Justice Award recipients were:

- 1. Legal Financial Obligation counties, including Representative Tarra Simmons with Civil Survival in collaboration with all the county courts; Judge Kevin Hull with Kitsap County Superior; Judge Michael Schwartz with Pierce County Superior Court and Judge Carol Murphy, Thurston County Superior Court. They were nominated by Cynthia Delostrinos, who also presented the award.
- 2. Commissioner Clint Johnson, Pierce County Superior Court. Commissioner Johnson was nominated by Tacomaprobono Community Lawyers and the award was presented by Carly Roberts.
- 3. Commissioner Brandon Mack and the Clallam County Dependency Court Improvement Team. They were nominated by Judge Brent Basden who also presented the award.
- 4. Clark County Volunteer Lawyers Program and Executive Director Elizabeth Fitzgerald. They were nominated by Judge Tsering Cornell who also presented the award.

BJA Task Forces and Work Groups

Alternatives to Incarceration Task Force

The Task Force just had its second meeting. The Task Force has a diverse and engaged membership. Two work groups will begin soon, an assessment and information gathering work group, and a work group that will solicit information on how to incorporate feedback from those impacted by the judicial system. Co-Chair Judge Kyle Mott will be leaving for private practice, and Judge Mary Logan will become the new co-chair.

Court Security Task Force

The Task Force met on September 26, 2022, and reviewed the budget package and development of a new advocacy campaign. The Task Force has met with commissioners in some small, rural counties who will support the court security budget package.

The Task Force tried last session to obtain funds for court security. The feedback from the Legislature was that local funding needed to be contributed as well. This year the budget request includes asking for matching funds from counties on a sliding scale.

Chief Justice González thanked Penny Larsen for her work.

Remote Proceedings Work Group

The first meeting of this Work Group will be October 26, 2022. They will discuss deliverables, assessment, best practices, and court rules work groups.

Chief Justice González would like assistance with the interim order that will replace the emergency orders. The Supreme Court is still working on finalizing remote proceeding rules. The Supreme Court voted to issue an order to preserve some sections of the emergency orders, including keeping remote proceedings in criminal, civil, juvenile and family cases. Courts will be able to continue with procedures currently in place.

Dirk Marler has been asked to review the orders on electronic signatures. Remote oaths and weddings should also continue. Chief Justice González would like input on the Involuntary Treatment Act rules.

The draft order is ready for review and was shared with the court associations this morning. Jeanne Englert also has a copy. Input on the draft order is requested by early next week.

Presentation: Structure of the Washington State Bar Association (WSBA)

Terra Nevitt presented on *Examining the Integrated Bar Structure*. Recommendations were made to the Supreme Court last week. Terra Nevitt reviewed the current structure and history of the WSBA and why the WSBA structure is being examined.

Recommendations included:

- 1. current federal litigation does not require the WSBA to make a structural change;
- 2. it will be important for the WSBA and Supreme Court to act if there is a ruling that forces a structural change;
- 3. litigation aside, the ideal structure is the current integrated model.

The recommendations are from the majority report; there is also a minority report. The reports were sent to the BJA membership prior to the meeting.

Standing Committee Reports

Budget and Funding Committee

The Judicial Branch budget request was submitted September 24, 2022. There are more requests statewide than last year.

The revenue forecast is tenuous. A recession is likely, and revenue is likely to fall. Continued losses of revenue will constrain opportunities for new funding, and it is likely that not all 34 packages will be funded. Christopher Stanley is working with Brittany Gregory to reach out to the Legislature and leadership in both chambers, as well as educating legislative staff on the Judicial Branch top priorities and on the full request generally.

Court Education Committee (CEC)

The CEC is planning for the spring programs to be held in person. A roster of dates will be sent in a week or so. Recorded sessions are being moved to the Learning

Management System (LMS) where they can be accessed. The CEC is running campaigns to work with small groups in the LMS for feedback.

The BJA members received a draft of ARLJ 14, Mandatory Continuing Education Standards for District and Municipal Court Administrators, for review. This will be on the November BJA agenda for a vote. Town halls will be held in December to introduce the new rule and standards, which will be effective January 1, 2023.

The first five days of the Judicial College will be held in person. Three days later there will be two days of virtual presentations.

The CEC is still working on a strategic plan.

Legislative Committee (LC)

The LC is meeting with legislators on budget priorities and garnering support. The LC is still working on information gathering on the jury diversity package. Committee days will be in person on December 1 and 2, 2022. There will be two or three bills related to the *Blake* decision. The LC has been invited to hold Law School for Legislators. Judge Scott and Brittany Gregory will reach out to see who would like to participate. An inperson legislative reception in January is possible.

Policy and Planning Committee (PPC)

The PPC will be meeting today with guests from Gender and Justice Committee (GJC) Implementation Committee to discuss the GJC survey and implementation recommendations. A follow-up plan of the local funding survey will be discussed.

Legislative Advocacy

The BJA discussed the need to improve communication with the Legislature. AOC's OJLR is helping to finalize a talking points guide that is included in the meeting materials. Brittany Gregory requested feedback. Brittany Gregory is also working on email templates and simulated conversations with legislators.

Interbranch Advisory Committee

The Interbranch Advisory Committee met in September. The Committee heard from Brittany Gregory about legislative priorities and from Christopher Stanley on the budget. The next meeting will be on December 15, 2022, via Zoom. The Zoom link and materials will be sent to participants.

September 16, 2022 Minutes

Judge Pennell corrected Court of Appeals information sharing from the September 16, 2022 minutes to "resuming traveling sessions."

It was moved by Chief Justice González and seconded by Judge Pennell to approve the September 16, 2022, meeting minutes. The minutes were approved by consensus with the noted correction.

Information Sharing

- Judge Pennell reported a task force was put together by the Court of Appeals to address obstacles to getting trial court records for appeals. This is particularly an issue for attorneys in rural areas. The Task Force membership includes appellate judges and clerks, transcriptionists, court recorders, and others. Anyone with ideas on this subject may contact Judge Pennell.
- Judge Fearing said the court backlog from the COVID pandemic has reached the Court of Appeals, where case numbers are down about 25%. He expects to be back up to normal case numbers soon.
- Judge Haan announced that the Cowlitz County Hall of Justice will be closed November 18, 2022, for an active shooter training followed by mock event. She will be happy to speak to any court interested in the training.
- Judge Forbes said the Superior Court Judges' Association (SCJA) is working on the emergency orders draft. Judge Forbes attended the Salary Commission meeting and can answer questions about that.
- Commissioner Leo welcomed the two new District and Municipal Court policy analysts attending the meeting, Antoinette Bonsignore and Brendan Higashi.
- Dawn Marie Rubio pointed out the e-mail sent this week announcing the publication of the *Full Court Press*.
- Jim Bamberger is busy with the expansion of the appointed counsel program for children and the civil public defense program for indigent defendants. He thanked AOC and the fiscal team for their assistance with OPD budget request.
- Carl McCurley discussed the Beta phase for making information from caseload reports more accessible and easier for courts to understand. There will be invitations to review the work.
- Esperanza Borbora announced the Access to Justice (ATJ) conference, September 28–30, 2023, in Tacoma. It will be a hybrid conference. ATJ has four new board members. The Delivery Systems Committee is reviewing and updating ATJ hallmarks and the state plan.
- Dirk Marler reminded the participants that the trial court legal services team is fully staffed and available to assist trial court judges.
- Jeanne Englert reminded the participants that the November meeting will be a
 joint meeting with the Court Management Council.
