Justice James Johnson is retiring as a Justice of the Washington State Supreme Court effective May 1, 2014. The court finds that it is necessary for the prompt and orderly administration of justice that Justice Johnson be appointed as a Justice Pro Tempore to complete pending cases and other judicial business.

Now, therefore, it is

ORDERED:

That the Honorable James Johnson be appointed as Justice Pro Tempore to serve for a period of 60 days commencing on May 1, 2014, pursuant to RCW 2.04.240(2). Justice James Johnson has voluntarily elected to forego the compensation and benefits authorized in RCW 2.04.250. Thereafter, the appointment as Justice Pro Tempore shall continue, pursuant to RCW 2.04.240(1) to act on the cases on the attached list until their completion.
