I don't know why an order of protection is not in force. It is absolutely horrible that a sick individual has the right to drag up all that poor girl's pain AGAIN in public. There is usually a lot of excruciating pain for the victim for a very long time. I guess there are some sadistic individuals still around who want to go back to the days when women were called liars, were "asking for it", said no when they "really meant yes", were "a slut anyway, so what's one more", shouldn't have "been dressed that way," and especially since law enforcement officers generally discouraged complaints from someone of "her ilk", or shouldn't have been in a bar, shouldn't have been using drugs, shouldn't have been sitting there allowing someone to put a roofie or micky in their drink. Makes me wonder what law enforcement does when their female vice officers, informants, volunteers get robbed, attacked, raped, poisoned, OD'd, porned or have car accidents, home invasions, vandalisms, loss of property and money, serve jail-time "by mistake", and get charged with the very crimes they are trying to stop. Worse still, for a person to volunteer to help stop certain crimes, you can bet they have been or are a victim of those crimes, and have been brutally hurt. Probably, most police forces do nothing, because they tell themselves, that they are saving the life of the poor volunteer, because somehow it was leaked that the volunteer was helping the cops, which opened them up to more punishments.

I know all they said to me went I went through that all very recently was that I shouldn't have been using drugs. And, I can't get any lawyer to touch this with a ten-foot pole. They say it is politically incorrect. So I sit here in my smashed up trailer, 50 grand gone, teeth gone (from infectious disease/merca/drano?/) scarred, raped, repeatedly vandalized, lied to or misled or ignored or discounted by everyone from the judge to the sherriff's, to border patrol, to fbi, to mental health associates, to the hospital, to ptpd, to the state attorney generals office, to aclu, to the warden, to public defender's office, to the army, the navy, to OPNET, to OLYCAP, to NAMI.

What else did the social security payee program people think would happen, when a ptsd/adhd/bi-polar/cult abuse/child abuse/spousal/family/abuse panic disorder survivor/patient gets 7 years back pay (when the back pay is actually from the theft and sale of the person's home, after they have had to live homeless/unemployable for 7 years? They give them a dump to live in, pay rent on, repair, get told its a control dope house-and sign them up for 7 years more of being scammed into giving away all the "back pay" for the "control house" so they can help the cops "catch" the bad guys, if they live that long, while OPNET "funds" itself through lots and lots of "property seizures", and "money seized during drug extortions, and blackmails, I mean "raids", cars, all kinds of groovy stuff, especially things like films, tapes, evidence of all kinds of things. I hear certain "friends" of OPNET find great interest in the films of women like me who did not even know about all the cameras, (some optical sensors like the ones developed for penn state, get these girls all whacked out on various dosages of whatever drugs-you can imagine the films-XXX. One bar here got shut down when I reported the films were here.

At the same time, computer hackers/cable tv hackers/phone/cell phone hackers, control who you are allowed to speak to, what news you see on tv, info you can find out on the net. Add to the fact that your cars are all siezed, your lisenca siezed and that whenever you leave your house, some one will

usually break in and take things to punish you, confuse you, scare you, make you spend a lot of time being misdirected, upset, afraid, crying, stealing identity papers, or any evidence you have that points to any of their misdeeds. Townies, strangers, etc., will keep giving you hints that yes something is wrong, but no one will dare upset the delicate financial balance that is barely maintained by this system, as all the jobs here virtually depend on this whipping post scapegoat/sacrifice of the low man on the totem pole being as exploited as possible, as well as the group having a monopoly of each element in the town: One psychiatrist. One grocery store. One fast food. One mental health facility. One drug treatment facility. One person judges if you are crazy, what meds you get. one person judges whether you need drug treatment or not. one judge decides what your sentence should be. there are no appeals or second opinions here, and all that is wide open to so many kinds of abuse. No inpatient, so adatsa is not available here. Though a statewide program, you are not allowed to use other counties treatment centers unless you live in that county. Mostly u pay out of pocket here, 3-5 days a week. Treatment is in groups, and the focus is on information gathering for crimes. That is the only place in the county to go to get an alcohol and drug assessment done (cash only-160 bucks) naturally they want you to sign up and find a way to be there every weekday 3-5 hours, pay 120 a week, even for those under the poverty level. (when will u go to work). Participants in the payee program are pressured to spend a certain amount of their monthly pittance on street drugs and told they are part-time cops, but they can make a lot of money (not for themselves) helping law enforcement, but if they don't do the game right, they go to jail. People can pay someone to voluntarily do someone else's time for them, or someone can pay someone else to force time upon an unsuspecting victim, especially if they are able to claim that fool is their wife or child. Supposedly the jailbird is rewarded for their help, unless the person who claimed them can slide out of repayment by secretly being "married:ie, having sex, with someone else a certain amount of times within a certain time period. By the same token, a woman who dated more than one guy, essentially belongs to both guys and must support them work for them or do time for them. No we are not in harlem. If u refuse to let one of them stay with you, live off you, donate to their support, let them go do crimes? in your car, therefore in your name, using your money, there will be hell to pay. So if you cooperate with law enforcement, all of whom are undercover naturally, giving out money, use of cars, phones, put up with the extortions, fires, floods, invasions of your time, home, money, privacy, self, then you are called the dope queen. when you run out of all those things, they want you to be the whore/porn queen. at any rate, all the crimes etc., especially terrorism, siezures, poisonings, drug deals, whatever they are all doing in your house/car/name/computer/phones are all blamed on you, even though you do not know most of the time what they are talking about, showing you with their own version of charades, gang signs, by the things they say, steal, do, imply, that is too bad, because not having knowledge of a law does not make you not guilty. They have 3 or more people there at any time so you will not know which one did the nasty act toward you, depends on who is highest on the totem pole. Neighbors, people you see on the bus, grocery store, street, only will be a witness for you, give you an emergency helping hand, report anything they see happening to you, if you pay them very very well, if you have any money left by then. Usually the situation calls for them to go to the offender and get paid for not telling on them. Some just go for the highest bidder, so do the lawyers, judge, cops, I think. I complained to the sherriffs dept, and the warden my public defender, therapist, drg counselor. What that all got me was a year long experience from hell where i was harrassed and kept awake for 11 days straight, my car was tampered with i think, i finally went over the edge emotionally, mentally, and drove my car and pulled off the road while having a flat tire, hit a telepone pole, got charged with dui after a whole bunch of different kinds of cops suddenly surrounded me, gave brealhlyzers, etc, went into ptsd mode, got accused of tweaking (meth), arrested by highway patrol, sent to jail for 40 days without any of my 7 medications, told to plead guilty. cos my mother was going to die, got

out on probation, and was subsequently arrested 6 more times for-not enough urine. too clear urine. being late to probation, cos the bus went past me would not stop, one time for using drugs in order to be able to be checked into inhouse treatment on adatsa in kitsap county, stayed 4 days got sent to jail for relapsing on probation. All to be a total of exactly 180 days-, no good time cos i complained about everything while there, hoping to find a real cop. Extremely extensive time, and being told initially by the prosecutors office that they had probable cause (even though I passed all breathlyzers) because my teeth were all out my head. the teeth fell out because of the poisonings. I got a severe ear infection, which was ignored, a very painful sty in my eye, harrassed by inmates for helping cops. the doctor and nurse told me they would dissolve the ear wax then give drops for the ear infection. then turned around and did it backwards, drops first, the dissolve wax, then antibiotics for a grand total of over 6 weeks in excruciating pain. Nobody wants to repair my house. Return priceless family treasures. Replace my teeth. My money. My liscence. Several years of hell, total terrorism and hell. I filed a torte claim to sue the county. No one will help. Time is up in a week where i have to file some otherkind of thing. Mental health proffessionals suddenly gave me a payee who is doling out parts of my tiny monthly check. Guess they don't want me to get a lawyer even if I could find one. The woman will not give me a reference. Of any kind. Cos I complained. No one has done a single thing to alleviate any of the problems i now face. I refuse to leave untill something is done. A rat infestation, fire, flood, cut phone lines, virus on computer, home invasions, finding pictures of myself online...that just makes me more determined that this stuff has to stop. thank you.
