Dear Members of the Court:

I send this comment with regard to the pending proposed changes to ELC 3.3 and 6.6. These provisions address the current diversion program. I suggest that the proposal pending may be counter-productive. Diversion is available to attorneys in circumstances in which the infraction is understood to be minor, and is not reflective of on-going attorney misconconduct. The attorney is provided the opportunity to acknowledge the misconduct and take action to avoid further violation of the Code.

This option permits the lawyer to take steps to improve conduct, which may include such things as better law office management, time management, counseling to address a life crisis or mental health issues. The improvements are obviously beneficial both to the attorney and to present or potential clients. The confidentiality presently afforded by the rules is the incentive to the attorney to address the existing impediments to appropriate attorney conduct.

Please consider these concerns. I urge that you not accept the proposed changes to ELC 3.3 and 6.6.
