POSITION DESCRIPTION:

The Municipal Court of Seattle is one of the highest volume Courts of Limited Jurisdiction in the State. The Court has over 200 staff with a total of 13 Judicial Officers including seven Judges, and six Magistrates.

This is an opportunity to serve your community by considering appropriate sanctions for all violations of the law. These sanctions range from imposition of fines on traffic infractions to incarceration on criminal charges when assigned Municipal Court Judge duties in a pro tempore capacity. In this role you would directly interact with citizens and ensure that each person is afforded a full and fair hearing for their case.

JOB RESPONSIBILITIES:

- Conduct hearings on red light traffic camera enforcement and parking ticket hearings and makes proposed settlements.
- Preside over infraction trials as an impartial arbiter between the City of Seattle and the defendant, ruling on the law applying to the facts presented and imposing financial sanctions based on case factors and defendant history.
- Preside over impound release hearings with individuals who have had their vehicles impounded.
- Determine if good cause exists to vacate a default judgment or quash a warrant issued
- Review correspondence from defendants wishing to mitigate infractions.
- Serve in formal court as a judge pro tempore when an elected judge is unavailable.

QUALIFICATIONS:

- Doctor of Laws or Juris Doctorate degree
- Member of the Washington State Bar Association in good standing
- Licensed attorney having practiced law for at least five (5) years with substantial criminal experience
- To be considered, all applicants must fully complete the online application form, supplemental questions, and include a cover letter and resume (either pasted in the resume section or uploaded as attachments).

The Court seeks highly qualified candidates who possess judicial temperament and demeanor, which means one possesses diplomacy and objectivity in the fulfillment of all job duties; maintains decorum in a courtroom; fair and equitable administration of the law while provides good customer service; conducts court business in a manner that brings honor and respect to the organization; establishes and maintains effective working relationships with all levels of staff; and demonstrates willingness to promote and explain court programs through speaking engagements at community and school events.
