SUBJECT: SUMMARY OF CHANGES TO GUARDIANSHIP FORMS

The Pattern Forms Committee updated the set of Guardianship forms. The update includes changes to implement Laws of 2011, ch. 329, and recommended changes.

2.4 Income Tax Payments/Accounting Fees

The Guardian is authorized to make payments for income tax due as required, and to pay fees for accounting services required in connection with the preparation of income tax returns.
