SUBJECT: JUNE 2020 SUMMARY OF CHANGES TO SEXUAL ASSAULT FORMS

The Washington Pattern Forms Committee updated the Sexual Assault forms. The changes are based upon:

- Title changes to the Order to Surrender and Prohibit Weapons forms;
- Feedback received from the judicial community; and
- Administrative edits.

	Page 5: <b>Complete the Temporary Orders</b> : If you ask the court to order the respondent to surrender firearms and other dangerous weapons, bring the <i>Order to Surrender Weapons <u>(and Prohibit</u> <u>Weapons, if applicable)</u> Issued Without Notice, form All Cases 02-030 for the judge to complete.</i>
	<b>Go to Court</b> : Bring your completed petition and temporary order and the blank order to surrender <u>and prohibit</u> weapons to the clerk's office of the local court. They will direct you further.
	Service of Court Documents: Unless the respondent or the respondent's lawyer was present at the hearing, the petition, any temporary order, and any order to surrender <u>and prohibit</u> weapons must be served on the respondent.
	If you filed on behalf of a vulnerable adult, unless the vulnerable adult or the vulnerable adult's lawyer was present at the hearing, the petition and any temporary order and order to surrender <u>and prohibit</u> weapons must be served on the vulnerable adult.
	If the court orders respondent to surrender <u>and prohibit</u> weapons, the local law enforcement agency must serve the order.
	If the court does not order respondent to surrender <u>and prohibit</u> weapons, you may choose service by:

Service:
If the court orders respondent to surrender weapons, or to surrender weapons and be prohibited from possessing weapons, local law enforcement must serve the respondent.
