The Washington Pattern Forms Committee has created new and updated protection-order forms based on the <u>Laws of 2021, ch. 215, §§18 and 25(E2SHB 1320)</u> and user feedback. The forms were also updated to improve accuracy and increase clarity of the form information.

The existing Order for Service of Summons by Mail forms have been updated and combined into PO 025 Order to Allow Service by Mail. This form replaces SA9_060 and VA9_060. The Order for Service of Summons by Publication has also been updated and combined into PO 026 Order for Service of Summons by Publication. This form replaces SA9_020, VA9_020, and DV9_020. The Law Enforcement Information Sheet (LEIS), WPF All Cases 01.0400, has been updated also. One new form has been created: PORHA Remote Hearing Attachment.
