		<u>Changed</u> sec 5 "Is there an emergency guardian?" to reflect the ability to obtain an emergency guardian by filing a motion in a Minor Guardianship case. See SB 5788 Sec1 changes to RCW 11.130.225.			
		Added "or nominated" to "[] A parent asked 'or nominated' for someone to serve as guardian" located in sec 9 regarding who else must be given notice addressing that a parent can ask for an individual to be named as a guardian by nominating someone in a sworn record. Sec * of SB 5788. Changes to RCW 11.130.215.			
		<u>Changed</u> sec 17 regarding knowledge of an Indian child to address <i>Dependency of Z.J.G.</i> , decided by the WA Supreme Court in 2020 (196 Wash.2d 152). (Courts must treat the child as an Indian child if there is a question of whether the child has Indian heritage.) Renamed the section "tribal heritage" and added a clear descriptor.			
		<u>Added</u> additional language when describing how the petitioner knows a child does not have tribal heritage. "I know this because (explain if the children have no tribal heritage, or if any possible tribal heritage has already been explored and decided in another court proceeding that complied with ICWA)."
