- RE: Summary of Changes for Misdemeanor Judgment & Sentencing forms, based on Laws of 2023, Ch. 161 and Laws of 2023, Ch. 449, Legal Financial Obligation forms, and No Contact Order forms.

The table below outlines changes based upon newly enacted legislation.

## Legal Financial Obligation (LFO) Forms

Changes to the Legal Financial Obligation forms will be published and effective based on Supreme Court Order. Please see the associated rules for changes.

## No Contact Order (NCO) Forms

- 1. NC 02 0100 No Contact Order
   Removed language specific to a Domestic Violence No Contact Order because a standalone Domestic Violence No contact Order was created.
  - Changed surrender language in sec 3 "<u>immediately surrender all firearms</u> and other dangerous weapons in your custody, control, or possession and any concealed pistol license to (local law enforcement agency)" to comply with change to RCW 9.41.800(6) in HB1715.
  - Added <u>"This order replaces all prior no-contact orders protecting the same person issued under this cause number.</u>" to section 4.
