Changed section 15 to better reflect the language in RCW 11.130.280 and .380. Changed "individual" to "person". Added "because of these extraordinary circumstances" when a party is requesting a specific court visitor.

GDN C 103 Order Appointing a Court Visitor	Added "If the Respondent opposes the professional selected by the court visitor, the court visitor shall obtain a professional evaluation from the professional selected by the respondent. The court visitor, after receiving a professional evaluation from the individual selected by the respondent, may obtain a supplemental evaluation from a different professional." To section 8 to better reflect the language in the statute. RCW 11.130.290 and.390

Changed section 3 Reporting Period Criteria to make it clearer. Clarified section 12 to make it more understandable. Removed explanation about ability to serve and made a simple sentence. Switched order re: appointing a successor guardian. Moved section 14 to the end of the report. Changed note above section 31 to only deal with filing of sealed cover sheet. Moved Other section to the end.

9.	GDN R 206 Order Approving Guardian/Conservator's s Report	Added appointment date to Summary. Added reporting period to the Summary. Changed section 6 to add option re: the reporting period stays the same or is changed. Changed The reporting date language in section 9 to better comply with RCW 11.1.30.345 and .530. Removed The court must review the report within 120 or 180 days from the due date of the next report. of the end of the reporting period. Changed section 10 to better illustrate that additional information may be needed if a co guardian or conservator is named.

		Added "a successor or co guardian or conservator has already been appointed" option.
10.	GDN R 207 Notice of Substantial Change in Circumstance	Added direction about filling out and return a Proof of Service.
11.	GDN ALL 001 Sealed Cover Sheet	Removed "[] Court Visitor/Guardian ad Litem Report from Sealed Cover Sheet" because lay guardians are filing reports under seal.
12.	GDN ALL 009 Proof of Service (Other than Personal Service.)	Added Notice of Right to Object to Plan.
13.	GDN M 501 Notice of Hearing about Terminating or Changing a Minor Guardianship or Non Parent Custody Order	Added Non-Parent Custody language to the <i>Notice of Hearing</i> .
14.	GDN M 409 Order Appointing a GAL or Visitor for a Child.	Added "(Example: Dependency and Juvenile Records – see RCW 13.50.100)" to section 10 to direct parties to who to contact when information needs to be released.
15.	GDN M 205 Immediate Minor Guardianship Order and Notice of Hearing	Changed the notice of hearing language (the only language covered by RCW 11.130.065) to 16-point font. Changed current code to ORAPEMG.
16.	GDN M 102 Minor Guardianship Petition	Added the CIF form to the list at the beginning. Also add "If needed" references to the immediate (204) OR regular (206) motion for emergency guardianship.
17.	GDN M 201 Notice of Hearing – Emergency Minor Guardianship Petition	Added the phrase "(short-term)" to the title of this form so it reads: Notice of Hearing about Emergency Minor Guardianship Petition (short-term)

18.	GDN M 202 Emergency Minor Guardianship Petition	Added the phrase "(short-term)" to the title of this form so it reads: Emergency Minor Guardianship Petition (short-term)
19.	GDN M 203 Order on Emergency Minor Guardianship	Added a "Use this form" instructional blurb at the beginning to clarify that this order can stem from an EMG Petition (202), motion for immediate EMG order (204) or a regular motion for EMG (206)
20.	GDN M 206 Motion for Emergency Minor Guardianship and Restraining Order	206 - Motion for Emergency Minor Guardianship and Restraining Order Issue: People are confused when to use this form and what order to use with it. Solution: Add to the instructions "To the person filing this motion" info about scheduling a hearing on this motion (separate from the hearing on the petition), and bringing a proposed EMG Order (203) and other needed orders to the hearing.

[] (Name/s) should be appointed as guardian of the children listed above.
