RE: Summary of Changes to Protection Order Forms (July 2022)

The table below outlines the changes to the Extreme Risk Protection Order forms based on Laws of 2021, ch. 215 (E2SHB 1320), Laws of 2022, ch. 268 (SHB 1901), and Laws of 2022, ch. 231 (5628).

Form Number & Title	Description of Changes
1. PO 001 Petition for Protection Order	This is a new form to be used by petitioners requesting a domestic violence, stalking, antiharassment, sexual assault, or vulnerable adult protection order.
2. PO 003 Law Enforcement and Confidential Information	This is a new form to be used in place of the Confidential Information form and the Law Enforcement Information form.
3. PO 004 Proof of Service	Changes: (1) Added "clerk's action" under 2, "Service by Mail" and added "Clerk's Action Required: 2" to the caption. (2) Expanded the electronic-service warning language to include "unless authorized by the court" and "a petition for a vulnerable adult protection order is filed by someone other than the vulnerable adult. After 2 unsuccessful attempts at personal service, you can ask the court to authorize electronic service. Court authorization is not necessary for vulnerable adult protection orders." (3) In 2, "Electronic Service," replaced "other reply" with "communication." (4) In 3, added "or there was no follow-up communication." (5) Updated the documents "to be served" list to include the new protection-order form set and removed the replaced forms. (6) Updated the footer with new statutory citation and publication date.

POi 004 Instructions for Proof of Service	Changes: <b>(1)</b> In "What are the different ways to serve the paperwork?", 2, added, "the petition for a vulnerable adult protection order is filed by someone other than the vulnerable adult." <b>(2)</b> In "What are the different ways to serve the paperwork?", subsection 2,

However, there were 2 unsuccessful attempts to personally serve the Respondent, and electronic service is not possible." (2) In second checkbox, replaced "the Petitioner requests service by mail and personal service is not required" with "personal service is not required and there have been 2 unsuccessful attempts at personal or electronic service." (3) In 1, added "[] Service to any known electronic addresses is also required to this electronic address/es (when electronic service was attempted but not verified)." (4) Updated the documents to be served list to include the new protection-order form set and removed the replaced forms. (5) In 3, replaced "each envelope must show the return address where petitioner can receive legal mail." (6) Removed "Note: Submitting a copy of the Proof of Service to Petitioner's local law enforcement agency will help ensure the data regarding your case is updated promptly." (7) Added line for judicial officer's printed name. (8) Updated the footer with new statutory citation and publication date.

PO 026 Order to Allow Electronic Service	Changes: (1) Added as last sentence, "Service to any known electronic address is also required to these electronic addresses (when electronic service was attempted and not verified):" (2) Added line for judicial officer's printed name. (3) Updated the footer with new statutory citation and publication date.
9. PO 027 Order to Allow Electronic Service	This is a new form to be used to authorize electronic service.
10. PO 028 Summons by Publication	This is a new form.
11. PO 029 Notice to Vulnerable Adult	This is a new form.

12. PO 030 Temporary Protection Order and Hearing Notice	This is a new form.
13. PO 032 Order Realigning Parties and Notice of Hearing	This is a new form.
