RE: New Proof of Service and Instructions

The Washington Pattern Forms Committee has updated the Return of Service forms, Proof of Mail forms, and Declaration of Mail form, combining them into one Proof of Service form to incorporate changes based on the Laws of 2021, ch. 215, §18 (E2SHB 1320). This form replaces WPF VA 4.020, WPF UH 04.0110, WPF DV 4.020, ST 4.0200, SA 4.020, WPF DV 9.040, WPF VA 9.040, and SA 9.040. This form was also updated to improve clarity and accuracy. The Pattern Forms Committee has also adopted the new Instructions for Proof of Service form. Both forms are effective July 25, 2021.

These protection order Return of Service forms, Proof of Mail forms, and Declaration of Mailing form will be removed from the Administrative Office of the Courts forms website by July 26, 2021: WPF VA 4.020, WPF UH 04.0110, WPF DV 4.020, ST 4.0200, SA 4.020, WPF DV 9.040, WPF VA 9.040, and SA 9.040.
