ORDER

NO. 25700-P - 1014

Justice Gerry L. Alexander's term as a Justice of the Washington State Supreme Court expires on December 31, 2011. A majority of the Court finds that it is necessary for the prompt and orderly administration of justice that Justice Alexander be appointed as a Justice Pro Tempore to complete pending cases and other judicial business.

Now, therefore, it is

ORDERED:

That the Honorable Gerry L. Alexander be appointed as Justice Pro Tempore to serve for a period of 60 days commencing January 1, 2012, pursuant to RCW 2.04.240(2), and receive compensation and benefits authorized by RCW 2.04.250(4). Thereafter, the additional appointment as Justice Pro Tempore shall be made as necessary, pursuant to RCW 2.04.240(1) to act on the cases on the attached list until their completion.
