

WASHINGTON STATE COURT INTERPRETER PROGRAM 2008 WRITTEN EXAM

The Administrative Office of the Courts (AOC) is offering the Written Exam for **Certified** and **Registered** court interpreter candidates on Saturday, **May 3, 2008**. The exam is only offered once a year in Western Washington at Bellevue Community College and in Eastern Washington at Yakima Valley Community College. The fee for the exam is \$50 for candidates in certified languages and \$30 for candidates in registered languages. You will receive a confirmation letter, directions to the testing location, and notice of the orientation upon registration.

REGISTRATION INFORMATION

You must register for the test (both locations) through Bellevue Community College/Continuing Education; you will need the item number to register.

You will receive additional information regarding the orientation when your registration is confirmed.*

Registration and payment must be completed with Bellevue Community College by March 31, 2008. Please make checks or money orders PAYABLE to BELLEVUE COMMUNITY COLLEGE. The exam fee is non-refundable.
