



WASHINGTON STATE COURT INTERPRETER PROGRAM ORAL CERTIFICATION EXAMINATION

The Administrative Office of the Courts (AOC) is offering the Oral Exam for court interpreter certification on **September 6 and 7, 2014**. The oral exam will be held at Bellevue College's North Campus. The fee for the Oral Exam is \$300 for Washington State residents and \$550 for out-of-state residents. Payment is due at the time of registration and is **non-refundable**. A completed application must be **postmarked by the deadline of Friday, August 8, 2014**. **No late applications will be accepted.**

The Oral Exam is only available to those who have passed the AOC Court Interpreter Written Exam and completed the AOC Court Interpreter Orientation in 2012, 2013 or 2014.

Please indicate your preference of date and time (morning or afternoon) on the registration form. The exam will take about one hour. After the registration deadline, you will receive exam information and an appointment for either September 6 or 7, 2014.

The oral exams used for Washington court certification are developed and maintained by the Consortium for Language Access in the Courts. Information about the Consortium is located on our website at www.courts.wa.gov/interpreters by clicking on the Consortium link on the left-hand side.

REGISTRATION

To register for the Oral Exam, you must submit all of the following, **postmarked** no later than **Friday, August 8, 2014**:

1. A completed registration form (pages 1 and 2);
2. A completed Court Interpreter Certification Oral Exam Survey (pages 1, 2 and 3 of the survey); and
3. Payment, either in the form of check/money order or credit card.

Court Interpreter Certification Oral Exam Survey — 2014
