He has held adjunct appointments at: The Union Institute, Clark College, Oregon Health Sciences University, and Portland State University. He is board certified by the American Board of Criminalistics, is a Fellow in the American Academy of Forensic Sciences, and is a Oregon Certified Medicolegal Death Investigator.
