Tribal Court Spotlight: Colville Tribal Court of Appeals

Located at 3 Joe Moses Road, in Nespelem, WA, the Colville Tribal Court of Appeals has been hearing cases formally since 1981. In 1990, the Confederated Tribes of the Colville Reservation voted to approve a separate branch of government consisting of the Tribal Court of Appeals (COA), with appellate jurisdiction over cases litigated in the Colville Tribal Court, the Tribal Court, and additional courts as the Business Council determines appropriate. The current bench was formally appointed in 1995 and has been serving continuously since then.

Combined, COA justices have over 150 years' experience at the Court. Currently, all COA justices are attorneys, though in the past, there have been 4 non-lawyer justices serving on the bench. The Court Administrator has been with the Court system since 1981, the court clerk since 1985, and both started at the Trial Court.

The COA has enacted Court of Appeals Rules and in 2019, the COA had 20 cases. The COA has also taken several cases to Gonzaga School of Law for oral argument hearings to expose the students to tribal law cases.

Court of Appeals decisions are published in VersusLaw and Westlaw/Thompson-Reuters, as well as its own Reporter system, available online at the Colville Tribes' website.

The COA facility includes one courtroom, a conference room, robing room and several offices. There is also a small limited library, open to the public, with Tribal Law and Order Code and Court of Appeals decisions from 1982 to present. People who need to research cases but don't have access to the online Reporter can use the library index card system.

TSCC Workgroup Progress

DV PO Enforcement

This workgroup kicked off on February 6th. The first meeting was to review plans for 2020, including a survey of protection order enforcement key issues and rollout of the 2018 AGO opinion on full faith and credit for tribal court protection orders. The first round of the survey will be for Tribal Justice Systems to help pinpoint where the biggest problems in the system are.

Spring Regional Meeting Planning

This workgroup has met 3 times since November and plans are underway for the May 15th Spring Regional Meeting. The meeting will be held in the morning at the Temple of Justice in Olympia and then convene in the afternoon at Nisqually Tribal Court. Invitations to Tribal Court Judges, statewide, and State Court Judges in the Thurston, Mason, Lewis and Pierce counties area will be sent out soon.

This workgroup has met several times and produced a TSCC information sheet for the national directory of tribal state court forums, approved the 2019 Annual Report, and has kick started the bi-monthly *TSCC Updates* with tribal court spotlights.
