Meeting Minutes

Welcome and Introductions

Judge Lori K. Smith and Judge Cindy Smith, Co-chairs of the Tribal State Court Consortium

- Thank you Judge Lorintha Umtuch for starting the meeting with a blessing.
- The Co-Chairs of the TSCC welcomed attendees and thanked them for attending.
- Attendees introduced themselves, the courts they represented, and provided information about their relationships with tribal courts and interest in the TSCC. In total, 34 people participated with 15 tribal courts judges attending.

Workgroup Updates

Justice Barbara Madsen, Judge Lori K Smith, Judge Cindy Smith

- Justice Madsen shared the amendment to Court Rule 82.5 passed and will be effective in late September when published in the next Washington Reports. A copy was distributed and is also available online in meeting materials. It will be important to report back at future meetings how the implementation is going.

Presentations: What can Courts do about MMIWG?

Annita Lucchesi, Executive Director, Sovereign Bodies Institute Sheldon Spotted Elk, Casey Family Programs, ICWA Program

- Annita Lucchesi shared with the group the work that Sovereign Bodies Institute is doing to build a comprehensive, indigenous led and informed database of missing and murdered indigenous women.
- In addition to data about the crime, SBI also tracks family connections, community response metrics and the justice system response.

- From the database, key statistics shared about Washington include that almost half of the cases where victim age is known are girls 18 and under and that 29% of cases are misclassified. SBI especially focuses on the fact that girls go missing multiple times.
- Especially impactful was when Ms., Lucchesi shared her own story as a survivor of domestic violence and sexual violence as well as trafficking.
- Sheldon Spotted Elk shared his work with courts in Washington and across the nation to stand up ICWA Courts. Native children are entering foster care at high rates and after years of decline the overall number of children entering foster care is rising.
- The Indian Child Welfare Act is the gold standard of foster care as it centers the child in relation to relatives and the community.
- ICWA Court model include five key components: judicial leadership, ICWA data collection, stakeholder collaboration, proximity/cultural humility, and ICWA training.
- While the group ran out of time to have a long discussion, people were encouraged to join the ICWA Courts workgroup to discuss issues this year.
