- 2.4 Mental Health Sentencing Alternative. The defendant is eligible for the mental health sentencing alternative. The defendant shall comply with any other conditions of community custody stated in this Judgment and Sentence or imposed by DOC under RCW 9.94A.704 during community custody. The court orders that during the period of supervision the defendant shall:
  - [] pay all court-ordered legal financial obligations.
  - [] obtain prior approval of the DOC for the defendant's residence location and living arrangements.
  - [] report as directed to a community corrections officer.
  - [] obtain a substance use disorder evaluation and comply with recommended treatment.
  - [] obtain a mental health evaluation and comply with recommended treatment.
  - [] meet with treatment providers.
  - [] follow recommendations in individualized treatment plan.

Other conditions:

- [] not possess or consume controlled substances, including marijuana, without valid prescription.
- [] not possess or consume alcohol.
- [] remain within prescribed geographical boundaries.
- [] obtain prior approval from DOC of residence location and living arrangements.
- [] take all prescribed medications.
- [] comply with monitoring of all prescribed medications.

The conditions of community custody shall begin immediately, unless otherwise set forth here:\_\_\_\_\_

## V. Notices and Signatures

- **5.1 Collateral Attack on Judgment.** If you wish to petition or move for collateral attack on this Judgment and Sentence, including but not limited to any personal restraint petition, state habeas corpus petition, motion to vacate judgment, motion to withdraw guilty plea, motion for new trial, or motion to arrest judgment, you must do so within 1 year of the final judgment in this matter, except as provided for in RCW 10.73.100. RCW 10.73.090.
- **5.2 Length of Supervision.** If you committed your offense prior to July 1, 2000, you shall remain under the court's jurisdiction and the supervision of the Department of Corrections for a period up to 10 years from the date of sentence or release from confinement, whichever is longer, to assure payment of all legal financial obligations, unless the court extends the criminal judgment an additional 10 years. If you committed your offense on or after July 1, 2000, the court shall retain jurisdiction over you for the purpose of your compliance with payment of the legal financial obligations for 10 years from your date of sentence or release from confinement, whichever is longer, and for restitution until you have completely satisfied your obligation, regardless of the statutory maximum for the crime. RCW 9.94A.760 and RCW 9.94A.505(5). The clerk of the court has authority to collect unpaid legal financial obligations at any time while you remain under the jurisdiction of the court for purposes of your legal financial obligations. RCW 9.94A.760(4) and RCW 9.94A.753(4).
- **5.3** Notice of Income-Withholding Action. If the court has not ordered an immediate notice of payroll deduction in Section **4.1**, you are notified that the DOC or the clerk of the court may issue a notice of payroll deduction without notice to you if you are more than 30 days past due in monthly payments in an amount equal to or greater than the amount payable for 1 month. RCW 9.94A.7602. Other income-withholding action under RCW 9.94A.760 may be taken without further notice. RCW 9.94A.7606.

### 5.4 Community Custody Violation.

- (a) If you are subject to a violation hearing and DOC finds that you committed the violation, you may receive a sanction of up to 30 days of confinement. RCW 9.94A.633(1).
- (b) If you have not completed your maximum term of total confinement and you are subject to a violation hearing and DOC finds that you committed the violation, DOC may return you to a state correctional facility to serve up to the remaining portion of your sentence. RCW 9.94A.633(2)(a).
- 5.5a Firearms. You may not own, use, or possess any firearm and, under federal law, any firearm or ammunition, unless your right to do so is restored by the court in which you are convicted or the superior court in Washington State where you live, and by a federal court, if required. You must immediately surrender any concealed pistol license(s). (The clerk of the court shall forward a copy of the defendant's driver's license, identicard, or comparable information to the Department of Licensing (DOL) and the Washington State Patrol Firearms Background Check Program along with the date of conviction or commitment.) RCW 9.41.040 and RCW 9.41.047.
- **5.5b [] Felony Firearm Offender Registration.** The defendant is required to register as a felony firearm offender. The specific registration requirements are in the *"Felony Firearm Offender Registration"* attachment.
