- RE: May 2016 Summary of Changes to Family Law Forms

The Access to Justice Board's Pro Se Project has converted the mandatory domestic relations pattern forms into plain language. These new plain language family law forms **may** be filed starting May 1, 2016, and **must** be filed starting July 1, 2016.

The new family law forms were originally posted on the courts' website on January 29, 2016. A few of the forms were modified later. The table below contains detailed descriptions of the changes that were made through May 2, 2016:
