SUBJECT: JUNE 2020 SUMMARY OF CHANGES TO ANTIHARASSMENT FORMS

The Washington Pattern Forms Committee updated the Antiharassment forms. The changes are based upon:

- Title changes to the Order to Surrender and Prohibit Weapons forms;
- Feedback received from the judicial community; and
- Administrative edits.
