SUBJECT: 2014 Summary of Changes to Stalking Protection Order Forms

The Washington Pattern Forms Committee updated the Stalking Protection Order forms to implement:

- Laws of 2014, Ch. 111, Relating to Surrender of Weapons
- Recommended changes from the legal community

Detailed descriptions of the changes follow:

1.	UHST 2.025	Worksheet for the Harassment and/or Stalking Petition  This form was substantially revised. Please discard the previous version and replace it with the June 2014 version.
2.	UHST 2.020	Petition for an Order for Protection – Harassment and/or Stalking  This form was substantially revised. Please discard the previous version and replace it with the June 2014 version.
3.	UHST 5.010	Petition for an Order for Protection – Respondent Under Age 18 – Harassment and/or Stalking  This form was substantially revised. Please discard the previous version and replace it with the June 2014 version.
4.	ST 3.020	Temporary Protection Order and Notice of Hearing – Stalking  On page one, immediately above the check box for “Petitioner is 16 years of age or older,” insert:  The protected person/s is/are the:

To the right of the check box, insert “<b>Surveillance:</b>” change respondent to lower case “r”, change “victim/s” to “protected person/s,” and delete “<input type="checkbox"/> and from keeping under surveillance, including electronic surveillance the following children who are not victims of stalking: _____”</p> <p>Third restraint: delete “3)” to the left of the check box. To the right of the check box, insert “<b>Exclude from places:</b>” change respondent to lower case “r”, change “victim/s” to “protected person/s,” and delete “<input type="checkbox"/> the workplace, school or day care of the following children who are not victims of stalking: _____.”</p> <p>Fourth restraint: delete “4)” to the left of the check box. 9.	ST 8.020	Order Transferring Case and Setting Hearing – Stalking  This is a new form.
