**RE:** Summary of Changes for Protection Order Forms (June 2024)

The table below outlines changes to the Protection Order forms based on chapter 7.105 RCW and comments. Additional changes were made to improve clarity and accuracy of the forms.

1.	<b>PO 054 Order Setting Hearing on Renewal and Extending Order</b>	Changes: <b>(1)</b> In caption, delete “7” from clerk’s action required. <b>(2)</b> In 2, remove hearing-setting language based on comment requesting removal of duplicate language. <b>(3)</b> In 4, delete “The parties shall appear on <i>(date)</i> _____ at _____ a.m./p.m.” based on comment requesting removal of duplicate hearing-setting language. <b>(4)</b> In footer, update publication date.
2.	<b>PO 066 Order Modifying or Terminating Protection Order</b>	Changes: <b>(1)</b> In caption, add “8” to clerk’s action required. <b>(2)</b> In 4, remove expiration dates and reword to have the expiration date listed once to improve readability. <b>(3)</b> In 4, add “[ ] Temporary Modification This is a temporary modification. It will be effective until the next hearing date on <i>(date)</i> ____ at <i>(time)</i> ____, at <i>(location)</i> _____. <i>(To modify the temporary protection order until the full hearing, use form PO 030, Temporary Protection Order and Hearing Notice.)</i> ” based on comment. <b>(4)</b> In footer, update publication date.
3.	<b>PO 030 Temporary Protection Order and Hearing Notice</b>	Changes: <b>(1)</b> In 8.S., replace “Appendix A School Attendance” with “PO 040B Attachment B School Transfer” based on comment that the old form referenced no longer exists and to be consistent with the language in PO 040. <b>(2)</b> In footer, update publication date.
4.	<b>PO 004 Proof of Service</b>	Changes: <b>(1)</b> In 2.B., delete “Court authorization is not necessary for vulnerable adult protection orders” based on comment that it isn’t a complete list of when it is not necessary. <b>(2)</b> In 2.C., change “order” to “ <i>Proof of Service</i> ” to address comment that the language is confusing. <b>(3)</b> In footer, update publication date.
5.	<b>PO 040</b>	Changes: <b>(1)</b> In 3, correct “interested person” citation to “RCW
