AOC provides a wide spectrum of **ADMINISTRATIVE**, **TECHNOLOGICAL**, **FINANCIAL**, **PROGRAM** and **RESEARCH SERVICES**. Established in 1957 by state lawmakers, AOC serves the judicial branch in carrying out its constitutional mission to provide equal justice under the law.

STATE COURT ADMINISTRATOR, Dawn Marie Rubio

The Washington State Court Administrator is appointed by the Supreme Court to act as a liaison between the judicial, executive, and legislative branches, justice partners and other state agencies. The Court Administrator oversees operations for more than 278 employees in four divisions of service within AOC:

- ➤ Administrative Services Division
- Judicial Services Division
- ➤ Information Services Division
- Management Services Division

ADMINISTRATIVE SERVICES DIVISION, Dawn Marie Rubio

Under the direction of the State Court Administrator, the ASD provides dependable leadership, effective planning, and exceptional service to the courts to:

- Coordinate staffing and representation on more than 100 workgroups, committees, commissions, boards and task forces working on justice issues.
- ➤ Tracked 210 bills and amendments and reviewed just under 1,177 bills during the 2021 legislative session.
- Serve as the central communications office for Washington's judicial branch of government, including media relations and community outreach.
- Monitor training, provide testing and certification, and standardize best practices for 327 certified or registered court interpreters in 45 languages.
- Serve as direct staff support to the Board for Judicial Administration (BJA).
- ➤ Provide regular performance reports for court managers and other stakeholders. Also conduct in-depth research into critical justice issues such as dependency, truancy, bias, and the effectiveness of court-based interventions.









AOC MISSION

Advancing the efficient and effective operation of the Washington Judicial System.

JUDICIAL SERVICES DIVISION, Scott Ahlf, Director

Provides comprehensive support to the state's judges, clerks, court administrators and their staff to:

- Provide legal services to trial and appellate courts such as benchbook development and coordination, jury instruction coordination and staffing, legal analysis of legislation involving courts, legal and administrative coordination of court rules and much more.
- Serve as direct staff support to the Superior Court Judges' Association (SCJA), the District and Municipal Court Judges' Association (DMCJA), and appellate court judges and staff.
- ➤ Maintain more than 1,000 court forms, with an average of 141 legislative changes each year.
- ➤ Respond to 20,000 to 30,000 Help Desk calls and online requests from courts each month.
- Develop and coordinate nearly 7,500 education program hours for judges, county clerks, commissioners, court staff and others in 2020-21.
- ➤ Processed an average of 55,394 Appellate court e-filings since 2019 for all divisions and Supreme Court.
- ➤ Recorded 114,491,000 visitors for all public case search and public-facing Web sites since 2019. Published 18 new online training modules since 2020.

INFORMATION SERVICES DIVISION, Vonnie Diseth, CIO

Supports the technology needs of the judicial branch through the Judicial Information System (JIS) by:

- ➤ Providing nine major applications which make up the Judicial Information System (JIS) that facilitates 20 million judicial transactions by more than 27,000 court, state, federal and public users each month.
- Managing data for more than 30 million cases, 61.3 million person records with case histories for more than 10.1 million well identified persons.
- ➤ Supporting 25 major data exchanges with nine different state and federal justice partners.
- Conducting semi-annual disaster recovery tests to ensure that JIS records and systems are protected in the event of a disaster so that the courts can continue to function.
- Providing statistical reports and analysis through the data warehouse to facilitate legislation and judicial needs.

MANAGEMENT SERVICES DIVISION, Chris Stanley, Director

Judicial branch budget planning, revenue monitoring, accounting, procurement and contract management, public records and court case data access management, facility operations, building security, and document printing and scanning are all functions of the Management Services Division. Services include:

- Management and distribution of nearly \$112 million in state funding to trial courts for judicial salaries; programs supporting children in court proceedings and at-risk youth; interpreter reimbursement; and juvenile and family court services.
- Production of judicial impact fiscal notes for legislative proposals. More than 200 fiscal notes were produced in 2021.
- ➤ Management of financial activities and forecasts for the AOC, the Supreme Court, the Court of Appeals, and the Office of Civil Legal Aid, with combined annual expenditures exceeding \$150 million.
- Development of biennial and supplemental budget requests for the judicial branch, with a total combined biennial budget of \$462 million.
- ➤ Production of more than 1.1 million pages of legal briefs and over 480,000 pages of educational materials and over 250,000 scanned documents through the AOC Copy Center.
- ➤ Coordination of public disclosure and emergency management activities for the AOC and other judicial branch agencies.
- ➤ Education of approximately 26,700 lay guardians to date, as well as certification and annual re-certification of the more than 300 professional guardians serving about 6,400 incapacitated persons each year.
