You may obtain your application packet from Superior Court Administration, 930 Tacoma Avenue South, Room 534, Tacoma, or on their website at www.co.pierce.wa.us/superior. All new applicants and current registry members for the RCW 26.09 Guardian ad Litem/Parenting Investigator Registry must complete an application packet with written documentation and submit by the closing to the Superior Court Administrator. The application period closes on **Friday, March 24, 2006** at **4:30 p.m.**
