#### Note

In the State of Washington, all judges are required by law to be non-partisan regardless of the party of the appointing authority. When appointed, they must stand for election at the next general election. Although initially appointed, all judges will have been subsequently elected for specified terms (normally four years except for appellate court which is six years).

State court judges (Superior Court and Court of Appeals) are appointed by the incumbent governor. County district court judges are appointed by the county commissioners. Municipal court judges are appointed by mayors and city councils.
