I, JOHN STANLEY, have received and reviewed the opening brief prepared by my attorney. Summarized below are the additional grounds for review that are not addressed in that brief. I understand the Court will review this Statement of Additional Grounds for Review when my appeal is considered on the merits.

Additional Ground 1

I would like to bring up the fact that an officer (STEPHANIE MCKINNEY-SPD) stated that she read me my MIRANDA RIGHTS AT THE SCENE, BUT SHE GOT ON THE WITNESS STAND AND SAID "THAT SHE NEVER HAD ANY CONTACT WITH ME." THAT WAS STATED IN THE 3.5 HEARINGS.

Additional Ground 2

THERE WAS A WITNESS THAT WAS SUPPOSE TO BE CALLED ON MY BEHALF (JOHN COLLINS). IT IS STATED THAT IN THE TRANSCRIPTS, BUT FOR SOME REASON HE WAS NEVER CALLED TO PROVE MY

INNOCENCE FOR THIS RUDDERY CHARGE. BOTH SIDES KNEW ABOUT MY WITNESS AND ALSO HAD A CONTACT NUMBER FOR HIM. BUT ~~NEITHER~~ NEITHER OF THEM ATTEMPTED TO SUBPOENA HIM.

#### Additional Ground 3

THERE WAS ALSO A CHARGE THAT HAPPENED IN THE COUNTY JAIL (ATT. BATTERY) IN WHICH 2 PEOPLE WAS SUBPOENED TO COME TO COURT. I HAVE A RIGHT TO FACE MY ACCUSER, BUT THE 2 NEVER SHOWED UP. ONE WAS MR. ANTHONY TERRY AND THE OTHER PERSON WAS MR. EARL BARRINGTON. I FEEL MY RIGHTS WAS VIOLATED.

#### Additional Ground 4

IN THE VICTIM'S TESTIMONY HE SAID SOMETHING LIKE "I BELIEVE" AND I FEEL THAT HIS STATEMENT OF "I BELIEVE" SHOULDN'T HAVE STOOD IN COURT. IT EITHER SHOULD HAVE BEEN IT WAS HIM OR IT WASNT. THE VICTIM ALSO GOT ON THE STAND AND LIED. HE NEVER TOLD THE COURT THAT HE GAVE 2 DIFFERENT DESCRIPTIONS OF THE ALLEGED PERPETRATOR.
