I received your letter. I am sorry, but I can't read English or speak it. I would like to ask you, please, if you can wait for me, because I am trying to come to court. That is why I am looking for someone who can help me fill out the papers, so I can come to court. But I am distrustful about my papers, and that is why I am looking for someone who is honest who can help me to be able to come to court with you. Mr. David C. Ponzoha, I am mistrustful because of what has been done to me. I am mistrustful because I am locked up here through no fault of my own. I am accused in this case, but it is only suppositions of the court, and that is why I am locked up through no fault of my own. I am going to tell you a little bit about this case, why they have me locked up here through no fault of my own. Sir, to begin with, I don't know those people who accused me. Sir, David, here is the thing: two people came from California to accuse me. One said twice that he didn't know me, and then he said that I hit him. I don't know those people, those two people who came from California to accuse me. I don't know who they are. I heard the prosecutor tell the judge that he was negotiating with those two people so that they would say I hit them. And they paid [? My attorney showed me all those papers in the county where I was held on this accusation. I was arrested, and that is why they made me guilty of something that I didn't do, and since they couldn't find anyone else to accuse, that's why they accused me. And my lawyer told me that they put me in the county because of my past record; that is why they made me guilty. What they did to me was unfair, Sir, David Ponzoha, and they also used my record from California and took me to court again to make it into a "strike" [?
