



The Court accepted this Plea, and set a date for Sentencing. At Sentencing the Court informed me that the Court does not have to accept my DOSA, with this said, this makes my Plea involuntary, because I only pled to DOSA and in the alternative to 75 Month Prison Sentence.

Mr. Baum failed to announce any objection to this change.

I have been misinformed of the consequences to this Plea Agreement.

Mr. Baum provide Ineffective Assistance of Counsel.

#### ADDITIONAL GROUND 2

Ineffective Assistance of Counsel (Failed to provide effective Representation when Counsel failed to move to Reduce Bail).

Mr. Christopher A. Baum, WSBA#32279, failed to Object, Submit or defend me effectively when he failed to Object to the States Bail amount, and failed to submit and file a Motion to Reduce the Bail.

This is ineffective assistance of counsel because it does not show or demonstrate adequate representation an appropriate defense strategy. Instead he informed me after I requested a reduction that their is absolutely no way the judge will reduce my bail.

Infact, since their was no reduction motion before the court, the court instead increased the bail six times.

#### ADDITIONAL GROUND 3

Ineffective Assistance of Counsel (Defense Counsel was incompetent and unwilling (Uncooperative) to provide adequate and the effective representation. (Conflict of Interest-Unruly ethics and unprofessionalism).

Mr. Christopher A. Baum, WSBA#32279, was constantly stubbornly defiant when I tried to advise him or suggest some strategies or to be explained to when I asked him what constitutes the element's the State must prove in my Information.

Instead, he became on numerous occasions argumentative, and disrespectful as if he honestly did not care. This behavior clearly constitutes unprofessionalism and in violation of the Washington State Superior Court Rules of the Professional Conduct.

I believe this relationship constituted a conflict of interest and prejudiced me.

#### ADDITIONAL GROUND 4

Ineffective Assistance of Counsel (Failed to move to Suppress Evidence).

During the preliminary stages of my criminal proceedings my attorney Mr. Christopher A. Baum, WSBA#32279, failed to Object and or move the Court with any motion to suppress any evidence used against me regardless.

I was entitled to the Effective Assistance of Counsel to be defended.

Some of the evidence should have been challenged. The witness's statement's and the Search of my Vehicle may have been unwarranted along with the Confidential Informant's statement's.

My attorney completely lacked any true skills to provide me adequate and appropriate representation to conduct and provide a sound defense of my case.

Therefore, because I was denied my Sixth Amendment Right of the United States Federal Constitution and of the Washington States Constitution of the Right to Privacy when the State unwarrantly searched my vehicle, I have been denied effective assistance of Counsel.

My case should be vacated and I should be given the right to effective assistance of copunsel. A right to a fair trial.

#### ADDITIONAL GROUND 5

Ineffective Assistance of Counsel (Counsel failed to provide adequate Representation at sentencing).

At my Sentencing hearing my defense counsel failed to defend me adequately, Instead, without any plausible reason he agreed entirely with the prosecutor during my sentencing hearing.

My defense Counsel Mr. Christopher A. Baum, WSBA#32279, did not object to nor conferred with me or attempt to challenge anything that the prosecutor presented regardless of what the original Plea agreement was falsely made out to say.

Instead, my defense Counsel allowed the prosecutor and the judge to sentence me, contrary to any previous agreements (Plea), or defenses presented. Instead he allowed me to be sentenced to more time than what I was informed of, without any logical objection put forth.
