




Comes now Washington State Association for Justice Foundation and, pursuant to RAP 10.8, submits the following additional authority for the Court's consideration: AT&T Mobility LLC v. Concepcion, \_\_\_ U.S. \_\_\_, 2011 WL 1561956 (April 27, 2011) (holding state public policy-based rule of general application invalidating arbitration clause is preempted by Federal Arbitration Act, 9 U.S.C. §§1 et seq., because it stands as an obstacle to accomplishing objectives of the act).
