

The petitioner Nancy Becker identifies the following additional authority: *Estate of Etsuko Toland v. Toland*, 2012 Wash. App. LEXIS 2300, 2012 WL 4373331 (Wn. App. Div. II, No. 41388-4-II, decided September 25, 2012) (holding that a decedent's divorced husband, who is the father of the decedent's only child [the child being the decedent's only heir], has standing under TEDRA to participate in the probate of his former wife's estate because he is "the father of the sole minor heir to the Estate . . . ," and is for that reason an "interested party" under TEDRA). The additional authority is pertinent to the issues presented for review as described in Section III.1 of the Petition of Nancy Becker for Discretionary Review to the Supreme Court.


