Dear Clerk Carpenter:

Yesterday I presented the oral argument on behalf of Petitioner Cashmere Valley Bank. During the course of my rebuttal, I stated that I would provide the Court with record citations pertaining to Cashmere's awareness of the default status of loans generating the payment streams in which Cashmere had invested.

The record pertaining to the reports Cashmere received are to be found at CP 128 through 185; several of these Clerk's Papers are referenced in Cashmere's Supplemental Brief, at page 11, n 6. These Clerk Papers consist of copies of reports pertaining to a representative REMIC in which Cashmere invested, and were attached as exhibits to the Declaration of Alan Crain, Cashmere's Chief Financial Officer during the audit period (CP 123-127). The reports do not set forth information regarding individual loans; the fact of a default on any loan would instead have been reflected in an ensuing failure of investment payments to be in accordance with certificate representations.
