## I. IDENTITY OF PETITIONER

Robert Wheeler, Petitioner, challenges his Pierce County convictions for Rape of a Child and Child Molestation. Mr. Wheeler, (DOC #893003) is currently incarcerated at the Monroe Correctional Complex in Monroe, Washington.

Mr. Wheeler filed a previous PRP which was granted in part and remanded for correction of a sentencing error. The issue raised in this petition was not raised in that petition. After an order correcting the judgment was entered, Mr. Wheeler appealed. After briefing on the issue of the appealability of the order correcting the sentence error, this Court determined that Mr. Wheeler had a right to an appeal. His appeal (No. 44141-1-II) is currently pending with this court.

## III. FACTS

Robert Wheeler was born on March 29, 1987. Between December 6, 2000, and December 5, 2001, when Robert Wheeler was between 13 and 14 years old, he committed the crimes of Rape of a Child and Child Molestation. Those crimes were reported on November 1, 2004. On January 3, 2005, the victims were formally interviewed. On January 23, 2005, Mr. Wheeler confessed. At the time of Mr. Wheeler's confession, more than 2 months remained before he turned 18.

According to documents obtained in a public disclosure request and not previously revealed to Wheeler, on March 7, 2005, the State drafted an information charging the aforementioned offenses in juvenile court. However, the charges were not filed at that time.

On March 26, 2005, three days before Wheeler's 18<sup>th</sup> birthday, the State prepared an information and probable cause statement (which contained less information than the probable cause statement prepared for the unfiled juvenile court charge). Once again, the charges were not filed at that time. Instead, the State waited until May 4, 2005, when it simply crossed out the earlier date and hand-wrote in the new date.

According to notes received from the prosecutor's office, there was no investigation taking place that would have justified the delay from March 7 to May 4, 2005.

As a result of the State's delay, juvenile court jurisdiction lapsed.

#### IV. ARGUMENT

##### A. Introduction

This case presents a striking violation of the due process protection against intentional or negligent delays which result in the loss of juvenile court jurisdiction. This Court should review whether the State intentionally or negligently delayed filing resulting in the loss of juvenile court

jurisdiction. This claim is based on newly discovered evidence of the State's delay—the product of a public disclosure request.

B. The State Either Intentionally or Negligently Delayed Filing Charges Resulting in the Prejudicial Loss of Juvenile Court Jurisdiction.

Both the law and the facts on this claim are clear.

The State delayed filing charges from March to May, 2005, not in order to conduct additional investigation and not even because of the press of other business, but simply so that juvenile court jurisdiction could lapse. The State was aware of Wheeler's date of birth. The investigation was largely, if not entirely complete in January 2005. Charges were actually drafted, along with a probable cause statement in early March. In fact, a case number was assigned.

There is only one apparent reason for delay—to prosecute Mr. Wheeler for a crime committed when he was 13 to 14 (and was 17 when the crime as fully investigated) as an adult.

The law is equally clear. Due process plays a limited role in protecting defendants against oppressive delay. *United States v. Lovasco*, 431 U.S. 783, 789, 97 S.Ct. 2044, 52 L.Ed.2d 752 (1977). Where a defendant commits a crime before he is 18 but is not charged until after he is 18, there is a violation of due process if the delay was intentional or negligent. *State v. Dixon*, 114 Wash.2d 857, 858–59, 792 P.2d 137

(1990) (holding that where a defendant committed the crime at age 16 but was not charged until he was 18, due process was not violated because prosecutorial delay was justified); *State v. Calderon*, 102 Wash.2d 348, 349, 684 P.2d 1293 (1984).

To decide if there is prosecutorial delay, a court must apply a three-prong test. First, the defendant must show the charging delay caused prejudice. If the defendant shows prejudice, the court then examines the State's reasons for the delay. Finally, the court balances the delay against the defendant's prejudice to decide if the delay violates the "fundamental conceptions of justice." If the delay is intentional, due process is violated, but if the delay only is negligent, due process may or may not be violated. *Lovasco*, 431 U.S. at 790; *Calderon*, 102 Wash.2d at 352–53; *Dixon*, 114 Wash.2d at 860.

Petitioners fulfill their burden of proof when prosecutorial delay causes a loss of juvenile court jurisdiction because the loss results in a decrease of benefits available to a defendant. *Dixon*, 114 Wash.2d at 860–61 (stating that two benefits lost to the defendant are the avoidance of the stigma attached to an adult conviction and the possibility for less harsh penalties); *Calderon*, 102 Wash.2d at 352–53 (stating that loss of juvenile court jurisdiction results in the loss of juvenile adjudication or the opportunity to argue against a decline from juvenile court jurisdiction); *State v. Alvin*, 109 Wash.2d 602, 604, 746 P.2d 807 (1987).

The delay in this case can only be described as intentional. The charges were ready to be filed before Wheeler turned 18. In fact, charging documents were prepared for both juvenile and adult court before Wheeler turned 18—after the pre-filing investigation was complete. The only possible reason for the delay was so that juvenile court jurisdiction could lapse and Wheeler be prosecuted in adult court.

This Court should either remand for an evidentiary hearing or grant this claim and remand for dismissal.

#### IV. CONCLUSION

Based on the above, this Court should either grant Wheeler's PRP of remand for an evidentiary hearing.



That I am a deputy prosecuting attorney for Pierce County and I am familiar with the police report and/or investigation conducted by the PIERCE COUNTY SHERIFF, incident number 043070671;

That the police report and/or investigation provided me the following information;

That in Pierce County, Washington, on or about the period between the 6<sup>th</sup> day of December 2000 and the 5<sup>th</sup> day of December 2001, the defendant, ROBERT T WHEELER, did commit the crimes of **Rape of a Child in the First Degree and Child Molestation in the First Degree.**


On November 1, 2004, Pierce County Sheriff's Deputy Larsen contacted a parent who reported that her twin daughters had disclosed that they had been sexually molested by the defendant, Robert T. Wheeler. The parents identified the girls as K.A.B. born 12-06-94 and R.L.B. born 12-06-94. The parent said the defendant is her stepson and is stepbrother to the twins. The parent said this happened when the twins were between 6 and 7 years old; the parent said she and her husband confronted the defendant and he admitted and apologized.

On January 3, 2005, the twins were interviewed by a forensic child interviewer. R.L.B. disclosed that she saw the defendant touch her sister on the front private area with his hand and that the defendant had done the same thing to her. K.A.B. disclosed that the defendant had touched her vaginal area with his hand.

On January 25, 2005, Deputy Nicholson contacted the defendant. The defendant told her that about 3-4 years earlier, he had touched R.L.B. and K.A.B.; he said he put his hand down their panties and rubbed their vaginal areas; he stated that he placed his finger inside R.L.B.'s vagina.

I have completed my review of the search for the requested records. We believe your public disclosure request received March 2, 2013 asked for the following records from the files of the Pierce County Prosecuting Attorney's Office:

Any documents relating to the filing of charges in this case, included but not limited to the receipt of the case for filing, the length of time from receipt to filing, information regarding the defendant's juvenile status at the time of the crime, and other information relevant to the delay between receipt of the case and filing.

We do not know what records you believe are "relevant to the delay between receipt of the case and filing." We have therefore interpreted your request to ask for any record relating to charging that existed prior to the filing date of 05/04/05.

Seventy-one (71) pages were located that are responsive to your request. Of those pages, 19 pages will be released to you. Please see the attached exemption log for additional information regarding these pages.

You have indicated that you would like to view these records. Please contact me at 253-798-4149 to set up a mutually agreeable time for you to come to this office to view these records. Please bring your own supplies. If at that point you select documents to be copied, copies will be made for you at a later time. 



7 That in Pierce County, Washington, on or about time period between the 1st day of November,  
8 2001, and the 1<sup>st</sup> day of November 2002, the respondent, ROBERT T WHEELER, did commit the crime  
9 of Rape of a Child First Degree against R.B. (DOB 12/6/94) who is more than 24 months younger and not  
10 married to the respondent, and did commit the crime of Rape of a Child First Degree against R.B. (DOB  
11 1/6/94), who is more than 24 months younger and not married to the respondent, and Child Molestation  
12 First Degree against K.B. (DOB 12/6/94), who is more than 36 months younger and not married to the


14 Victims R.B. and K.B. are twin sisters and are stepsisters of the respondent, ROBERT

17 around 2001. The respondent was then confronted by Mrs. Wheeler and her husband. The respondent  
18 admitted that there had been two incidents where he had touched the vaginas of both victims (R.B. and  
19 K.B.).

20 On 1/3/05, R.B. and K.B. were interviewed at the Mary Bridge Child Abuse Intervention  
21 Department by Child Forensic Interviewer Kim Brune. R.B. reported that that she observed the  
22 respondent touch her sister, K.B. in her front private with his hand and that the respondent had done the  
23 same thing to her. K.B. disclosed that the respondent had touched her potty with his hand.

24 On 1/25//05, the respondent was contacted by Pierce County Sheriff Deputy Joanna Nicholson  
and advised of his constitutional rights. The respondent stated that approximately 3-4 years prior he had  
inappropriately touched R.B. and K.B. He stated he placed his hand down K.B.'s pants and panties and  
rubbed his hand on her vagina. He stated he then placed his hand down R.B. pants and panties and  
rubbed her vagina with his hand and placed his finger into her vagina.


