nonclaim statute. (18c) **1. STATUTE OF LIMITATIONS. 2.** A law that sets a time limit for creditors to bring claims against a decedent's estate. •Unlike a statute of limitations, a nonclaim statute is usually not subject to tolling and is not waivable. – Also termed (in sense 2) *statute of repose*.

Black's Law Dictionary 1213 (10th ed. 2014):

nonclaim. (15c) A person's failure to pursue a right within the legal time limit, resulting in that person's being barred from asserting the right. See STATUTE OF LIMITATIONS.
