

2017 Wash. Legis. Serv. Ch. 126 (S.B. 5813) (approved April 25, 2017) (effective July 23, 2017) (Amendment to RCW 9.68A.050 and 9.68A.060 proposed and approved after the Court of Appeals' decision in *State v. E.G.*, amending second degree dealing in depictions of a minor engaged in sexually explicit conduct and second degree sending or bringing into the state depictions of a minor engaged in sexually explicit conduct from class C felonies to class B felonies. The amendment does not change any of the substantive language of either statute.)
