AUTHORITIES


The Employment Security Department submits the following additional authorities to the Court pursuant to RAP 10.8:

- Former RCW 34.04.130 (1967 to 1988) (Administrative Procedure Act section providing procedures for petitions for judicial review that exclusively applied “even though another procedure is provided elsewhere by a special statute or a statute of general application.”).
- Former RCW 50.32.120 (1973 to 1988) (“Judicial review of a decision of the commissioner involving the review of an appeals tribunal decision may be had only in accordance with the procedural requirements of RCW 34.04.130.”).
- Laws of 1988, ch. 288 § 706 (final section of the 1988 revisions of the Administrative Procedure Act directing the Code Reviser to update statutory references from former RCW 34.04. to RCW 34.05 in light of the amendments to the APA).

- RCW 50.32.120 References revised. (1988 Supp.) (Reviser’s note changing the statutory cross reference in RCW 50.32.120 from RCW 34.04.130 to RCW 34.05.570) (located at page 389).
- *Compare with* Laws of 1989, ch. 175 (cross reference corrections *adopted by the legislature* most frequently change “RCW 34.04.130” to “RCW 34.05.510 through RCW 34.05.598” or to “chapter 34.05”).
- RCW 1.08.015(2) and (2)(i) (Code reviser may “[c]orrect manifest errors in references, by chapter or section number, to other laws,” but only “without changing the meaning of such law.”).
- RCW 34.05.001 (“The legislature intends that to the greatest extent possible and unless this chapter clearly requires otherwise, current agency practices and court decisions interpreting the Administrative Procedure Act in effect before July 1, 1989, shall remain in effect.”).
