

COMES NOW Erik Petterson, by and through his attorney,  
Thomas E. Weaver, and provides the following additional authority:  
State v. Bigsby, \_\_ Wn.2d \_\_ (decided August 10, 2017) (“Three statutes,  
RCW 9.94A 660(6)-(7), 670(10)-(12), and 655(5)-(7), explain that when  
an offender is sentenced to community custody under special sentencing  
alternatives for certain drug or sex crimes, or because the offender is a  
parent, the court has concurrent supervisory authority with the Department  
over these offenders. Outside of these narrow categories, RCW  
9.94A 6333(1) explains that the court is authorized to ‘modify its order of  
judgment and sentence and impose further punishment’ when an offender  
violates a sentence condition or requirement, but only if the offender ‘is  
not being supervised by the department.’”)
