
STATEMENT OF

State*, 172 Wn.2d 296, 310-11, 268 P.3d 892 (2011) (Court directs that canon about unlikely or absurd results be applied “sparingly” because it refuses to give effect to language Legislature actually used and adds language by courts to statute; separation of powers concerns are implicated);
- *In Matter of Dependency of D.L.B.*, 186 Wn.2d 103, 119, 376 P.3d 1099 (2016) (“We may not invoke that canon just because we question the wisdom of the legislature’s policy choice.”).


