## A. INTRODUCTION

The State pursued a crime it could not prove. It charged Jennifer Dreewes with assaulting Marty Brewer-Slater and accepted a to convict instruction requiring it to prove Dreewes assaulted Brewer-Slater.

Dreewes was not the principal; she never came in contact with Brewer-Slater. Dreewes also could not be an accomplice to the crime, because she did not have actual knowledge of the assault of Brewer-Slater. The Court of Appeals properly dismissed the charge for insufficient evidence.

## B. ISSUES FOR WHICH REVIEW WAS GRANTED

1. Accomplice liability attaches if a person has actual knowledge of the crime at issue. The crime here was assault of Marty Brewer-Slater with a deadly weapon. By not objecting to the to convict instruction, the State agreed to prove Dreewes assaulted Brewer-Slater with a deadly weapon. Did the State fail to establish Dreewes acted as an accomplice to the assault of Brewer-Slater where Dreewes lacked actual knowledge?

2. Under GR 15(c), GR 31, and in the interest of respecting the privacy and confidentiality of Dreewes and her estranged husband, whether the appellate court should have ordered the State to redact personal financial information incorporated into publicly-filed briefing when the information derives from now-sealed superior court files and relates to an issue mooted by amendment to the appellate rules?

C. STATEMENT OF THE CASE

**1. A frustrated victim of theft, Jennifer Dreewes asked her friend, Michelle Thomas, to help locate her property and the suspected thief, Vanessa.**

Jennifer Dreewes' laptop, iPhone, business checks, credit cards, and wedding rings were stolen from her car in Marysville. RP 252-57.<sup>1</sup> She reported the theft to the police and provided new information as they investigated the case. *E.g.*, RP 252-59, 371-72. Frustrated by the slow police response, Dreewes offered her Facebook friends a small reward for information about her stolen property. RP 290-93, 296-97, 308, 504-05.

Dreewes recently became reacquainted with her high school classmate Michelle Thomas. RP 330-31. Unbeknownst to Dreewes, Thomas thought this could be “a testing ground for being a bounty hunter.” RP 331, 464. Thomas also wanted the small financial reward. RP 297. She learned the suspect's name, Vanessa, and obtained a photograph that she posted on Facebook. RP 293, 318, 332, 377.

Over Facebook, Thomas and Dreewes joked about giving Vanessa black eyes, bringing Vanessa to Dreewes, and retaking Dreewes' personal property. RP 294-97, 299-300, 328, 344-45. Thomas offered to go to the house where she thought Vanessa lived, but wanted to know “how many

people were in the home, if there was any sort of weapons.” RP 298-300, 308-10, 313. Dreewes responded that her cousin “Kyle said 4-5 and yes he said don’t go there unless packing.” RP 313-14; Ex. 52, p.3810.<sup>2</sup>

Dreewes told Thomas the plan could not deviate from what they had discussed: giving Vanessa black eyes and bringing her to Dreewes. RP 299; Ex. 52, p.3809. They only discussed action against Vanessa. Ex. 52. Dreewes insisted she wanted her property back more than anything else. Ex. 52, p.3810 (“I don’t care about anything other than my shit.”)

Thomas reported to Dreewes that she went to the house, knocked on the door, and left after no one answered. Ex. 52, p.3813.

**2. Thomas did not locate Dreewes’ property or Vanessa, but, of her own accord, Thomas assaulted a third party, Marty Brewer-Slater.**

Thomas and her boyfriend Don Parrish returned later, apparently high on drugs and armed with guns, zip ties, and duct tape. RP 124, 166, 177, 179, 202, 314-18. They knocked at the front door. RP 121. Rohen Brewer-Slater “cracked” open the door to ask what the strangers wanted, and Parrish replied they were looking for Vanessa. RP 121-22. Rohen told him Vanessa was not in the home, but Parrish said “yeah, right” and pushed through the door pointing a gun. RP 123. Rohen’s wife Marty, his

daughter, and her boyfriend were inside. RP 115-22, 148-50. Parrish and Thomas locked the front door behind them and issued various commands to direct the family where to stand. RP 124, 127-29, 174. Parrish looked for personal property and asked for people whose names the family did not recognize. RP 175. Ultimately, Rohen grabbed the small pistol from Thomas, who ran outside, and Parrish hit Rohen in the face with the butt of his rifle. RP 129-30.

The family pulled Parrish to ground. RP 131, 194-95. He pointed his gun at Marty and pulled the trigger but the safety was locked; she sprayed him with bear mace. RP 132-33, 177-79. Rohen followed Parrish outside and eventually turned him over to the police. RP 134-37. Thomas turned herself in to police. RP 244-45, 325.

Dreewes was not present for any of these events. *E.g.*, RP 187.

**3. Although Dreewes neither knew of nor participated in the assault of Marty Brewer-Slater, the State elected to charge Dreewes with the assault of Marty Brewer-Slater, forgoing other charges.**

Jennifer Dreewes had no prior criminal record. CP 58-68. The State initially charged her as an accomplice to robbery in the first degree. CP 171. It later amended the charge to first degree burglary and added a charge for being an accomplice to the second degree assault of Marty Brewer-Slater. CP 73 (“That the defendant, on or about, the 23rd day of

January, 2014, did intentionally assault another person, to-wit: Marty Brewer-Slater, with a deadly weapon, to-wit: a firearm; proscribed by RCW 9A.36.021(1)(c), a felony.”), 163. The State did not charge Dreewes with any crimes in relation to Vanessa.

Thomas pleaded guilty, with the State promising a reduced sentence if she testified against Dreewes. RP 327-28.

At Dreewes’ trial, without objection from either party, the court instructed the jury:

To convict the defendant of the crime of assault in the second degree as charged in Count II, each of the following elements of the crime must be proved beyond a reasonable doubt:

(1) That on or about the 23rd day of January, 2014, the defendant assaulted Marty-Brewer Slater with a deadly weapon;

(2) That this act occurred in the State of Washington.

CP 27; RP 523-24 (State does not object). The jury was also instructed on accomplice liability. CP 30.

Mirroring the to convict instruction, the State emphasized that liability was limited to an assault on Marty Brewer-Slater as an accomplice. RP 104 (“you can be legally accountable for something that someone else does if you encourage them to do that . . . they broke into that house with a firearm, pointed a firearm at Marty, and squeezed the

trigger”) (opening statement), 532, 545-46 (arguing Dreewes’ accomplice assaulted Brewer-Slater) (closing argument).

The jury convicted Dreewes of first degree burglary while armed with a firearm and assault in the second degree of Brewer-Slater as an accomplice. CP 7-9. The Court of Appeals affirmed the burglary conviction and it is not on review. A unanimous court further reversed the assault conviction because there was insufficient evidence Dreewes had actual knowledge and aided the assault of Brewer-Slater, a burden the State assumed by including her name in the to convict instruction without objection. Slip Op. at 23-26. The Court of Appeals concluded, “No evidence supports finding Dreewes had actual knowledge of assault in the second degree of Marty Brewer-Slater with a deadly weapon.” *Id.* at 26.

#### D. SUPPLEMENTAL ARGUMENT

**1. The Court of Appeals correctly held the State failed to prove Dreewes had actual knowledge of the charged assault against a specific person.**

The State charged Dreewes as an accomplice to assault against Marty Brewer-Slater. Because Dreewes did not aid, encourage, solicit, or request Thomas assault Brewer-Slater, Dreewes is not liable for this crime.

- a. The prosecution had to prove Dreewes had specific knowledge of the assault against Marty Brewer-Slater.

Dreewes was not with Thomas when Thomas and her boyfriend decided to enter the Brewer-Slater's home. In fact, Dreewes was on her way to Leavenworth and was under the impression that Thomas would only seek out Vanessa and Dreewes' property. Ex. 52, p.3809-11. The State arguably could have charged Dreewes with conspiracy to commit a crime against Vanessa, but chose not to. The State arguably could have charged Dreewes with attempted assault of Vanessa, but chose not to. Instead, the State charged accomplice liability for assault with a deadly weapon against Marty Brewer-Slater.

Accomplice liability has a long, settled history in this state. A person is liable as an accomplice if she aids or agrees to aid the principal in planning or committing "the crime" with the knowledge that it will promote or facilitate the commission of that specific crime. RCW 9A.08.020(3); *State v. Cronin*, 142 Wn.2d 568, 579, 14 P.3d 752 (2000).

Accomplice liability requires proof that the accused person had actual knowledge of the crime charged. *State v. Allen*, 182 Wn.2d 364, 374, 341 P.3d 268 (2015). The legislature limited accomplice liability to actual knowledge of the crime. *State v. Roberts*, 142 Wn.2d 471, 14 P.3d 713 (2001); *Cronin*, 142 Wn.2d at 579.

The mens rea of “knowledge,” requires the accused have actual subjective knowledge. *State v. Shipp*, 93 Wn.2d 510, 517, 610 P.2d 1322 (1980); *Allen*, 182 Wn.2d at 374. While circumstantial evidence may be used to show the accused actually knew of the crime, liability cannot depend upon what the accused “should have known.” *Id.*

Accomplice liability is further restricted. It is not strict liability. *Roberts*, 142 Wn.2d at 511. An accomplice is not liable for all acts or crimes that are merely foreseeable. *State v. Stein*, 144 Wn.2d 236, 246, 27 P.3d 184 (2001). The “fact that a purported accomplice knows that the principal intends to commit ‘a crime’ does not necessarily mean that accomplice liability attaches for any and all offenses ultimately committed by the principal.” *Cronin*, 142 Wn.2d at 579 (quoting *Roberts*, 142 Wn.2d at 511-12). “[F]or one to be deemed an accomplice, that individual must have acted with knowledge that he or she was promoting or facilitating *the* crime for which that individual was eventually charged.” *Id.*

Thus, for example, a person is not an accomplice to robbery if she encourages the principal to commit only theft. *State v. Grendahl*, 110 Wn. App. 905, 911, 43 P.3d 76 (2002); *see also Stein*, 144 Wn.2d at 246.

Advance knowledge is critical to accomplice liability because it enables the accused to make the relevant legal and moral choice for which she may be ultimately held accountable. *Rosemond v. United States*, 572

U.S. 65, \_\_\_, 134 S. Ct. 1240, 1249, 188 L. Ed. 2d 248 (2014). When an accomplice knows nothing of the intended crime, she lacks the ability to withdraw from it. *Id.*

*State v. Farnsworth* is instructive. 185 Wn.2d 768, 374 P.3d 1152 (2016). The State proved Farnsworth and his partner specifically discussed committing a bank “robbery” and acknowledged robbery, unlike theft, involves threatened force. *Id.* at 778. The State also proved Farnsworth knew a bank teller would comply with any demand if they passed the teller a note with a threat. *Id.* at 777. The accomplices did not deviate from the plan, except as to who entered the bank and who drove the car. *Id.* at 780-81. Farnsworth even wrote the demand note that was used in the robbery. *Id.* at 781. The evidence was sufficient because “Farnsworth planned the crime [of robbery] exactly as it occurred.” *Id.* at 780. Farnsworth had advance knowledge of and aided in the crime.

Dreewes, like Farnsworth, was charged as an accomplice, thus the adequacy of the evidence adduced at trial depends upon her actual knowledge of the crime at issue.

- b. The State assumed the burden of proving the elements in the to convict instruction, including that Dreewes “assaulted Marty Brewer-Slater with a deadly weapon.”

Under a straightforward application of the law of the case doctrine, the State was required to prove Dreewes committed assault with a deadly

weapon on Marty Brewer-Slater. Where the State assumes the burden of naming the victim of the charged conduct in the to convict instruction the individual becomes an element of the crime the State must prove at trial.

Just last year, in *State v. Johnson*, this Court reaffirmed its long adherence to the law of the case doctrine. 188 Wn.2d 742, 399 P.3d 507 (2017); see *State v. Hickman*, 135 Wn.2d 97, 101, 954 P.2d 900 (1998) (“The law of the case is an established doctrine with roots reaching back to the earliest days of statehood.”). As relevant here, the law of the case doctrine means that, in a criminal case, the State assumes the burden of proving otherwise unnecessary elements of the offense when they are included without objection in the to convict instruction. *Hickman*, 135 Wn.2d at 102.

Sound policy supports the doctrine. Law of the case “benefits the system by encouraging trial counsel to review all jury instructions to ensure their propriety before the instructions are given to the jury.” *Id.* at 105. It also promotes finality and efficiency in the judicial process and encourages general fairness. *Johnson*, 188 Wn.2d at 757.

In *Hickman*, the State assumed the burden of proving the venue for the crime when it acquiesced to venue as an element in the to convict instruction. 135 Wn.2d at 105. Because the State failed to prove the defendant committed the crime in the venue included in the instruction,

this Court reversed for insufficient evidence and dismissed the charge. *Id.* at 105-06.

Here, the State elected to charge Dreewes with assault of Marty Brewer-Slater with a deadly weapon. CP 73. The court instructed the jury that it must find Dreewes “assaulted Marty Brewer-Slater with a deadly weapon.” CP 27. The State did not object. RP 523-24. Thus, Brewer-Slater became an element in the case. *See Johnson*, 188 Wn.2d at 754-56. The State bore the burden to prove Dreewes actually knew Thomas would assault Brewer-Slater. *See Petit. for Rev.* at 6 (State agrees it took on burden of proving assault of Brewer-Slater).

- c. There was no evidence Dreewes actually knew of an assault on Marty Brewer-Slater.

The State did not prove Dreewes had actual knowledge that Thomas or her boyfriend would assault Marty Brewer-Slater. Unlike in *Farnsworth*, where the defendant “planned the [bank robbery] exactly as it occurred,” the assault of Brewer-Slater was an independent act that Thomas pursued on her own, without notice to Dreewes. 185 Wn.2d at 781. Dreewes’ animosity was focused on Vanessa. She sought Thomas’ help in getting back her stolen property and admitted she would like it if Vanessa had “2 black eyes.” Ex. 52, p.3809. Marty Brewer-Slater was not the suspected thief, Dreewes did not know her, and Dreewes and Thomas’

conversations never encompassed assault on, or any action against, anyone other than the suspected thief. *Id.*, p.3792-93, 3795, 3809; RP 299.

Instead, the State pursues a prohibited “should have known” or strict liability argument. It argues Dreewes should have known Brewer-Slater would be assaulted with a deadly weapon because Dreewes answered Thomas’ question by relaying information from her cousin, four to five people could be in the house and not to retrieve Vanessa unless Thomas was “packing.” Supp. Br. of Rep’t, No. 74055-5-I (filed Aug. 9, 2017); *see* RP 313-14. But, “should have known” is not the actual, subjective knowledge required for accomplice liability. *Allen*, 182 Wn.2d at 374. Dreewes cannot be held liable as an accomplice to all foreseeable crimes. *See Roberts*, 142 Wn.2d at 511 n.14 (accepting Washington’s accomplice liability statute does not authorize liability for all acts of the principal); *Stein*, 144 Wn.2d at 246 (accomplice liability is not strict liability); *Roberts*, 142 Wn.2d at 511 (same).<sup>3</sup>

In *Stein*, this Court held the accused could not be liable as an accomplice for acts that exceeded those to which he acquiesced. 144

Wn.2d 236. There, the defendant's compatriots attempted to murder the victim. Under the instructions, the jury could have convicted the defendant of the attempted murder if the evidence showed that the defendant conspired simply to intimidate the victim, "even if [Stein] had no idea that his coconspirators would attempt to commit murder." *Id.* at 245-46, 247-48. The defendant could not be liable as an accomplice for crimes that exceeded his knowledge, even if they were foreseeable. *Id.* at 246, 248.

Similarly, this Court dismissed a conviction due to the accomplice's lack of knowledge of the crime in *State v. Cordero*, 36 Wn.2d 846, 221 P.2d 472 (1950). There, the accused was a passenger in a vehicle and knew the driver had been drinking. 36 Wn.2d at 848, 852. However, the State failed to prove he was an accomplice to negligent homicide because no evidence showed he knew the driver was driving in a reckless manner or was affected by the use of intoxicants an appreciable time before the accident happened. *Id.* at 851-52.

In other cases, too, our courts have reversed for insufficient evidence where actual knowledge was lacking. *E.g.*, *State v. LaRue*, 74 Wn. App. 757, 762, 875 P.2d 701 (1994) (insufficient evidence the accused knew of the principal's crime or desired to facilitate it where evidence did not clearly point to knowledge of the crime); *State v. Luna*, 71 Wn. App. 755, 759-60, 862 P.2d 620 (1993) (insufficient evidence the

accused accomplice, who transported the principal to the crime, knew in advance the principal was going to stop the stolen truck or take over driving it; reversing conviction for taking a stolen vehicle).

A theory of transferred intent also would not apply here. *State v. Elmi*, 166 Wn.2d 209, 207 P.3d 439 (2009) (principal's specific intent for assault in the first degree of targeted victim, intent to commit great bodily harm, can transfer to unintended victim creating liability for principal). *Cf. State v. Sandoval*, 189 Wn.2d 811, 816-17, 825-26, 408 P.3d 675 (2018) (accused liable as accomplice when present for and actively aided shooting into car of rival gang member but unintended victim hit). First, the jury was not instructed on transferred intent. *State v. Abuan*, 161 Wn. App. 135, 156, 257 P.3d 1 (2011). Further, Parrish did not assault Brewer-Slater believing she was Vanessa. In fact, the suspect was not even in the home when Thomas and Parish entered. Accordingly, transferred intent does not apply because their actions toward Brewer-Slater were not intended for the suspected thief.

Contrary to the State's assertion, this Court's decision in *State v. Teal*, 152 Wn.2d 333, 96 P.3d 974 (2004) is inapposite. *See* Pet. for Rev. at 7-8. In *Teal*, the petitioner asserted that a to convict instruction does not provide a basis for accomplice liability if it merely states "the defendant," and not "the defendant or an accomplice," even where the jury was

provided an accomplice liability instruction. 152 Wn.2d at 337. “Teal specifically argue[d] that when a ‘to convict’ instruction only refers to the conduct of the ‘defendant, and not to the conduct of the ‘defendant or an accomplice,’ accomplice liability is beyond the scope of the jury instruction.” *Id.* at 338. This Court held the scope of the defendant’s liability was amply defined by a separate accomplice liability instruction. *Id.* at 338-39. Teal helped plan the crime, transported his brother to the scene, and watched. *Id.* at 334-35. Here, unlike in *Teal*, no jury instruction expanded the definition of the term Marty Brewer-Slater or indicated the defendant was broadly liable for any assault. Dreewes lacked actual knowledge of the crime set forth in the instructions.

Likewise, *State v. Trout* does not compel a different result. *See* Petit. for Rev. at 5 (claiming support from *State v. Trout*, 125 Wn. App. 403, 105 P.3d 69 (2005)). There, the defendant had actual knowledge of the crime committed: he planned it; he participated in it; he furthered the crime by assuming a position of authority; and, despite being present the entire time, he did nothing to stop it. *Id.* at 410-13.

Here, the evidence was insufficient to sustain accomplice liability as to the charged and instructed crime. *See Roberts*, 142 Wn.2d at 510. As in *Stein* and *Cordero*, and unlike in *Farnsworth*, Dreewes did not have

actual knowledge of the substantive crime of assault of Marty Brewer-Slater. *See Roberts*, 142 Wn.2d at 512-13.

- d. Regardless of the wording of the to convict instruction, the State did not present sufficient evidence Dreewes actually knew of any completed assault .

Even if the trial court had instructed the jury on second degree assault without Brewer-Slater's name, the evidence would be insufficient. The only assault to which Dreewes arguably had actual knowledge was of Vanessa. However, Thomas and Parrish did not assault Vanessa. "The" crime of which Dreewes arguably had knowledge did not occur. Therefore, Dreewes could not have been convicted as an accomplice to a completed assault in the second degree of any other. *See Stein*, 144 Wn.2d at 246 (accomplice is not strictly liable for all crimes of the principal); *Allen*, 182 Wn.2d at 374 (accomplice must have actual subjective knowledge of the crime). Substituting "another" for Marty Brewer-Slater in the to convict instruction would not change the result.

It is possible the State could have obtained a valid conviction if it charged Dreewes with attempted assault of Vanessa or conspiracy to assault Vanessa. Yet, the State elected to proceed on an accomplice liability theory to assault of Brewer-Slater with a deadly weapon. The evidence for that count is insufficient.

- e. The Court of Appeals should be affirmed.

This Court should affirm the Court of Appeals. The “State assumed the burden to prove beyond a reasonable doubt” Dreewes acted with actual knowledge “she was promoting or facilitating the specific crime of assault in the second degree with a deadly weapon of Marty Brewer-Slater.” Slip Op. at 26. “No evidence supports finding Dreewes had actual knowledge of assault in the second degree of Marty Brewer-Slater with a deadly weapon.” *Id.*

**2. Details of Dreewes’ personal finances should have been redacted from appellate briefing because it was sealed in the trial court.**

- a. Dreewes’ personal financial information is publicly available in appellate court briefing although it has been sealed in the superior court.

In response to Dreewes’ argument that appellate costs should not be imposed, the State filed contested financial declarations from Dreewes and her estranged husband’s divorce action and included details of her personal finances in the body of its response brief. Br. of Rep’t at 22-24 (filed Jan. 12, 2017). Dreewes had moved pro se to seal this personal financial information in the superior court, and the files were sealed after the State filed its brief. Motion to Seal, App. A (filed Aug. 16, 2017). The Court of Appeals Clerk denied Dreewes’ motion to seal those portions of the appellate briefing that detailed her personal finances, ruling “that

neither [appellate brief] includes any financial account number or other personal identification numbers.” Ruling at 2 (filed Oct. 3, 2017).

The State’s response brief incorporating Dreewes’ personal financial information from the sealed declarations is posted online.<sup>4</sup>

b. Personal financial information sealed in the superior court should be sealed in the Court of Appeals.

Under GR 15 and GR 31, appellate court files are open for public examination. Because Dreewes’ financial declaration and attached documents contain personal financial information, the superior court sealed the documents in her divorce proceedings pursuant to *Seattle Times v. Ishikawa*, 97 Wn.2d 30, 640 P.2d 716 (1982) and GR 22(e). *See Dreiling v. Jain*, 151 Wn.2d 900, 918-19, 93 P.3d 861 (2004) (personal financial information may be subject to sealing); *Hundtofte v. Encarnación*, 169 Wn. App. 498, 513-14, 280 P.3d 513 (2012) (financial records in family law cases entitled to privacy).

General Rule 15(g) sets forth a presumption that records sealed in the superior court remain under seal on appeal. “Court records sealed in

the trial court shall be sealed from public access in the appellate court subject to further order of the appellate court.” GR 15(g).

The GR 15 presumption is meaningless if parties can recite in appellate briefing information that has been sealed in the trial court. Yet, Section E of the State’s response brief and the corresponding section in Dreewes’ reply brief incorporate the sealed financial information and remain publicly available.

Separately, our appellate courts may seal a court record if “justified by identified compelling privacy or safety concerns that outweigh the public interest in access to the court record.” GR 15(c)(2). *Ishikawa* sets forth five factors relevant to this inquiry. 97 Wn.2d at 30, 37-39. These factors compel sealing. *See generally* Mot. for Discr. Rev., No. 95571-9 at 7-10 (filed Feb. 28, 2018). Sealing these pages is necessary because the documents relay personal financial information, recite details of Dreewes’ personal financial circumstances, and, in the case of the State’s response brief, misrepresent her finances. *See* GR 22(c)(2). There has been ample opportunity to object. There is no alternative to redacting two pages from the response brief and the final section of Dreewes’ reply brief.

Dreewes is sensitive to the public’s general right to access appellate proceedings. However, the courts’ hearings and opinions, all but

a few pages of the briefing, the orders, and the remainder of the court file would remain open. Moreover, the amendments to RAP 14.2, change the legal standard for imposing appellate costs and direct the commissioner or clerk to determine ability to pay. If the State seeks costs, this portion of the appeal would need to be newly briefed. Consequently, the public's interest in reviewing the details of Dreewes' personal financial circumstances at this time is minimal, if it exists at all.

E. CONCLUSION

Dreewes did not participate in and did not know other people would assault Marty Brewer-Slater as charged. This Court should affirm the Court of Appeals. The Court should also hold the sensitive, personal financial information recited in the appellate briefing should be sealed here as it is in the superior court.




