Dear Ms. Carlson:

In reviewing the Amici Brief submitted on behalf of Thurston County Volunteer Legal Services (TCVLS), Snohomish County Legal Services, and Kitsap Legal Services, I discovered a factual error. I write now to correct the record and I respectfully request that you pass this correction on to the Court.

Both the Amici Brief (at page 2) and the Motion for Leave to File (at page 2) state that Petitioner Harmon received assistance from a TCVLS volunteer attorney when she requested the Stay of the Writ of Restitution on Monday, September 19, 2016. It has come to my attention that Harmon did not receive advice from or representation by a TCVLS volunteer attorney until Friday, September 23, 2016, the date of the show cause hearing for the Stay. I do not believe that this factual error has any material effect on the question of TCVLS's interest in this case, nor on Amici's arguments in support of the Petition for Review, but I wanted to correct the record before further briefing had begun.
